1. (U) IN COMPLIANCE WITH YOUR TELECON REQUEST I SOUGHT APPOINTMENTS WITH DEP MOD GEN OLCAY AND DEP CH TGS GEN ERSOZ TO DETERMINE REACTION TO SECDEF LETTER.
2. (U) AS REPORTED IN REFERENCE, GEN ERSOZ STATED HE HAD NOT SEEN LETTER AND NEITHER HAD CHIEF, TGS, ALTHOUGH HE KNEW IT HAD BEEN RECEIVED. SUBSEQUENTLY, INFORMATION WAS RECEIVED THAT LETTER HAD BEEN SENT TO FOR MIN AND THERE APPEARED TO BE SOME DISCUSSION REGARDING INTERPRETATION OF THIRD PARAGRAPH.
3. (U) I MET WITH DEP MOD AT 1700 HOURS ON FRIDAY 21 FEB, GEN OLCAY STATED THAT MOD SANCAR WAS VERY HAPPY TO RECEIVE LETTER AND NOTED WITH PLEASURE THE SUBSTANCE OF SECDEF STATEMENTS. HE STATED THAT AN ANSWER TO SECDEF WOULD BE DISPATCHED WITHIN A FEW DAYS. GEN OLCAY STATED IN ANSWER TO MY QUERY THAT LETTER WAS QUITE CLEAR AND WELL UNDERSTOOD, HE REFERRED TO THE BRUSSELS MEETINGS OF DECEMBER IN WHICH HE HAD PARTICIPATED AND STATED THAT THESE DISCUSSIONS HAD BEEN MOST VALUABLE IN GAINING A GOOD MUTUAL UNDERSTANDING OF TURKEY'S PROBLEMS.
4. (U) GEN OLCAY STATED THAT HE HAD BEEN IN MEETINGS CONTINUOUSLY FOR SEVERAL DAYS DISCUSSING ALTERNATE COURSES OF ACTION FOR THOSE AREAS UNDER MOD PURVIEW SHOULD THE U.S. EXECUTIVE EFFORTS TO REVERSE AID CUT-OFF NOT BE SUCCESSFUL. HE MENTIONED ARES OF PROCUREMENT AND INDUSTRIALIZATION. HE EXPRESSED GREAT HOPE THAT, AT MINIMUM, THE PRIVILEGED OF PURCHASING COULD BE RESTORED THIS NEXT WEEK.
5. (U) I DEPARTED AT 1730 HOURS AND GEN OLCAY STARTED FOR ANOTHER MEETING. HE WAS FRIENDLY AND WARM, WITH NO VISIBLE EMOTION WHEN SPEAKING
