AWACS TALKING POINTS FOR USE IN EXECUTIVE SESSION APPEARANCE BEFORE THE SENATE FOREIGN RELATIONS COMMITTEE Chief, Records & Declass Div, WHS OCTOBER 1, 1981

ACCOMPLISHMENTS OF THE MURPHY MISSION

- -- Mr. CHAIRMAN, I WELCOME THE OPPORTUNITY TO APPEAR BEFORE THE COMMITTEE TODAY TO REVIEW OUR UNDERSTANDINGS WITH THE SAUDIS GOVERNING THE SALE AND OPERATION OF THE AMACS. THIS IS PARTICULARLY SO BECAUSE AS YOU MAY KNOW, IRANIAN JETS THIS MORNING ONCE AGAIN STRUCK AT TARGETS ACROSS THE PERSIAN GULF. THIS TIME THEY ATTACKED KUMAIT. I BELIEVE THIS EPISODE STANDS AS AMPLE AND ELOQUENT TESTIMONY OF WHY I AM HERE THIS MORNING.
- -- I APPRECIATE YOUR COOPERATION IN CONVENING THE COM-MITTEE IN EXECUTIVE SESSION SO THAT I CAN DESCRIBE FULLY AND CANDIDLY WHERE WE STAND. AS I KNOW YOU ARE AWARE, PUBLIC DISCLOSURE OF OUR DISCUSSIONS WITH THE SAUDIS COULD SERIOUSLY DAMAGE OUR OVERALL RELATIONSHIP WITH THEM.
- -- I WANT YOU TO KNOW THAT, THROUGHOUT THIS PROCESS WE HAVE WORKED TO TAKE FULL ACCOUNT OF THE ISSUES RAISED IN THE CONGRESS.
- -- I CAN NOW SAY WITH CONFIDENCE THAT WE HAVE CREATED A JOINT SYSTEM OF SAFEGUARDS FOR THE SAUDI AWACS WHICH IS RESPONSIVE TO CONGRESSIONAL CONCERNS.

-- I BELIEVE THAT AFTER YOU HAVE HEARD WHAT WE HAVE ACCOMPLISHED, YOU WILL AGREE WITH ME THAT WE HAVE BEEN ABLE TO MEET THE FUNDAMENTAL CONCERNS WHICH HAVE BEEN RAISED ABOUT THE SALE ON THE HILL.

THE UNDERSTANDINGS REACHED WILL GUARANTEE A CRITICAL US ROLE IN THE OPERATION OF THE SAUDI AWACS INTO THE 1990s AND BEYOND, AND WILL GIVE US A WELL FOUNDED CONFIDENCE IN:

- HOW THE SAUDI AWACS ARE USED!
- THEIR PHYSICAL SECURITY AND THE SECURITY OF THE AWACS TECHNOLOGY;
 - SHARING DATA FROM THE SAUDI AWACS, AND
- THE CONTINUING PARTICIPATION OF AMERICANS ON BOARD THE SAUDI AWACS, AND IN AWACS GROUND FACILITIES IN SAUDI ARABIA.

THE MECHANISM FOR U.S. PARTICIPATION: IN OUR DISCUSSIONS WITH THE SAUDIS, WE HAVE AGREED ON A STRUCTURE FOR U.S. PARTICIPATION IN AWACS OPERATIONS AND SECURITY WHICH I BELIEVE WILL ALLOW US TO ACHIEVE AN IMPORTANT DEGREE OF DEFACTO CONTROL OVER THE SYSTEM. THROUGHOUT THESE NEGOTIATIONS THE SAUDIS HAVE EMPHASIZED THE VALUE THEY PLACE ON CLOSE U.S.—SAUDI COOPERATION IN A JOINT EFFORT TO DEVELOP AND TO BENEFIT

MUTUALLY FROM THE SAUDI ANACS SYSTEM. IN AGREEING TO

SECURITY ASSURANCES

WE HAVE SAUDI APPROVAL OF A RANGE OF AGREEMENTS WHICH ARE RESPONSIVE TO THE CONCERNS WHICH WE AND THE CONGRESS SHARE. If any of these agreements are breached, we have the right to cancel the sale before any US equipment is delivered. Let me detail them for you:

- -- First, the Saudis have agreed to a <u>set of compre-</u> <u>HENSIVE AND STRINGENT SECURITY MEASURES TO SAFEGUARD THE</u> <u>EQUIPMENT AND TECHNOLOGY</u> WE ARE PROVIDING. CAP WILL BE <u>DISCUSSING THESE ARRANGEMENTS WITH YOU IN MORE DETAIL.</u>
- -- I BELIEVE THAT THESE MEASURES ARE REMARKABLE, NOT ONLY BECAUSE THE SAUDI TRACK-RECORD IN PROTECTING CLASSIFIED MATERIAL IS IMPECCABLE, BUT ALSO BECAUSE OF HOW FAR THE SAUDIS HAVE AGREED TO GO IN ACCEPTING MEASURES WHICH ALLOW FOR SUBSTANTIAL US PARTICIPATION IN SAUDI INTERNAL SECURITY PROCEDURES.
- -- LET ME GIVE YOU SOME EXAMPLES OF THESE SECURITY
 - US INSPECTION TEAMS WILL BE ABLE TO MONITOR THE USE OF ALL THE EQUIPMENT ASSOCIATED WITH THE AWACS SALE;
 - Only US and Saudi Personnel Will be used to Perform any operations or maintenance functions;



- No THIRD-COUNTRY PERSONNEL WILL BE PERMITTED TO MAKE ANY MODIFICATIONS TO THE AWACS AIRCRAFT OR RELATED GROUND EQUIPMENT WITHOUT US CONSENT, AND
- SPECIAL FACILITIES WILL BE CONSTRUCTED TO PROVIDE AROUND-THE-CLOCK SECURITY AND MAXIMUM PROTECTION AGAINST UNAUTHORIZED ENTRY.

These measures to protect the security of the AWACS will have to be approved by the US at least one year before any Saudi AWACS are delivered.

- -- THESE ARRANGEMENTS DO MORE THAN PROVIDE EXTRA-ORDINARILY TIGHT PHYSICAL SECURITY FOR THE AWACS.
 - SINCE: SKILLED SAUDI AIRCREWS WILL REMAIN IN SHORT SUPPLY INDEFINITELY, THE US-SAUDI AGREEMENT THAT THIRD COUNTRY NATIONALS CANNOT OPERATE OR MAINTAIN THE SAUDI

AWACS WILL HAVE THE <u>PRACTICAL RESULT OF EXTENDING THE</u>
PRESENCE OF AMERICANS ON BOARD THE AYRCRAFT WELL INTO

- LIKEWISE, ANY ARMS SUPPLIER WHICH MIGHT BE TEMPTED TO CHALLENGE THE PREDOMINANT US ROLE IN THE SAUDI AIR DEFENSE SYSTEM WOULD FACE THE VIRTUALLY INSURMOUNTABLE OBSTACLES CREATED BY THE US-SAUDI AGREEMENT TO PROHIBIT ANY THIRD-COUNTRY MODIFICATIONS TO THE AWACS AIRCRAFT AND GROUND ENVIRONMENT.
- -- SECOND, THE SAUDIS HAVE AGREED TO SHARE COMPLETELY THEIR AWACS DATA WITH US ON A REAL-TIME BASIS. IN THIS CONNECTION, THEY HAVE AGREED THAT THE US WILL BE ABLE TO MAINTAIN AN INDEPENDENT AMERICAN CAPABILITY INSIDE THE COUNTRY TO RECEIVE AND PROCESS SAUDI AWACS RADAR INFORMATION FOR OUR OWN USE. US NAVY SHIPS AND OTHER US FACILITIES IN THE REGION ALSO WILL BE ABLE TO RECEIVE DATA FROM THE SAUDI AWACS.
- -- THIRD. THE US HAS A COMPLETE VETO OVER WHO THE SAUDIS
 ARE ABLE TO SHARE AWACS DATA WITH. THIS ARRANGEMENT, OF COURSE,
 PRECLUDES ANY POSSIBILITY THAT SAUDI AWACS COULD CONTRIBUTE TO
 A COORDINATED ARAB ATTACK AGAINST ISRAEL.

- -- FOURTH, THE SAUDIS HAVE AGREED THAT THEY WOULD NOT OPERATE THEIR AWACS OUTSIDE SAUDI AIRSPACE. WE ARE ASSURED THAT THEY WILL FOLLOW STANDARD USAF DOCTRINE CONCERNING AMACS OPERATION. USAF DOCTRINE REQUIRES THAT AWACS BE OPERATED A "SAFE DISTANCE" BACK FROM POTENTIALLY HOSTILE BORDERS. A "SAFE DISTANCE" TRANSLATES INTO 100 TO 150 MILES, A DISTANCE AT WHICH THE ABILITY OF A SAUDI AWACS TO SEE INTO ISRAEL WOULD BE SEVERELY DEGRADED.
- -- IN SUMMARY, THIS SYSTEM OF JOINT SAFEGUARDS -- IN COM-BINATION WITH SAUDI AGREEMENT TO OPERATE AWACS AT "SAFE DISTANCES" FROM HOSTILE BORDERS -- WILL HAVE THE PRACTICAL RESULT OF:
- MINIMIZING THE THEORETICAL THREAT WHICH AWACS COULD POSE TO ISRAELI SECURITY;
- ENSURING FULL; REAL-TIME US ACCESS TO THE VALUABLE INFORMATION COLLECTED BY THE SAUDI AWACS; AND
- GUARANTEEING THE SECURITY OF SENSITIVE EQUIPMENT AND TECHNOLOGY.
- -- I THINK YOU CAN SEE WHY I REGARD THIS PACKAGE OF SAFE-GUARDS, WHICH WE ARE ASSURED WE WILL BE ABLE TO MONITOR CAREFULLY THROUGH THE EXPANDING TRAINING MISSION MECHANISM, AS SUBSTANTIAL, BOTH FOR THEIR COMPREHENSIVENESS AND FOR WHAT THEY SAY ABOUT SAUDI WILLINGNESS TO ENGAGE OUR CONCERNS AND TO WORK WITH US.

THE BOTTOM LINE

- -- LET ME TELL YOU, WITH THE BARK OFF THE TREE, WHERE I THINK WE ARE, WHAT THE PRACTICAL CHOICES ARE, AND WHAT IS AT STAKE.
- -- THE SAUDIS HAVE ACCEPTED THE REALITY OF A WIDESPREAD US
 PRESENCE AND PARTICIPATION IN THEIR MILITARY STRUCTURE. WE RECOGNIZE THAT OUR ALREADY EXTENSIVE INVOLVEMENT HAS "INSTITUTIONALIZED"
 US CONTROL OVER CRITICAL ELEMENTS OF THEIR MILITARY FORCES.
 NOW, THESE NEW SAFEGUARDS EXTEND THIS INSTITUTIONALIZATION
 OF THE US ROLE TO THEIR AIR DEFENSE SYSTEM, INCLUDING AWACS.
- -- WHATEVER THE FORMALITIES, THIS IS THE RELAITY INTO THE 1990s.
- -- AS THE SAUDIS THEMSELVES PUT IT, WE WILL BE IN A PERIOD OF DE FACTO JOINT US, SAUDI COMMAND AND CONTROL AT LEAST UNTIL 1990, SIMPLY BY VIRTUE OF THE FACT THAT US CREWS WILL BE REQUIRED TO OPERATE THE SAUDI AWACS SINCE THE SAUDIS WILL NOT HAVE ENOUGH TRAINED PERSONNEL. THIS GUARANTEES AN AMERICAN PRESENCE IN THE PLANES AND ON THE GROUND.
- -- AFTER 1990, THIS JOINT ARRANGEMENT WILL CONTINUE, NOT ONLY BECAUSE OF MECHANISM FOR DE FACTO JOINT CONTROL AND THE NATURAL DEVELOPMENT OF CLOSER US-SAUDI COOPERATION, BUT -- AS I HAVE SAID -- BECAUSE THE SAUDIS WILL BE UNABLE TO ROUTINELY MAN THEIR FIVE AWACS WITH THEIR LIMITED AIRCREW RESOURCES.

- -- THE SAUDIS HAVE RUN HEAVY RISKS IN BEING AS RESPONSIVE AS THEY HAVE. LET ME EMPHASIZE THIS IS NOT SIMPLY A MATTER OF NATIONAL PRIDE ON THEIR PART. IT IS A MATTER OF SUSTAINING CREDIBLE AND CONSTRUCTIVE SAUDI LEADERSHIP AS A MODERATING INFLUENCE IN THE WORLD OF ARAB POLITICS, AND THE SOMETIMES DEADLY WORLD OF ARAB RADICALISM.
- -- WE HAVE HAD EXTENSIVE DISCUSSIONS WITH THE SAUDIS.

 THE RESULT IS AN EXCELLENT ARRANGEMENT WHICH, I THINK YOU WOULD HAVE TO AGREE, DEMONSTRATES THAT WE HAVE HEARD CONGRESS'

 CONCERNS AND WE HAVE RESPONDED TO THEM.
- -- IN THE FINAL ANALYSIS, WE FACE A SIMPLE, BUT FUNDAMENTAL CHOICE. WE CAN ASK THE SAUDIS TO GO STILL FURTHER, AND INSIST THAT THEY AGREE TO FORMALIZE AND PUBLICIZE A NETWORK OF AGREEMENTS WE ALREADY HAVE IN HAND. BUT OUR EXTENSIVE DISCUSSIONS HAVE MADE CLEAR THAT IF WE PRESS THEM FOR STYLL MORE, THEY WILL NOT YIELD. ALL WE WILL HAVE ACCOMPLISHED WOULD BE TO JEOPARDIZE SAUDI COOPERATION ON CRITICAL ISSUES LIKE LEBANON AND PEACE IN THE MIDDLE EAST AND TO RISK THE OVERALL US-SAUDI RELATIONSHIP.
- -- ALTERNATIVELY. WE CAN BUILD ON THE PRACTICAL CONSEQUENCES OF WHAT HAS BEEN ACHIEVED: A LARGE AND CONTINUING US ROLE IN THE SAUDI AWACS, A STRENGTHENED, FRIENDLY SAUDI ARABIA WITH EXTENSIVE AND GROWING INFLUENCE WITH THE ARAB AND ISLAMIC WORLD, AND A CONFIDENT SAUDI ARABIA WHICH CAN WORK WITH US IN PROTECTING AND PROMOTING OUR SECURITY INTERESTS IN THE VITAL PERSIAN GULF REGION.
