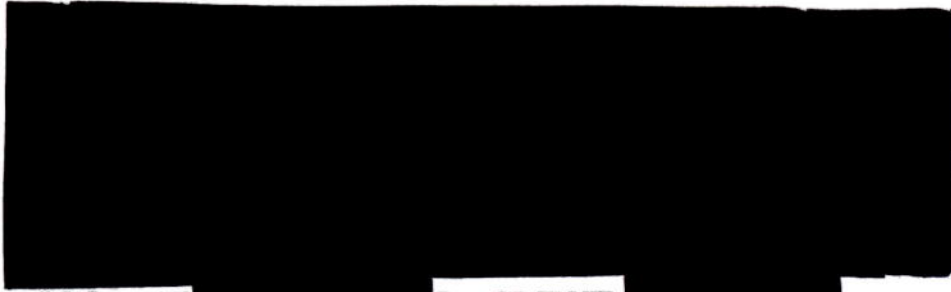

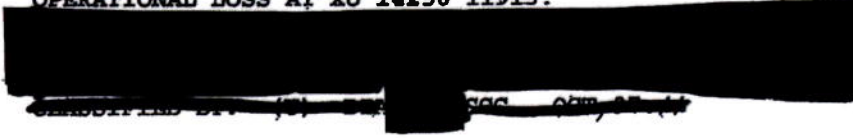

THE DETAILED CHAIN OF COMMAND INFORMATION OF SECTOR 21 AND MEMOT DISTRICT MAY BE HELPFUL IN IDENTIFYING POTENTIAL WITNESSES. [REDACTED] REPORTING OF THE PEOPLE'S ARMY OF VIETNAM LIAISON AND MEDICAL SUPPORT TO THE KHMER COMMUNIST SECTOR 21 AND THE EASTERN REGION MAY PROVE HELPFUL IF A LIST OF PRISONERS TREATED CAN BE IDENTIFIED. UNRESOLVED CASES 1398, 1410, 1431, AND 1610 ARE IN THE GENERAL AREA OF THE REPORTED PAVN HOSPITAL AT RUMCHEK COMMUNE. THE ONLY CRASH SITE LOCATED NEAR TREAK COMMUNE IS A 11 MAY 1970 AH-1G HELICOPTER OPERATIONAL LOSS AT XU 14250 11915.
