



SUBJECT: Problems in Kabul Embassy Counternarcotics Staffing

 State's International Narcotics and Law Enforcement (INL) office is responsible for the following programs in Afghanistan (FY04 figures):

o Poppy eradication (\$40M)

o Alternative Livelihood (\$25M) (USAID has additional Alternative Livelihood Programs)

o Police Training (\$160M)

o Public Affairs (\$2.5M)

o Counternarcotics Capacity Building (\$9.5M)

o Judicial Reform (\$18M)

- The INL staff operates within the Narcotics Affairs Section (NAS) at the
 Embassy. The only NAS person assigned to the Embassy departed Sunday.
 after three weeks in country (no Acting Director was named) and there is no
 identified replacement. (The position was open for three months prior to the
 NAS person's arrival.) INL Embassy staffing follows:
 - O Currently there is one INL staff person assigned to the Embassy in Kabul and he is responsible for eradication (Mr. Craigo).
 - o There is one INL TDYer who is responsible for all the counternarcotics, police and judicial reform efforts. She has no known experience in the police or judicial sectors, and State has not yet determined how long she will remain in Kabul.
 - o There are no other INL staff officers implementing INL's programs.
- In addition to INL, there are two DEA agents assigned to the Embassy working on counternarcotics issues.
- The Ambassador's Counternarcotics Coordinator, Doug Wankel, arrived this summer. He has extensive counternarcotics experience from DEA.
- Many PRTs do not have USAID and State Department representatives (these
 positions remain vacant).
