SUMMARY: (U) THIS IS A STONY BEACH REPORT. IT PROVIDES INFORMATION OF KHMER ROUGE STRUCTURE IN KAMPOAN COMMUNE, MEMOT DISTRICT, KAMPONG CHAM PROVINCE, CB, AND THE POSSIBLE DEATH OF AN ASSUMED AMERICAN IN SRE SANGKE, CB.

JOINED THE KHMER COMMUNIST MOVEMENT IN 1970, BUT IS CURRENTLY A FARMER.

2. (U) MEMOT DISTRICT FORCES. [REDACTED]

BUN CHHEUEN WAS THE MEMOT DISTRICT CHIEF. MEMOT DISTRICT FORCES CONSISTED OF THREE COMPANY-SIZED UNITS--1ST COMPANY, 2ND COMPANY, AND 3RD COMPANY. THE 1ST COMPANY WAS STATIONED NEAR KROCH CHHMAR DISTRICT. THE 2ND COMPANY WAS STATIONED NEAR DAMBE DISTRICT. THE 3RD COMPANY WAS STATIONED IN CHHLONG MUOY VILLAGE AND WAS A MOBILE UNIT. THE 3RD COMPANY COMMANDER WAS ((PHI)) RON, WHO IS DECEASED. THE DEPUTY COMMANDER OF THE 3RD COMPANY WAS ((O)) KHI, ALSO DECEASED. THE 3RD COMPANY CONSISTED OF THREE SQUADS--1ST SQUAD, 2ND SQUAD, AND 3RD SQUAD. AFTER ONE MONTH, MEMOT DISTRICT FORCES WERE RE-DESIGNATED SECTOR 21 FORCES. THE CHAIN OF COMMAND FOR THE UNITS REMAINED THE SAME.

3. (U) MILITARY REGION 203 (EASTERN) FORCES. [REDACTED]

[REDACTED] THE 153RD DIVISION CONSISTED OF FOUR BATTALION-SIZED UNITS--126TH BATTALION, 153RD BATTALION, AND TWO OTHER UNITS FOR WHICH [REDACTED] COULD NOT REMEMBER THE DESIGNATORS. THE 126TH BATTALION OPERATED IN O REANG AU (CNA). THE 153RD BATTALION OPERATED IN CHHEU KOH BA PHNOM (CNA). THE 126TH BATTALION CONSISTED OF FOUR COMPANY-SIZED UNITS--3RD COMPANY, 4TH COMPANY, 5TH COMPANY, AND 6TH COMPANY. THE 3RD COMPANY WAS A LOGISTICS UNIT AND OPERATED IN TRAPEANG KHLA (CNA). THE 4TH COMPANY WAS AN INFANTRY UNIT AND OPERATED IN BUNG BATI (CNA). THE 5TH COMPANY WAS AN INFANTRY UNIT AND OPERATED IN PREK SANDEK (CNA). THE 6TH COMPANY WAS AN INFANTRY UNIT, CONSISTED OF 116 SOLDIERS, AND OPERATED IN AMBENG CHES (CNA).

4. (U) AN AMERICAN IN THE RUBBER PLANTATION. IN 1971, WHILE AWAITING ORDERS TO HIS NEXT LOCATION, [REDACTED]

[REDACTED] HEARD THAT KHMER COMMUNIST SOLDIERS KILLED THE AMERICAN IN 1972. BECAUSE THE AMERICAN WAS SUPPOSED TO GO TO SRE SANGKE (CNA), [REDACTED] THINKS HE WAS KILLED THERE.

5. (U) SOURCE DID NOT KNOW OF AIRCRAFT CRASHES IN THE AREA, OR OF OTHER FOREIGNERS CAPTURED, DEAD, OR MISSING IN THE AREA.

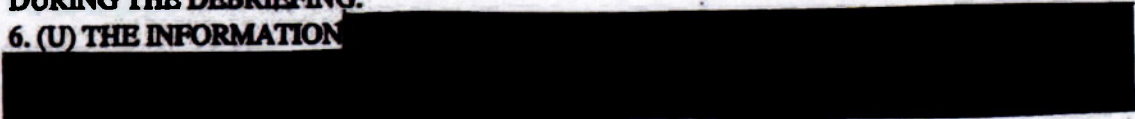

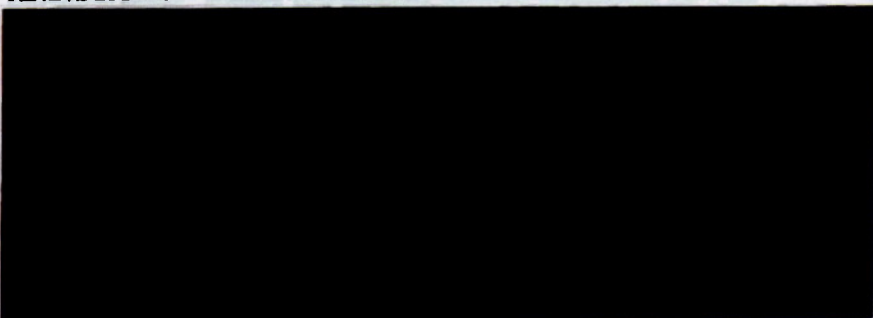
