[REDACTED] WHO ACQUIRED THIS INFORMATION THROUGH PERSONAL EXPERIENCE. RELIABILITY HAS NOT BEEN ESTABLISHED. SUMMARY: (U) THIS IS A STONY BEACH REPORT. IT PROVIDES NEW INFORMATION ON THE PRIORITY CASE 1610 POSSIBLE GRAVE SITES AND INFORMATION ON AN EXCAVATED SITE.

TEXT: 1. (U) THE FOLLOWING INFORMATION WAS OBTAINED DURING THE 29TH JOINT FIELD ACTIVITY (JFA) 03-1C CONDUCTED IN THE KINGDOM OF CAMBODIA FROM 17 JANUARY THROUGH 18 FEBRUARY 2003. DEBRIEFINGS WERE ACCOMPLISHED WHILE INVESTIGATING LAOS LAST-KNOWN-ALIVE (LKA) CASE 1610. RO CONDUCTED DEBRIEFS.

3. (U) REPORTED GRAVE SITES. WHEN SOURCE WAS ABOUT 12 OR 13 YEARS OLD HIS NOW-DECEASED FATHER SHOWED HIM A BURIAL SITE. SOURCE OBSERVED TWO GRAVES. HIS FATHER TOLD HIM ONE WAS AN AMERICAN WHO WAS CAPTURED AND TAKEN FROM A LARGE HELICOPTER AND WAS LATER SHOT AND KILLED. THE SECOND GRAVE CONTAINED A VIETNAMESE PERSON. SOURCE WAS A WITNESS FOR THE IE DURING THE 27TH JFA 02-1C AND AFTER SHOWING THE SITE TO THE JFA 02-1C TEAM, SOURCE REMEMBERED THE GRAVES WERE ACTUALLY FOUR TO EIGHT METERS NORTH-NORTHEAST OF THE LOCATION HE PREVIOUSLY POINTED OUT. THE GRAVES WERE PARALLEL TO EACH OTHER, APPROXIMATELY ONE HALF METERS APART, AND WERE ORIENTED NORTH TO SOUTH. THE GRAVE TO THE WEST WAS THE AMERICAN'S GRAVE AND THE GRAVE TO THE EAST WAS THE VIETNAMESE GRAVE. THE WEST GRAVE WAS APPROXIMATELY TWO AND ONE HALF METERS LONG AND THREE-FOURTHS OF A METER WIDE. THE EASTERN GRAVE WAS APPROXIMATELY TWO METERS LONG AND THREE-FOURTHS OF A METER WIDE. SOURCE DID NOT KNOW WHICH WAY THE HEADS WERE FACING, AS HE DID NOT WITNESS THE BURIALS. NO ONE ELSE IN HIS FAMILY WOULD KNOW ANYTHING MORE ABOUT THESE GRAVES BECAUSE HIS FATHER SHOWED ONLY HIM.

5. (U) EXCAVATION OF WRONG SITE. FIVE DAYS AFTER THE EXCAVATION OF THE BURIAL SITE ASSOCIATED WITH PRIORITY CASE 1610 DURING THE 28TH LIMITED JFA, [REDACTED] BROTHER-IN-LAW, [REDACTED] WHO WAS FRIEND, [REDACTED] WAS TOLD BY HIS

[REDACTED] THAT THE AMERICANS DUG IN THE WRONG AREA. [REDACTED] WHO WAS A SOLDIER DURING THE WAR, SAID HE BURIED THREE AMERICANS IN A DITCH FROM FIVE TO TEN METERS NORTH OF THE DIG SITE. [REDACTED] THREW THE BODIES IN A DITCH, PUT BAMBOO OVER THE BODIES AND THEN FILLED THE DITCH WITH DIRT.

COMMENTS: (U) 1. (U) [REDACTED] DFT BECAME SLIGHTLY AGITATED IN THE BEGINNING OF THE INTERVIEW BECAUSE HE DID NOT UNDERSTAND WHY HE WAS BEING INTERVIEWED ON THE SAME QUESTIONS AS HE WAS DURING THE 28TH JFA. ALTHOUGH, SOURCE ONE'S STORY DID NOT CHANGE, HE WAS ABLE TO PROVIDE A LITTLE MORE DETAILED INFORMATION CONCERNING THE GRAVES. SOURCE ANSWERED ALL QUESTIONS IN A SINCERE MANNER.

2. (U) SOURCES ARE AVAILABLE FOR FURTHER DEBRIEFINGS ONLY THROUGH THE CAMBODIAN POW/MIA COMMITTEE. MEMBERS OF THE COMMITTEE WERE PRESENT DURING THE DEBRIEFING.
