MEMORANDUM FOR THE SECRETARY OF DEFENSE

SUBJECT: Pentagon Security (U)

(S) In an earlier memo to you on this subject [redacted] as well as the potential danger to Department leadership at the regularly scheduled Armed Forces Policy Council.

(U) Subsequently, as part of an initiative to reexamine the vulnerability of all Air Force units/functions, our Air Force Office of Antiterrorism has proposed that a comprehensive joint agency review of Pentagon security be made. [redacted]

(U) The Air Force strongly supports formation of a joint agency task force to undertake a comprehensive review of Pentagon security. Immediate, as well as long term solutions, should be developed.
