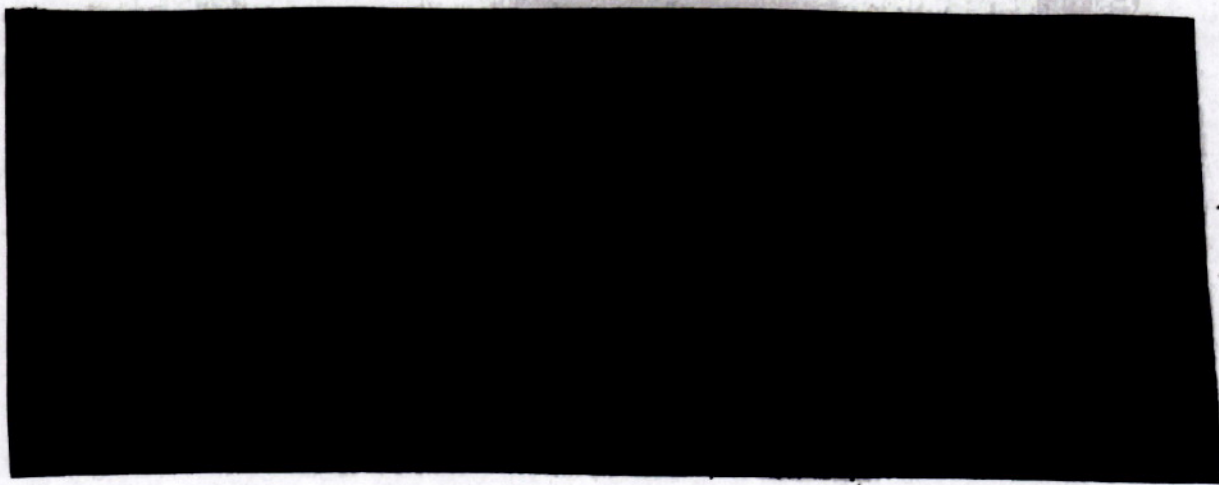

SUBJECT: European Trip Report, 19-22 March 1973 - INFORMATION.
MEMORANDUM (U)

(U) The purpose of this trip was twofold. First, to exchange views with some of the senior military commanders in NATO, namely General Jones, Commanding General of USAFE; General Sutherland, Commanding General of USEUCOM; and General Goodpaster, Commanding General of SHAPE. Second purpose was to attend the Conference of NATO Armaments Directors (CNAD) in Brussels. Our purpose in the latter meeting was to continue our efforts to revitalize the CNAD, to make it an effective instrument in strengthening NATO military posture.
