THIS MOMENT, WHEN THE ALLIES HAVE TO FACE UP TO A DECISION, GIVES US A PROBABLY FLEETING OPPORTUNITY TO MOVE RAPIDLY TO A COHERENT PACKAGE OF POSITIONS THAT GO AS FAR AS WE CAN HOPE TO GET IN RECONCILING THESE OPPOS-ING POSITIONS WITHOUT A BRUISING EUROPEAN (AND EVENTUALLY TRANS-ATLANTIC) DEBATE.

6. THE PACKAGE SHOULD CONSIST OF THE FOLLOWING, IN MY VIEW:

A. ACCEPT ZERO SRINF AT THE 500KM RANGE LIMIT (WHATEVER THE ACTUAL RANGE OF THE SS-23: GORBACHEV SPEAKS IN TERMS OF 500KMS, SHEVARDHADZE IS SYSTEM SPECIFIC.)

8. LINK THIS TO ELIMINATION OF THE LAST 100 SS-20'S. THIS TOGETHER WITH SOME ACTIVE ASIAN DIPLOMACY AND THE VERIFICATION ISSUE SHOULD BE ENOUGH.

C. FOR REASONS OF WATO STRATEGY, VERIFICATION AND A DESIRE NOT TO APPEAR HEADED TOWARD DENUCLEARIZATION, DRAW THE LINE AND AGREE THAT WE WILL NOT NEGOTIATE FURTHER LINITS ON OUR MUCLEAR WEAPONS IN EUROPE.

7. THERE ARE COMPELLING REASONS FOR NOT ENTERING FURTHER NEGOTIATIONS ON LESSER-RANGE SYSTEMS. THEIR MOBILITY, THE EASE WITH WHICH THEY CAN BE HIDDEN, THE FACT THAT

MANY (MOST) ARE CAPABLE OF FIRING BOTH NUCLEAR AND NON-NUCLEAR CHARGES -- ALL OF THIS SUGGESTS THAT THERE CAN BE NO GOOD AGREEMENT AFFECTING THESE SYSTEMS. BUT THE TIME TO MAKE THESE POINTS IS WHEN THE EUROPEANS ARE THEMSELVES ANXIOUS TO DEMONSTRATE THAT THE EUROPEAN ARMS CONTROL ELEVATOR HAS REACHED THE BASEMENT: THERE IS NO SENSIBLE LOWER FLOOR.

8. THE GENSCHERS MIGHT BE PREPARED TO ACCEPT SUCH A PACKAGE BECAWSE IT GETS THEM ZERO SRINF. THE THATCHERS AND KOHLS MIGHT ACCEPT IT BECAUSE THERE IS A DEFINITIVE BOTTOM LINE -- AND BECAUSE THERE IS STILL SUFFICIENT PUBLIC CONFUSION ABOUT WHAT WE MEAN WHEN WE TALK LOOSELY ABOUT SHORTER RANGE SYSTEMS SO THAT THEY MIGHT ARGUE THAT THIS IS AN IDEAL WAY TO DRAW THE LINE APPROPRIATELY
