1. - ENTIRE TEXT.

OVER THE PAST TWO NONTHS WE HAVE PICKED UP SIGNIFICANT NUMBERS OF INTELLIGENCE REPORTS OF RENEVED DISCUSSION WITHIN EGYPTIAN NILITARY AND GOVERNMENT CINCLES ADOUT THE WISBON OF OFFERING THE UNITED STATES BASE RIGHTS. THE NOTION IS NAMOLY NEW AS THOSE INVOLVED WITH RAS BANAS WILL RECALL. 5. WE MUST ALSO KEEP IN MIND THAT OUR CONCEPT OF AN ACCEPTABLE PRICE BEARS NO RELATIONSHIP TO EGYPTIAN EXPECTATIONS. WRITING OFF EGYPT'S FMS OBLIGATION WOULD CONSTITUTE ONLY AN OPENING BID. BEFORE EGYPT'S POLITICAL LEADERS WOULD TAKE THE POLITICAL PLUNGE, THEY WOULD WANT TO BE CENTAIN THAT THE SIZE OF THE US CONTRIBUTION WOULD BE SUFFICIENT TO HELP THEN TO NAMAGE THEIR ECONOMY WITHOUT NAVING TO MAKE THE DIFFICULT AND POTENTIALLY DESTABILIZING DECISIONS WHICH THEY ARE FACED WITH TODAY. FURTHERMORE, ONCE MAVING EXACTED THE INITIAL PAYMENTS AND OPENING ITSELF TO INATIONALIST CRITICISM, THE GOVERNMENT WOULD BE TEMPTED TO FEINT AND STALL, GIVING LESS THAN FULL COOPERATION IN CARRYING OUT THE CONTROVERSIAL PROJECT. FINALLY, SHOULD WE INDULGE OURSELVES BY EXPLORING THE POSSIBILITY OF BASE FACILITIES, WE WOULD RUN THE RISK OF COMPLICATING OUR DELICATE ELABORATION OF PREPOSITIONING AND OTHER ACCESS AND TRANSIT ARRANGEMENTS.

7. IN SHORT, WE SHOULD READ OUR REPORTS, KEEP TRACK OF THE EGYPTIAN DEBATE, BUT TAKE NO ACTION IN WASHINGTON OR CAIRO WHICH WOULD INDICATE AMERICAN INTEREST IN PURSUING BASE RIGHTS. BT
