Delahunt (D-MA), Member of HIRC; Mr. Caleb McCarry, Staff Director, Subcommittee on the Western Hemisphere (WHEM), HIRC; and Mr. Ted Brennan, Professional Staff Member, WHEM, HIRC, to join Codel Ballenger and travel on official business to El Salvador, Colombia and Brazil from May 29 through June 2, 2001. For purposes of protocol Members spouses will be authorized to accompany the delegation at no additional expense to the U.S. Government.

The purpose of this trip is to evaluate the progress of earthquake recovery efforts in El Salvador and to visit facilities involved with the implementation of Plan Colombia.
