

SUBJECT: Allegations of President Uribe's Ties to Narcotraffickers (U)

- (U) A recently declassified 1991 U.S. military intelligence report (Tab A) linked Colombian President Uribe to narcotraffickers, specifically Pablo Escobar, head of the Medellin Cartel.
- (U) On 2 August 2004, both the New York Times and the Los Angeles Times picked up
  the story. Newsweek subsequently posted a cover story on its Latin America web site
  (Tab B).
- (C) As of yet, there are no other (b)(1),1.4(c) reports that corroborate the 1991 accusations.
- (C) Uribe almost certainly had dealings with the paramilitaries (AUC) while governor of Antioquia—it goes with the job. We have no reports to suggest that drugs were part of the picture.
- (C) Informal soundings with key Hill staffers indicate that they, too, doubt the allegations. They are, however, concerned, as are we, with the direction of Uribe's peace talks with the AUC.
- (U) While president, Uribe has extradited 160 suspected narcotics traffickers to the U.S. He has always vehemently denied ties to narcotraffickers.



HE HAS PARTICIPATED IN NUMEROUS HURDERS OF HIGH OFFICIALS OF THE COLOMBIAN GOVERNMENT. HE WAS DETAINED IN THE PASSPORT OFFICE OF BOGOTA WITH A FALSE INDENTIFICATION CARD WHEN HE ATTEMPTED TO OBTAIN A PASSPORT, UNDER A FALSE NAME, IN ORDER TO TRAVEL TO THE US. HE IS BELIEVED TO LEAD AN ASSASIB NETMORK IN THE US.

12. JORGE BALPH ((ABRAHAMSON NANCHEIN)) - A 44 YEAR OLD COURDORAM, BORN IN AMBATO, ECUADOR NHO IS A MAJOR GROUP CHIEF FOR MEDELLIN CARTEL OPERATIONS IN ECUADOR. ABRAHAMSON IS CURRENTLY A FUGITIVE FROM ECUADORAM JUSTICE RELATING TO HIS LARGE SCALE NARCOTICS TRAFFICKING ACTIVITIES TO THE US. IN 1987 A BARCOTICS LOAD CONCEALED IN BERSMAX DISTRIBUTED BY THE CIMIX SHIPPING FIRM MAS SENT FROM AMBATO AND SEIZED IN THE EVERGLADES, FLORIDA. ECUADORAN AUTHORITIES SEIZED DROGS AND PROPERTIES BELONGING TO ABRAHAMSON BUT, HE REPORTEDLY, BRIBED THE JUDGES, ESCAPED FROM JAIL AND IS CURRENTLY BELIEVED TO BE LIVING IN EITHER COLOMBIA, PARAMAL OR THE US.

13. OLIVIERA ((ACUMA INFANTE)) - A RELATIVE OF WILLIAM INFANTE WHO WAS CAPTURED IN FLORIDA. THIS WOMAN SELONGS TO THE MEDELLIN CARTEL AND WORKED FOR GOMEALO RODRIGUEE GACHA. SHE ALLEGEULY PARTICIPATED IN THE MUNDER OF JAIME PARDO LEAL, PARTY CAMBIDATE FOR THE UNION PATRIOTICA, BUT WAS SET FREE THROUGH BRIBERY OF JUDGES. OLIVIERA IS EXTREMELY DAMCEROUS AND CURRENTLY HEADS THE MACOTICS TRAFFICKING NETWORK OF JUSTO ((PASTOR ROORIGUEZ)). SHE ALSO WAS AM ASSOCIATE OF THE DECEMBED TRAFFICKER VICTOR MANUEL ((LIMARES)). SHE IS BELIEVED TO TRAVEL IM AND OUT OF THE US. 14' ELICIA ((TORRES)) - FRONT PERSON AND MARCOTICS TRAFFICKER FOR GOMEALO RODRIGUEZ GACHA. ELICIA WAS PARTICIPATED IN TERRORIST ATTACKS IN BOGOTA.

15. Jaime ((Rodriguez Torres)) - am assassin and narcotics trafficer who operates in bogota and is am associate of justo pastor roomiguez gacha. Jaime seads a trafficking network between bogota and the us. He plans to travel to the us akd continue his strafficking operations. Date of birth - 030252.

16. Dandemis ((Brumoz Hosquera)) - alias "La Quica Cr Kika". An assassid and leader of am assassin gang in medellin mose center of operations is located in the barrio castilla of medellin. Candemis was a deserter from the colombian armed forces at the age of 17 who fled nith his assigned mearon. Be subsequently formed an assassin and bank robbing garg and was involved with killing of mumerous policemem between 1985 and 1990. Dandemis was captured in 1986, accused of more than twenty murders, numerous bank robberies, and the killing of hore than the folicemen. He was turned over to a medellin judge, who after being paid a two million peso bether released him. He was recaptured and turned over to the armed forces to day for the crimes of desertion and teeff of a military weapon, homever, he mysteriously was set free. In 1987, it was learned that minoi mosquera worked for the los priscos gang and for pablo escobar. This gang currently comprises approximately 100 criminals. Dandemis also has brothers who work in the garg. La kika/Quica is currently 25 years old?



# U.S. officials are worried that Uribe may let paramilitary drug kingpins go free

Aug. 9 issue - The swarthy, 65-year-old warlord cut an odd figure in his dark business suit, white dress shirt and red striped tie. And when it was time for Ramon Isaza to address a session of the Colombian Congress last week, the paramilitary supremo asked a lawmaker to deliver his prepared remarks. But the significance of the occasion was in no way diminished: Isaza, who is wanted for drug trafficking in Colombia, and two fellow paramilitary leaders, accused of murder in their native land, had been allowed to visit the capital city of Bogota on a 48-hour safe-conduct pass issued by the government of President Alvaro Uribe. Only a week prior to their appearance--where they asked for immunity from prosecution and extradition in exchange for pacifying their militias—a force of 50 U.S.-trained anti-narcotics policemen had raided a cocaine lab allegedly belonging to Isaza and seized 850 kilos of the drug. But that in no way dampened the enthusiasm of some pro-Uribe lawmakers over the paramilitary leaders' unprecedented visit. "This country is bleeding to death," said Congresswoman Eleanora Pineda. "What it wants is peace." But at what price? That's a question that some Colombians and not a few U.S. officials are asking themselves as the Uribe government completes its second year in office. Until the fairly recent past, the Colombian president had been receiving rave reviews within the Bush administration as the exterminating angel of the Washington-financed war on drugs. It wasn't always so: for years Uribe was dogged by accusations of links to drug traffickers—a charge he's denied in the past—and his name surfaced in a 1991 U.S. military-intelligence report about Colombia's notorious Medellin cartel (attached). But a record 140 suspected narcotics traffickers have been extradited

to the United States since Uribe was sworn in as president, and a massive aerial-furnigation program destroyed 30,000 hectares of planted coca fields between 2002 and last year. Last month Colombian police seized eight tons of cocaine with a U.S. street value of \$160 million—their biggest haul in six years—and the eradication campaign also reduced oplum-poppy cultivation by 15 percent in 2003.

Uribe's decision to begin peace talks with right-wing militias, however, has gone over badly with some U.S. officials. Some of the groups' senior commanders have been indicted by federal prosecutors on charges of drug trafficking, and last week's televised spectacle in Congress only seemed to make matters worse. "It's a bit strange," said U.S. Ambassador to Colombia William Wood, "that in Congress, where they write the laws, approve the laws and defend the laws, you would also find those who break the laws."

Bogota's policy of seeking a negotiated settlement with the paramilitary Self-Defense Forces of Colombia (AUC) comes as no surprise to longitime Uribe watchers. When he was governor of Antioquia department in the mid-1990s, right-wing militias operated with virtual impunity in rural areas and killed dozens of trade unionists and suspected sympathizers of Marxist guerrilla movements. Paramilitary chieftain Salvatore Mancuso publicly halled Uribe's victory in the 2002 presidential election, and he was one of the three warlords invited to speak before Congress. Mounting evidence of the para-military forces' involvement in drug trafficking has led U.S. officials to seek the extradition of Mancuso and four of his comrades in arms. But that has not deterred Uribe from ceding a zone of land to paramilitary forces, where they are immune from extradition so long as they continue taiking with his government. "A peace process is worth the trouble if there is an intention to reform," Uribe said in a recent radio interview. "[That] must represent a severing of all activities connected to drug trafficking."

That may prove to be an impossible demand to fulfill in practice. Uribe may talk tough on the subject of drugs, but he appears quite prepared to countenance some pretty shady characters if they are allied with the far right wing of Colombia's political spectrum.

Consider the case of Diego Fernando Murillo, aliegedly a onetime leader of an assassins' gang in Medellin who's been accused of overseeing much of the cocaine trade in western Colombia. He was indicted recently in New York on two counts of conspiracy to traffic drugs, and Murillo's deep involvement with Mancuso's right-wing militias is spelled out by federal prosecutors. The indictment describes Murillo as "the defacto leader of the AUC," and says he "has maintained his power in the AUC in part from the proceeds of his drugtrafficking activities."

Yet despite such an unsavory reputation, Murillo was on hand for the formal opening of peace talks between the paramilitary forces and the Uribe government earlier this year. The AUC's team of negotiators includes a former associate of convicted drug traf-ficker Alejandro Bernal named Ramiro Vanoy, whose extradition is being sought by prosecutors in Ft. Lauderdale, Florida. "Some of these people don't even have antiguerrilia credentials," says Adam Isacson, a Colombia expert at the Washington-based Center for International Policy. "They're just drug traffickers who've bought their way into the paramilitary movement as a way to claim political status, legitimize their fortunes and walk free."

That gets to the heart of the growing U.S. concern about Uribe's peace process. Democratic presidential nominee John Kerry takes a dim view of Colombia's paramilitary forces; he was one of 23 U.S. senators who signed a letter to Uribe dated July 26 urging him to prosecute any military or civilian officials of his government who have collaborated with AUC units. But the Bush administration must tread more carefully. At a time of surging anti-Americanism, the 52-year-old Uribe stands out as one of Washington's few staunch friends in Latin America. He backed the U.S. invasion of Iraq, and he has pushed through new laws in the energy sector to facilitate investment by U.S. and other foreign oil corporations. In exchange, Colombia has preserved its privileged status as the biggest recipient of U.S. foreign aid outside the Middle East. "This is probably one of the most pro-American presidents in Latin America's entire history," says Isacson. "Among administration officials and on [Capitol] Hill, you hear people compare him to Winston Churchill and Abraham Lincoln."

That may be a stretch, but millions of Colombians seem to feel the same way about their president. They elected Uribe on a promise to crack down on the country's Marxist guerrilla armies, and his tough law-and-order policies have driven down homicide and kidnapping rates during the last two years. All available evidence points to Uribe's remaining in the presidential palace for some time: his current term ends in 2006, and with his approval ratings hovering above 70 percent, he stands a good chance of pushing through a constitutional amendment later this year that would allow him to seek reelection to a second four-year term. For better or worse, Alvaro Uribe will be Washington's go-to man in Bogota for the foreseeable future, whether or not he cuts a peace deal with alleged drug traffickers whom U.S. officials would rather put behind bars.

## A declassified Pentagon report claims Uribe once worked for Pablo Escobar

Aug. 9 Issue - In September 1991 the U.S. Department of Defense compiled a list of Individuals believed to be associated with Colombia's notorious Medellin drug cartel. There are 106 names on the newly declassified intelligence document, and they read like a who's who of thugs, assassins, midlevel traffickers and crooked attorneys. The cartel's ruthless kingpin, Pablo Escobar, was prominent on the list, of course, along with the former Panamanian dictator Gen. Manuel Antonio Noriega. But the real head turner is item No. 82, which reads as follows: "Alvaro Uribe Velez---a Colombian politician and senator dedicated to collaboration with the Medellin cartel at high government levels. Uribe was linked to a business involved in narcotics activities in the U.S.... Uribe has worked for the Medellin cartel and is a close personal friend of Pablo Escobar Gaviria."

The Pentagon report portrays Uribe in a light sharply at variance with his current image as Washington's main ally in the U.S.-financed war on drugs in South America. But in those days, he was among dozens of Colombian pols who openly opposed the extradition of their drug-trafficking countrymen. Uribe has since changed his views—and, in fact, his government has sent scores of drug traffickers to the United States for prosecution since he took office.

The report was obtained by the National Security Archive, a Washington-based nongovernmental research group. The identity of the document's author was removed by Pentagon censors. The detailed thumbnail descriptions of the Medellin cartel's associates suggest that the data came from Colombian or U.S. counter-narcotics officials, and the text states at the beginning that the report "forwards profiles on the more important nerco-terrorists contracted by the Colombian narcotic cartels." It is stamped CONFIDENTIAL NOFORN WNINTEL, meaning that its contents shouldn't be shared with foreign nationals. The U.S. ambassador to Colombia in 1991, Morris Busby, does not recall the document, and efforts to reach the U.S. Defense Intelligence Agency Balson officer in Bogota in 1991, retired Army Col. James S. Roche Jr., falled to elicit a response. In a two-page written statement, the office of the Colombian president denied that Uriba had links of any kind to a business in the United States as asserted in the 1991 report.

But the statement did not address the allegations that Uribe had worked for the Medellin cartel and was a close friend of Escobar, who was killed in a 1993 police raid.
