This is an administrative appeal under the Freedom of Information Act. Through a letter dated 17 October 2006, the U.S. Air Force released a number of excised documents that your agency, among others, had reviewed. I ask for further review of these documents to determine whether more information may be released without harm to national security or foreign relations. I also ask the reviewers of this appeal to take into account previously declassified documents that are directly relevant to the information withheld in this case. The availability of this material, some of which various agencies, including the Air Force, the Defense Department, and the State Department declassified some years ago, should make it possible to release substantially more information from these documents.

One of the heavily excised documents in this release is an "Oral Presentation" by General Hickey, 6 November 1959, concerning a report on alternative retaliatory efforts that the NSC's Net Evaluation Committee, which Hickey directed, had prepared at the direction of President Eisenhower pursuant to NSC Action 2009. The details of Eisenhower's request, to determine the "relative merits ... of alternative retaliatory efforts directed toward a) primarily a military target system, b) primarily an urban-industrial target system, or c) an optimum mix of combined military-urban-industrial target systems," has been declassified for years. It has also been published in the State Department's Foreign Relations series (see enclosures 1, 2, and 3). Moreover, the JCS has declassified JCS Chairman General Twining's "terms of reference" to General Hickey, e.g., to develop target lists based on the alternatives listed above (see enclosure 3).

Significant information on the conclusions of the NESC/Hickey study has also been declassified over the years; e.g., JCS Chairman Twining's observation that the study showed that a "retaliatory force structure based on the destruction of an urban target system would not provide an adequate military posture" (see enclosure 4). A SIOP briefing prepared for President Kennedy includes summary information on the Hickey report, e.g., that "Successful attack of the optimum-mix [target] system should result in the US prevailing in general war" [see enclosure

5]. Finally, it should be possible to release more information on specific target types discussed in the Hickey presentation. Over the years, the Defense Department has declassified, and the Foreign Relations series has published, significant material from the early 1960s on strategic targeting priorities and target types (see enclosures 6 and 7). In light of these releases, much more information from this Cold War-era war planning document should be ripe for declassification release without harm to national defense. Indeed, I question whether the continued withholding of information from the decades-old Hickey report serves any significant national security interest.

Another document with significant excisions is a "US Air Force Structure Presentation to Congress by Col. Evans, 28 Jan 59." Much of the same information is withheld from a subsequent 2 February 1959 presentation. Again, previously released information is relevant to the release of additional details from this document:

- P. 12: excision re: targets. Again, information on target types and categories in enclosures cited above, especially 6 and 7, should make it possible to released more information from this page. In addition, a declassified speech by General Curtis LeMay from May 1957 also contains information on target priorities (see enclosure 8).
- P. 12A: withheld details re: possible deployment locations of Jupiter IRBMs. Previously declassified information, some published in a publicly-released Air Force history, shows that Italy, Greece, and Turkey, among other countries were considered as deployment sites for Jupiters. They were finally deployed in Italy and Turkey until early 1963 (see enclosures 9 through 12)
- P. 12A: withheld details on Polaris submarine patrol areas. The State Department and the U.S. Navy has released information on patrols slated for Norwegian sea as well as Sino-Soviet target priority (see enclosure 13).
- PP. 13 and 14: withheld details on ICBM and B-52 target range. That the Soviet Union, China, and satellite countries were within range of ICBMs should be easily declassified. Moreover, enclosure 6 at pages 5 and 6 contains relevant detail on targets slated for attack by ICBMs and other delivery systems.
- P. 15: Details withheld from this page most likely concern Strategic Air Command ground alert operations, involving a capability for a 15 minute reaction time by alert bombers. Considerable detail has already been released on SAC's ground alert concepts and its implementation (see enclosures 14, 15, and 16).
- P. 16: Bomber and missile force information withheld on this page should be easily releasable. Details on missile force numbers and bombers may be found in enclosure 6 at page 2.
- P. 24: Excisions re: warning systems, space detection of missile launches, Ballistic Missile Early Warning System. Significant declassified information on these issues may be found in a study by the Institute for Defense Analyses, *History of Strategic Command and Control and Warning*, 1945-1972 (see enclosure 17). For the SAGE system, see pages 214-216, for BMEWS, see

pages 216-218 and 340-341, for the Bomb Alarm System, see pages 218-219; for space-based launch detection systems such as SAMOS and MIDAS, see pages 219 and 345. Related information from the State Department (see enclosure 18) may also be relevant. The availability of this declassified information on the warning problem during the Cold War should make it possible for the Defense Department to release this page in its entirety.

- P. 25: Excisions re: BOMARC air defense system. The excisions may relate to proposals to deploy BOMARC and interceptors in Canada. Declassified information on this subject is also available (see enclosures 19 and 20)
- P. 42: Excisions re: possible space military capabilities. Information on this subject has already been declassified. Besides the details on SAMOS/MIDAS that may be found in enclosure 17, the Air Force has declassified general information on proposed orbital interceptor and satellite inspector (SAINT) systems (see enclosure 21)

Another excised document released by the Air Force is a 20 January 1959 "Summary of Actions Taken by the Joint Chiefs of Staff." Excised from this document is part of a proposed statement, discussed with Canadian authorities, on acquisition and control of nuclear weapons. If you have not already done so, I ask that the Canadian embassy be consulted to determine whether it has any objection to the release of this statement. In any event, considerable formerly sensitive information has already been declassified on the U.S.-Canadian nuclear relationship during the late 1950s (for example, see enclosure 18). In light of that, and assuming Canadian agreement, it should be possible to release the rest of the statement.

Several portions were excised from one of the documents, "Summary of Actions Taken by the Operations Deputies at their Meeting," 3 January 1959. I question whether, after so many years, any of the information excised from this documents remains so sensitive that it must continue to be withheld.

We have reviewed the material attached to your memorandum and have no objection to declassification/release of the marked portion of the document numbered 5 (i.e., the portion entitled "SUBJECT: Draft Statement for Possible Use in the House of Commons Regarding the Acquisition and Control of Nuclear Weapons"), to which our review has been limited. We have referred a copy of the document numbered 2 to the British Embassy for concurrence in release of item #6 on page 3, the portion which you designated for our review. We will inform you when the Embassy has replied.

With respect to both documents, we would note that DOD has expressed the view that material involving military utilization of nuclear weapons, storage, deployment location, etc., falls under the Atomic Energy Act of 1954 in that it is considered Formerly Restricted Date (FRD) and is, therefore, not releasable. DOD may deem the designated portions of these documents to constitute such material. Accordingly, we believe these portions should be forwarded to Mr. A. H. Passarella, Director, FOI/Security Review at DOD for a release/denial determination based on the material's relevance to the above-cited Act.

This letter constitutes an administrative appeal in accordance with the Freedom of Information Act (FOIA), 5 U.S.C. Sec. 552., of the Department of Defense response to a FOIA request I submitted on August 10, 2006 to the Department of Defense. The request was for all documents from 1998 to the present that pertain in whole or in part to the participation of Department of Defense officials in meetings of the National Security Council Principles Committee pertaining primary to Colombia. In a letter dated August 10, 2006 the Department of Defense informed me that 93 pages of documents responsive to my request were found (Attachment 1). The letter further advised me that all information contained within these pages is classified under Sections 1.4(a), (b), (c), and (d) of Executive Order 12958, and thus cannot be released. I appeal the decision to withhold this information.

Several documents responsive to my request have already been declassified and released by the Department of Defense. For example, in response to previous FOLA requests, the Department of Defense has sent me the read-aheads for Principals Committee Meetings that took place on July 7, 1998 (Attachment 2), September 9, 1999 (Attachment 3), and September 24, 1999 (Attachment 4). According to the released documents, all three of those meetings focused on Colombia.

I would expect that most of the documents reviewed in response to this FOIA request primarily pertain to the development and implementation Plan Colombia, a multi-billion dollar counter-narcotics, security, and development program. In reviewing these documents, I ask that you keep in mind that Plan Colombia is the centerpiece of American policy in Colombia and one of the most important American programs in all of Latin America.

When Plan Colombia was first announced, President Clinton called it "urgently needed" and "in our fundamental national interest" (Attachment 5). In 2000, Brian E. Sheridan, Assistant Secretary of Defense for Special Operations and Low Intensity Conflict gave detailed testimony before Congress about Plan Colombia (Attachment 6). Claiming that "the US has a vital material interest in the success of this plan," he outlined the various aspects of the program as well as "concerns" that the Department of Defense had about the plan,

including the poor organization of the Colombian Armed Forces, the human rights situation in Colombia, and the possibility of the US becoming engaged in Colombian counter-insurgency efforts.

I also ask you to note that the Presidential Decision Directive on Colombia has been declassified and released by the Department of State (Attachment 7). This directive is the promulgation of the policy shaped in the National Security Council Principles Committee meetings that I have requested documents from. The document says that one of the "primary objectives" of Plan Colombia is to "increase the capability of the Colombian National Police, in conjunction with the Colombian Armed Forces units, to curtail the cultivation and production of illicit drugs in Colombia" as well as "to interdict shipments of illicit drugs and the precursor and essential chemicals necessary for the production of such drugs at and within the borders, including the territorial waters, of Colombia."

I would remind you that non-sensitive material must be released unless inextricably intertwined with other sensitive material. At a minimum, I expect that document titles, dates, subject headings, and other non-sensitive material can be released without disclosing sensitive information.







Dear Sir or Madam:

This letter constitutes an administrative appeal in accordance with the Freedom of Information Act (FOIA), 5 U.S.C. Sec. 552., of a Department of Defense response to a FOIA request I submitted on April 1, 2003. The request was for any information about the activities of California Microwave Systems, Inc. (CMS) in Colombia. I further requested that you search all reporting on or monitoring of CMS operations in Colombia and documents that relate to Northup Grumman (or any other subdivision thereof) involvement with aerial reconnaissance (whether for counternarcotics, counterinsurgency, or any other purpose) programs in Colombia. According to the Department of Defense's letter of response, dated March 31, 2008, 118 were withheld in full and portions of an additional eight documents were withheld on the basis of Sections 1.4(a)(b)(c)(d), Sections 3.3(b)(5)(b)(6), and exemptions (b)(1), (b)(5) and (b)(6).

It is likely that the documents in question pertain to CMS involvement in the SOUTHCOM Reconnaissance System (SRS), a U.S. intelligence-gathering program in Colombia. Two planes operated by CMS personnel crashed over Colombia in February and March 2003: the first during a counterdrug surveillance mission, the second while assisting search and recovery efforts relating to the first accident. Two men from the February plane (a CMS employee and a Colombian military officer) were executed by members of the Revolutionary Armed Forces of Colombia (FARC). Three CMS employees that survived the February crash were subsequently taken hostage by the FARC.

I would point out that these accidents and the subsequent investigations are discussed in declassified documents and have been the subject of several news stories. In reviewing the withheld material for maximum declassification, I would ask that you please consider the detailed information already available about CMS, the February and March 2003 crashes and the SRS program.

An April 3, 2003 Department of Defense document released on appeal in a separate FOIA request (DOD case # 05-F-1817; 05-A-1817) contains the following details about the February and March crashes.

At approximately 0852 hours on February 13, 2003, contact was lost with SRS # 2...The Americans on board were California Microwave Systems (a susiduary [sic] of Northrup-Grumman) contract employees. The Colombian on board was Colombian Army host nation rider. The senior pilot and the host nation rider were killed by the FARC. Three crewmembers were taken hostage by the FARC...

An independent non-governmental research institute and library located at the George Washington University, the Archive collects and publishes declassified documents obtained through the Freedom of Information Act. A tax-exempt public charity, the Archive receives no U.S. government funding; its budget is supported by publication royalties and donations from foundations and individuals.

In the evening of March 25, SRS #1 crashed eleven nautical miles north of Larandia...It was on a search and rescue mission for the missing crew of the previous crash. The plane was carrying three American crewmembers and no host nation rider.

The document mentions the ongoing formal investigation into the crashes, as well as media reports on the safety concerns regarding single engine aircraft operations in Colombia. In particular, the document notes that both the Los Angeles Times and the Miami Herald reported that two former California Microwave employees had "repeatedly warned their employers of the risks of the Colombia SRS missions. Specifically they cited the following concerns: danger of use of single-engine Cessna due to high elevations flights and triple canopy jungle, frequent night flights, heavy equipment loads." Southern Command reportedly acknowledged that they received the letters and "assessed it was an internal Northrup/Grummon issue," but also adjusted flight routes and requested "an operational standdown to evaluate the problem." (Attachment 2)

A State Department cable from April 2003 also mentions the safety concerns of the two former SRS pilots whose "November and December 2002 letters to Northrop Grumman management officials raised concerns about the safety of the SRS program." The cable refutes a claim published in the Los Angeles Times stating that the U.S. planned to continue to use single-engine Cessna airplanes in spite of two deadly crashes. (Attachment 3)

A July 1, 2003 investigation report, recently released by U.S. Southern Command (SOUTHCOM FOIA case # 04-111), includes extensive details about the March 2003 plane crash and the SRS program in general. The "Mishap Narrative" that begins on page five is a detailed summary of the events surrounding the accident, including the accident, The "Summary of Evidence" that begins on page ten includes specific information about the mission and organization of the SOUTHCOM Reconnaissance System and the SRS contract, awarded to California Microwave Systems through its parent company, Northrup Grumman Systems Corp. The report contains detailed information about the contract and the roles of the companies involved. In the analysis of the accident itself, the report notes prior engine problems with the Cessna 208B and personnel issues within the SRS program, including one pilot's perception that there was an "SRS 'culture' of not always operating 'by the book'". Some of the theories accepted in the report's analysis include:

- SRS aircrew operated SRS aircraft in a complacent manner.
- Pilot at the controls was not prepared to navigate properly on the route flown.
- The Contract failed to establish an adequate means to ensure quality control of the contractor's method of performance.
- SRS local leadership failed to properly control and discipline unprofessional and unsafe practices. (Attachment 4)

Although much of the declassified material addresses the SRS program and the plane crashes, U.S. government agencies have also released documents about the ongoing efforts to free the CMS employees held hostage by the FARC. A **Department of Defense** information memo released on appeal in FOIA case # 05-F-1817; 05-A-1817 details talking points for a meeting with representatives of Northrop Grumman. The memo notes, "It is U.S. Government policy to assist an employing organization's efforts to secure their employees safe release...It is also U.S. Government policy to deny hostage takers the benefits of ransom, prisoner releases, policy changes, or other acts of concession." The memo also notes that Northrop Grumman planned to withdraw from the SRS program as of June 2003. (Attachment 5)

Aside from government documents, numerous news articles published in the past few years have also covered the incident, the safety concerns expressed by the pilots and the ongoing hostage situation.

- The Washington Times, March 18, 2003: Attesting to CMS's involvement in Colombia, this article quotes the CMS website: "Our real-time intelligence systems have been used in peacekeeping operations in Korea, Haiti and Bosnia, and for counternarcotics in Colombia and South America and the Caribbean,' the site says." (Attachment 6)
- The New York Times, February 14, 2004: Regarding the CMS employees who were taken hostage by the FARC, the article explains that, "The three Americans -- Marc Gonsalves, Keith Stansell and Thomas Howes -- worked cloaked in secrecy for two subsidiaries of Northrop Grumman, the huge military contractor, in an arrangement used increasingly by the United States government in conflict zones from Colombia to Afghanistan." The article further reports that "rebels killed two other survivors: an American pilot, Tom Janis, and a Colombian intelligence officer. Weeks later, on March 25, a plane on a mission to track the captives hit a tree. Three more Americans were killed: Tommy Schmidt, Ralph Ponticelli and James Oliver. The men were part of a team of a dozen or so pilots and technicians overseen by the American military mission in Latin America, the Southern Command, based in Miami. Their operation was dubbed the Southcom Reconnaissance System, and Northrop Grumman held the \$8.6 million contract for the work." (Attachment 7)
- Atlanta Journal Constitution, May 9, 2004: In reference to a federal lawsuit filed by families of the victims, this article states, "The suit alleges Northrop Grumman used single-engine Cessna 208B Super Caravans in the program because they were less costly than multiengine craft. The suit says government and Northrop Grumman officials ignored warnings from pilots that the planes were 'underpowered and unable to provide a safe platform for the surveillance." (Attachment 8)
- Times-Picayune, May 21, 2004: "Families of four American civilian contractors killed when two Defense Department drug surveillance planes crashed in Colombia in February and March 2003 have filed federal lawsuits alleging that negligence led to the deaths." The article describes the nature of the suits, which target "companies involved in the manufacture and maintenance of the airplane and its engine," as well as "companies that ran the spy plane program, the Defense Department and various people involved. The suits, all of which seek damages, deal with the Southcom Reconnaissance System, a program run under the auspices of the Defense Department's Southern Command, which is based in Miami. Following the trend of contracting jobs once performed by military personnel to private companies, the program was outsourced to California Microwave Systems, a division of defense contractor Northrop Grumman Corp." (Attachment 9)
- The Los Angeles Times, December 1, 2007: Northrop Grumman made news again following the recent discovery of video footage of hostages "Thomas Howes, Keith Stansell and Marc Gonsalves, employees of defense contractor Northrop Grumman Corp. who were captured when their plane crash-landed in the Colombian jungle in 2003. The videos offered the first "proof of life" of Betancourt and the three Americans in more than four years. Also captured were letters and documents, including a will written by Howes that had Monday's date." (Attachment 10)

Considering the extensive information already publicly available about CMS's involvement in Colombia and the CMS employees involved in the plane crashes, including their identification and the legal action their families plan to take, I ask that you please review the withheld material in this case. Given the public knowledge, it is reasonable to assume that, at a minimum, portions of the withheld and excised documents could be released at this time.

With respect to the material withheld on the basis of FOIA exemption (b)(1), I ask that you use your discretion to release the sections that are either factual and/or descriptive, or that are no longer time sensitive. I would remind you that non-sensitive material must be released unless inextricably intertwined with other sensitive material. At a minimum, I expect that document titles, dates, subject headings, and other non-

sensitive material could be released without disclosing sensitive information.

With respect to the material withheld on the basis of exemption (b)(5), I ask that each portion of these documents be independently evaluated to determine whether they are, in fact and according to law, exempt from mandatory disclosure. Furthermore, any claim of exemption five is wholly discretionary - material believed to be covered by it can always be disclosed as a matter of agency discretion. In fact, the Justice Department's Office of Information and Privacy has advised that agencies may exercise their discretion to release information previously withheld under the (b)(5) exemption. Where the government has complete discretion to assert or not assert an exemption, consideration should be given (as Congress has made clear) to the public interest in disclosure. I ask that our request for such a release be given careful, sympathetic consideration. I would also remind you that the courts have ruled that the (b)(5) exemption should not apply to "statements of policy and interpretations which have been adopted by the agency." [Federal Open Market Comm. v. Merrill, 443 U.S. 340, n.23 1979; Schwartz v. IRS, 511 F.2d 1303, 13 05-06 (D.C. Cir. 1975); Bristol-Myers Co. v. FTC, 424 F2.d 935 (D.C. Cir. 1969)]. Morcover, to fall under exemption (b)(5), a document must be a direct part of the pre decisional process in that it makes recommendations or expresses opinions on legal or policy matters to be decided by the agency, and furthermore that the government must carry the burden of establishing the existence of a genuine pre-decisional process. Portions of the documents not meeting these requirements should be released.

Pursuant to the Freedom of Information Act (FOIA), I hereby request disclosure of all documents relating in whole or in part to the activities of California Microwave Systems, Inc. (CMS) in Colombia. According to press accounts (please see *The Washington Times*, March 18, 2003), CMS is a division of Northrup Grumman and specializes in imagery, communications and electronics intelligence. It has acknowledged performing reconnaissance missions in Latin America, and has been the recipient of contracts from the U.S. Army to develop specialized image-gathering aircraft to be used by the U.S. Southern Command for Aerial Reconnaissance Low projects (for more information on this topic, please see http://www.globalsecurity.org/intell/systems/arl.htm).

Most of what has been publicly revealed concerning CMS is based on information that has surfaced since February 2003, when employees of CMS on board a small plane in Colombia were forced to make an emergency landing in Caqueta, Colombia. Two men from the plane (one an CMS worker, the other a Colombian military officer) were allegedly executed by troops from the Revolutionary Armed Forces of Colombia, or FARC. Three remaining CMS employees were subsequently taken hostage by the FARC.

While I seek any documents generated as a result of this incident, I also request that you search for all reporting on or monitoring of CMS operations in Colombia prior to the downing of the plane. Please search for material that makes specific reference to CMS, as well as all documents that relate to Northup Grumman (or any other subdivision thereof) involvement with aerial reconnaissance programs in Colombia, whether they are for counternarcotics, counterinsurgency, or any other purpose.

If you regard any of these documents as potentially exempt from the FOIA's disclosure requirements, I request that you nonetheless exercise your discretion to disclose them. As the FOIA requires, please release all reasonably segregable nonexempt portions of documents. To permit me to reach an intelligent and informed decision whether or not to file an administrative appeal of any denied material, please describe any withheld records (or portions thereof) and explain the basis for your exemption claims. I also ask that no material be omitted on the basis of "non-relevance."



This responds to your Freedom of Information Act/Privacy Act request dated April 1, 2003, Archive # 20030247DOD018, and received in this Office on April 1, 2003, for records pertaining to, "the activities of California Microwave Systems, Inc. (CMS) in Colombia." The eight enclosed documents are provided as responsive to your request. Please note one document located for this request was not processed because it was handled on case number 05-F-1817, as documents B13 and B13A.

Mr. Robert Newberry, Principal Director, Office of the Deputy Assistant Secretary Of Defense, Counter-Narcotics has determined that portions of these eight documents, as well as 118 additional documents totaling 498 pages which are being denied in their entirety, are exempt from release because they are currently and properly classified in accordance with Executive Order 12958, as amended, specifically, Section 1.4 (a) concerning military plans, weapons, or operations; Section 1.4 (b) concerning foreign government information; Section 1.4 (c) concerning Intelligence activities (including special activities), intelligence sources or methods, or cryptology, and Section 1.4 (d) concerning foreign relations or foreign activities of the United States, including confidential sources. The information denied is exempt from automatic declassification in accordance with Section 3.3 (b)(1), which could reveal the identity of a confidential human source, or a human intelligence source, or reveal information about the application of an intelligence source or method; Section 3.3 (b)(5) which could reveal military war plans which remain in effect, and Section 3.3 (b)(6), which could reveal information, including foreign government information, that would seriously and demonstrably impair relations between the United States and a foreign government, or seriously and demonstrably undermine ongoing diplomatic activities of the United States. Additional information is exempt from release pursuant to 5 U.S.C. § 552(b)(5), which pertains to certain inter- or intra-agency communications protected by the deliberative process

privilege. Further information has been withheld pursuant to 5 U.S.C. § 552(b)(6), which applies to information that, if released, would constitute a clearly unwarranted invasion of the personal privacy of third parties. Accordingly, this information is denied pursuant to 5 USC § 552 (b)(1), (b)(5) and (b)(6).

In order for the Deputy Director, Administration and Management to fulfill responsibilities as the appellate authority, we ask that you conduct another review of the attached 121 documents (documents 2-8, 11-29, 32-61, and 63-127). Please note that Documents 2 and 4 were partially released. All the remaining documents were withheld in their entirety.

Taking into consideration the passage of time, the subsequent release of the hostages, and the fact that certain information has already been publicly released, we believe significant portions should be released on appeal. Therefore, we request that you conduct a line-by-line review, bracket any information you determine should remain withheld, eite the FOIA exemption(s) invoked, and provide your rationale for withholding. While conducting your appellate review, please keep in mind the United States Attorney General's latest guidance, i.e., there is a presumption of openness and FOIA Exemptions 2 and 5 may only be used if the agency can articulate a foreseeable harm. Also, please note that the unclassified portions of classified documents cannot be withheld under FOIA Exemption 1.

Once we receive your appellate review, we will ask the United States Southern Command to review the documents for their equities. Afterwards, we will forward the Defense Intelligence Agency documents and the Department of State documents to those agencies for their final response.







This letter is an administrative appeal regarding a Freedom of Information Act (FOIA) request submitted on July 26, 2004 by Peter Kornbluh. The request was for all documents related in whole or in part to the Department of Defense plan code-named "Desert Badger." In the Department's letter of December 07, 2006 it was stated that a search located thirteen pages of responsive material which was withheld in full under exemption (b)(1).

The information within these pages is highly unlikely to harm "military plans, weapon systems or operations." General details regarding the plan are already public knowledge through statements given by public officials, including President George W. Bush, and media reports. This plan was also discussed in the attached excerpt from Bob Woodward's book, Plan of Attack. More importantly, this plan was completed before the 2003 invasion of Iraq and was made obsolete by that invasion because this plan was designed to react to potential actions which may be taken by Saddam Hussein's government in Iraq. In this case, it is apparent that the extraordinary public interest regarding the military planning against the Saddam government outweighs the desire for secrecy. For the same reasons, it is unlikely that the release of any information contained in these pages would threaten the "foreign relations or foreign activities" of the U.S. since it concerns relations which a regime no longer in power. The historical and public interests in these matters outweigh secrecy concerns in this regard.

I appreciate your search of records, but ask that you review these pages again while giving due interest to the extraordinary public interest concerning the U.S. relationship with Iraq before the war and information which is already public knowledge. Please use your discretion to ensure maximum disclosure of information. At a minimum, I request that the Department release all reasonably segregable information in the documents.





This is an appeal under the Freedom of Information Act, regarding request 04-F-2766.

In a letter of January 6, 2009, Will Kammer rejected my April 29, 2004, request for "all photographs showing interior areas of Camp X-Ray and Camp Delta" and "all photographs of detainees who are being kept, or who were kept, at Camp X-Ray and Camp Delta from 11 Jan 2002 to the present."

I am appealing the latter ruling, regarding photos of detainees. In withholding all 5,537 photos in their entirety, Mr. Kammer cited exemption (b)(1), with particular regard to material concerning "intelligence activities (including special activities), intelligence sources or methods, or cryptology."

First of all, I ask you to make sure that not a *single one* of those 5,537 photos is releasable. The FOIA requires the release of "any reasonably segregable portion of a record" that is releasable. Any individual photo from among the 5,537 would be reasonably segregable. Therefore, I ask that you make sure that each individual photo is truly unreleasable.

Second, it seems odd that not a single photo can be partially redacted in a way that makes it releasable. I ask that you consider whether applying redactions to the photos would make at least some of them releasable.

Finally, I assume that when each detainee enters the system, a mugshot is taken of him. Certainly there are many such mugshots among the 5,537 photos. It would seem that such mugshots, which reveal nothing except the detainee's face, are releasable in that they would not compromise intelligence activities, sources, or methods. After all, the DOD has already released lists of all Guantanamo detainees, so their names and nationalities are already a matter of public record. Their mugshots should be, as well. If absolutely necessary, a black bar could be placed across their eye area to make them unrecognizable, although this would be odd since mugshots are always released unredacted.

On a related matter, if photographs are released, I request that they be in digital format, rather than print-outs. Under section a(3)(B) of the FOIA, an agency must provide records in any format that is requested if they are "readily reproducible" in that format, which digital documents are.







In a letter dated March 19, 2007, Will Kammer informed me that MENA director Paul JC Hulley had determined that two responsive documents would be withheld in their entirety under exemption (b)(1).

I ask that you reconsider your decision to withhold this material. Sixteen years have passed since Secretary Cheney's trip. The policies of the first Bush administration regarding the Persian Gulf in general and the intent of Cheney's trip in particular have, during ensuing years, been extensively described and analyzed in press accounts, books, articles, and congressional reports. The purpose of the visit included rallying the Saudis in opposition to Iraq's invasion of Kuwait and persuading that country's leadership of the necessity of military cooperation with the U.S., including the prepositioning of forces. It is extremely doubtful that release of documents responsive to this request could in reality have negative consequences for national security. These documents do, however, have historical significance and their release would contribute to the public's understanding American foreign policy. I therefore ask that you review withheld information again in order to ensure maximum disclosure of information





This is an appeal under the Freedom of Information Act, 5 U.S.C. 552. On May 6, 2004, I filed the attached request. The response is attached.

The response was not correct for the following reasons:

1)Information on unexploded military munitions is available in other forms through EPA environmental impact statements and a variety of other sources, including the U.S. General Accounting Office. "A Guide to Military Installations in the U.S." published by the Army, Navy and Air Force Times and Jane's Defense publications also offer similar information by providing locations of former ranges. Hundreds of claims and suits filed under the Federal Tort Claims Act also specifically identify installations, munitions, dates, etc. — all information freely provided by the government during discovery. I have obtained hundreds of pages of these documents. An Internet search of media reports identified dozens of locations where military munitions have been found at former range sites, the types of munitions found and when the munitions were buried. Any teenage boy within 10 miles of a former military range likely knows where they are, too. Having done two series of stories on lost and stolen military weapons, I can tell you that some of those teenage boys have been injured by UXO.

If ranges — many decades old — containing unexploded military ordinance are such a threat to national security and the agency's operation, why then does the government make their locations public, allow media officers to speak about them openly, conduct town hall-type meetings all over the country to explain environmental cleanup plans, provide hundreds of thousands of pages of records to hundreds of private attorneys across the country? These locations are not only unclassified, they are openly identified and discussed by the military. In fact, people are building subdivisions and schools over these locations, quite aware — through laws requiring disclosure — that they exist and exactly where they exist and exactly what is buried. In fact, the military has deemed them safe for human habilitation and encouraged development.

To deny the press the same information in a different form only serves to prevent the public from learning the extent of the dangers and only serves to protect the department from potentially embarrassing information. Terrorists face greater danger trying to dig them up than their potential victims would ever face. Besides, no terrorist or other criminal has ever committed a crime using an unexploded device dug up from a former military range — not that releasing this information would help them at all.

2)Thus, the response offered no concrete evidence or even possibility how release of information — nearly all of which is available in another form — could in any way impede future investigations, impede the agency in the conduct of its mission or lead to the circumvention of an agency rule.

3)There are virtually no privacy concerns related to buried military munitions, and if there were, the information could be edited out of the release material, as I requested. Again, much of the information about these locations is available in other forms and even required to be disclosed by law. Real estate laws in many states require disclosure of such hazards, and federal law requires disclosure via environmental impact statements. Even if there were some privacy concerns — which, again, could be edited out easily — they would be outweighed by the intense public interest in this issue, which involves not only public health and safety but also billions in potential tax dollars and environmental concerns. Even the response acknowledged that only "some" of the information involved privacy concerns.

4)I asked for a complete record layout (data dictionary) and only received the name of some fields. No exemption was cited for denying me a complete record layout. The response doesn't certify that these are all the fields, and even if it did, this is not a complete record layout (data dictionary). Since I will need the complete record layout to know all of what was denied, I reserve the right to file a further appeal once I receive the complete record layout I requested. In addition, the response doesn't — as I specifically requested — say which fields are related to which exemptions. The date field, for example: Which exemption does that fall under? Location? Which exemption is that covered by? Not knowing these thing hampers my ability to file an appeal.

I respectively asked that you consider that this request and appeal are made by a journalist working for a newspaper in this country and that the information I seek is sought under a law intended by Congress to keep our citizens informed about the activities of government – a law our government and many others feel is vital to a free nation. I also respectively ask that you consider that this response is not in keeping with the spirit or the letter of that law or with your own policies.

In any case, I expect to receive your decision no later than by 20 business days, as

the statute requires.


This is in response to your May 6, 2004, Freedom of Information Act (FOIA) request, which was received in this Office on May 6, 2004.

Ms. Sarah Hagan, Program Analyst for the Deputy Under Secretary of Defense for Installations and Environment, an Initial Denial Authority, has determined that the database with entries responsive to this request is denied in its entirety. This information is exempt from release because its release would allow circumvention of an agency rule, policy, or statute, thereby impeding the agency in the conduct of its mission. Release of this information would impair the integrity of the process whereby mishap information is obtained and evaluated, thereby impeding any future investigations. Release of the accident information could lead to determinations of locations of specific weapons and would potentially assist terrorists or other enemies of the U. S. in exploiting fulnerabilities of the security procedures associated with the storage of weapons. Additionally, some of this information is exempt from release because it pertains to personal information which, if released, would constitute a clearly unwarranted invasion of the personal privacy of the individuals concerned. Therefore, this information is withheld pursuant to 5 USC § 552 (b)(2) (High) and (b)(6).

Concerning the portion of your request for the database fields, the following are available fields: Location, Installation, Command, Type of Explosives or Munitions, Operation, Narrative, and Date.

You may appeal Ms. Hagan's decision to withhold the information by submitting your rationale to reverse the initial decision. Any such appeal should be postmarked within 60 calendar days of the date of this letter to the address on the letterhead above, and cite our case file number 04-F-1433.

Each document is directly referenced in the 9/11 Commission Report, Chapter 4, Responses to Al-Queda's Initial Assaults which discusses pre-9/11 U.S. policies that attempted to combat the growing threat al-Queda was posing to the safety and security of U.S. assets and interests. Firstly, I ask the Policy, Appeals and Litigation Branch to reconsider the initial determination to withhold these seven documents in full. Although I understand the sensitivity of the materials, the overwhelming public interest in these documents and the fact that the fundamental discussion of these documents has already been released to the public through the 9/11 Commission Report, including the release of quotations and summaries directly from the documents themselves, provides strong justification for further review and release.

For example, the 9/11 Commission Report provides the following specific details regarding documents 6-7:

"After the decision—in which fear of collateral damage was an important factor—not to use cruise missiles against Kandahar in December 1998, Shelton and officers in the

Designed specifically for the special forces, the version of the AC-130 known as "Specky" can fly in fast or from high altitude, undetected by radar; guided to its zone by extraordinarily complex electronics, it is capable of rapidly firing precision-guided 25, 40, and 105 mm projectiles. Because this system could target more precisely than a salvo of cruise missiles, it had a much lower risk of causing collateral damage. After giving Clarke a briefing and being encouraged to proceed, Shelton formally directed Zinni and General Peter Schoomaker, who headed the Special Operations Command, to develop plans for an AC-130 mission against Bin Ladin's headquarters and infrastructure in Afghanistan. The Joint Staff prepared a decision paper for deployment of the Special Operations aircraft, 141"

Additionally, the information contained in these withheld documents is almost certainly immaterial and outdated for current national security purposes due to the tremendous changes that have since taken place in related U.S. counterterrorism and foreign policies. At this date, almost 10 years since the creation of most of the documents requested, and over five years since 9/11 and the elemental change 9/11 had on every debate related to al-Qaeda and U.S. national security policy, the material contained in these pre-9/11 documents on bin Laden, al-Qaeda, U.S. allies and U.S. interests, seem almost certainly primarily limited to interesting historical information, irrelevant for current policies or security concerns.

Furthermore, I would argue that the use of the (b)(1) exemption to withhold documents such as these that would elucidate the policy decisions made by the U.S. government in the years preceding 9/11, or documents relating to what information the U.S. government had on the threat of al-Qaeda before 9/11 is inappropriate considering it is the duty of the U.S. government to be transparent regarding such a matter of public safety when it relates to an event so far past, with little contemporary operational sensitivity. Classification should not be used as a barrier to public access to primary source government materials that may serve to empower the public dehate and heighten government accountability on these issoes. Considering the eventual impact the al-Qaeda threat on public safety and the importance of these documents to public debate on security policies before 9/11, releasing these documents, at least in part, is entirely appropriate, especially in light of the enormous changes in U.S. counterterrorism policy since the creation of these documents in 1998-1999.

Regarding the two documents that were not located - (5) DOD order. Execute Order (EXORD), Dec. 18, 1998 [116] 8) DOD order, MOD 001 to CJCS warning order, Feb. 8, 1999 [153]) Although we greatly appreciate the Department's initial efforts to locate the requested documents and do not wish to further burden the Department, by this letter I request an additional search be conducted to locate these two documents. The National Security Archive has reason to believe that the documents were cited correctly in the initial request, that the documents are important to locate, review and release under the FOIA in order to better inform the public on an issue of overwhelming public interest and that the requested materials are under the control of the Department of Defense. We request the Department search all locations reasonably expected to contain the requested documents.

Again, it is not my goal to create extra work for the Department, but I do feel the documents were reasonable and accurately described and if located and released would be highly valuable to the public record. It is important to keep in mind that the Department's obligation is to "conduct a search reasonably calculated to uncover all relevant documents." *Truitt v. Department of State*, 897 F.2d 540, 542 (D.C. Cir. 1990). This means that the search must be conducted in good faith using methods that are likely to produce the information requested. *See Campbell v. United States Dep't of Justice*, 164 F.3d 20, 27 (D.C. Cir. 1998). The Department "cannot limit its search to only one record system if there are others that are likely to turn up the information



requested." Department of Justice FOIA Guide (May 2004).² Rather, the obligation of the Department to search other sources likely to contain responsive records includes contacting former employees where necessary. See, e.g., Comer v. IRS, No. 97-76329, 2001 U.S. Dist. LEXIS 16996 (E.D. Mich. Sept. 25, 2001) (finding an agency search inadequate when the agency made no attempt to contact a former employee familiar with the information sought). Stated another way, an agency search meets the requirements of FOIA only where the agency "can demonstrate beyond material doubt that its search was 'reasonably calculated to uncover all relevant documents." Valencia-Lucena v. United States Coast Guard, 180 F.3d 321, 325-326 (D.C. Cir. 1999) (quoting Train, 897 F.2d at 542 (D.C. Cir. 1990) (emphasis added). The fact that a search may require extensive effort on the part of an agency is not, in and of itself, dispositive of undue burden. See, e.g. Pub. Citizen v. Dep't of Educ., 292 F. Supp. 2d 1, 7-8 (D.D.C. 2003) (rejecting adequacy of agency search of computerized database and instead ordering agency to manually review 25,000 paper files).

The fact that additional responsive records exist and were not located by the Department in its search demonstrates that the search was not adequate. Cf. Cooper v. DOJ, No. 2004 U.S. App. LEXIS 8135 (D.C. Cir. April 23, 2004) (relying on FOIA requester's affidavit demonstrating the existence of a type of record that was not produced by the search and finding the search, therefore, inadequate). See also Truitt, 897 F.2d at 543 (holding grant of summary judgment for agency inappropriate since requester's discovery in the National Archives of relevant records generated by agency, but never disclosed to him, cast doubt upon the adequacy of the agency's search). Where, as here, it is clear that the responsive records exist that were never located, courts usually require not only a detailed explanation of the search conducted but also a convincing explanation of why further searches would be unreasonably hurdensome. See, e.g., Weisherg v. Department of Justice, 627 F.2d 365, 370-71 (D.C. Cir. 1980).

In conclusion, as advised by the 9/11 Commission Report, our existing classification system "implicitly assumes that the risk of inadvertent disclosure outweighs the henefits of wider sharing. Those Cold War assumptions are no longer appropriate. The culture of agencies feeling they own the information they gathered at taxpayer expense must be replaced by a culture in which the agencies instead feel they have a duty to the information—to repay the taxpayers' investment by making that information available." In light of such advice, and the passage of time since the creation of these documents, I ask the Policy. Appeals and Litigation Branch to consider releasing additional portions of these documents initially withheld in full.



This is an administrative appeal under the Freedom of Information Act. Through a letter dated 24 August 2011, the Defense Department released excised versions of two reports that had been referred to your office by the State Department. I ask for further review of the withheld portions so that it may be determined whether additional information can be declassified.

One of the documents is a "Posture Statement" for FY 1981 by the Chairman of the Joint Chiefs of Staff. Excisions concern a number of issues, including strategic and theater nuclear forces, warhead numbers, conventional forces in the European theater, and the Chinese ballistic missile arsenal. The availability of previously declassified and public record documentation should enable the reviewers of this appeal to declassify significant and substantive information from the withheld portions of the "Posture Statement." With this I enclose excerpts from Secretary of Defense Brown's annual reports from 1979 and 1980 which include detailed discussion of Minuteman vulnerability and the role of the MX as a solution to that problem, the U.S.-Soviet strategic balance, and NATO-Warsaw Pact conventional and theater nuclear issues (see enclosures 1 and 2). Also relevant are previously declassified Department documents on Minuteman survivability and the U.S.'s "diminishing lead" in strategic warheads (see enclosures 3 and 4) as well as a White House document on Minuteman vulnerability (see enclosure 5). Moreover, the CIA has declassified reports on Soviet/Warsaw Pact theater nuclear forces (see enclosures 6 and 7) while DIA has declassified most of a report from 1977 on Chinese ballistic missiles (see enclosure 8) In light of these previous declassifications, it should be possible to declassify more information from the "Posture Statement" without harm to national security.

Also excised is a Defense Department "HLG Threat Assessment Paper" from 1981. The availability of previously declassified information on U.S. strategic and theater nuclear force cited above (in enclosures 1, 2, 5, and 6) should make it possible for the Defense Department to release more information from this document.


With respect to information withheld under the (b) (5) predecisional exemption, I question the legitimacy of withholding "deliberative process" information from documents that are now thirty years old or older. It is difficult believe that the declassification of the (b) (5) information would have a "chilling" impact on deliberative processes within the U.S. government, including the Pentagon's relationships with other agencies. Moreover, withholding the information on (b) (5) grounds is also inconsistent with President Obama's January 2009 directives which specified that

"[t]he Government should not keep information confidential merely because public officials might be embarrassed by disclosure, because errors and failures might be revealed, or because of speculative or abstract fears."

With respect to any names withheld on (b) (6) grounds, I question the decision to invoke personal privacy as a justification for exempting the name of a civilian or military official, living or dead, from government records that are 30 years old or older. This is a misuse of the privacy exemption because these individuals were working in their official capacity as public servants and privacy claims are irrelevant. There is no invasion of privacy as would be the case if an official's home address, or home phone, or social security number were cited.





This letter constitutes an appeal under the Freedom of Information Act (FOIA), 5 U.S.C. § 552, of a determination by the Department of Defense (DOD) on a Freedom of Information Act (FOIA) request filed on December 15, 2004. By letter of August 30, 2007, the Department of Defense withheld four requested documents in their entirety under exemption (b)(1) of the FOIA. (8/30/07 Letter Attached)

The following documents referenced in the 9/11Commission Report remain the subject of this appeal:

- DOD briefing materials, "Evolution of Infinite Resolve Planning (AQ, UBL)," undated (provided to the Commission on Mar. 19, 2004)
- 2. DOD notes, Victoria Clarke notes, Sept. 11, 2001
- 3. DOD memo, Office of the Under Secretary of Defense for Policy, "War on Terrorism: Strategic Concept," Sept. 14, 2001
- 4. DOD memo. Wolfowitz to Rumsfeld, "Preventing More Events," Sept. 17, 2001

According to the August 30, 2007 letter these four documents have been withheld because they 1.4(a) concern military plans weapons systems, or operations, (c) concern intelligence activities or (g) concern vulnerabilities or capabilities of systems, installations, infrastructures, projects, plans, or protection services relating to national security, which includes defense against transnational terrorism.

However, by the date, title and description of the documents as provided to the public in the 9/11 Commission Report, it remains highly doubtful that the release of these documents would pose a credible threat to current U.S. national security interests. Although al-Qaeda's terrorist networks are unfortunately very much still active, and the war on terrorism likewise remains an ongoing effort, it is evident that the structure of both al-Qaeda and the war on terrorism have undergone enormous changes since the creation of these documents in September 2001. It is inconceivable that the strategic concept for the war on terrorism drafted in September 2001 is the war on terrorism that is in current operation in September 2007.

The 9/11 Commission Report describes "DOD memo, Office of the Under Secretary of Defense for Policy, "War on Terrorism: Strategic Concept," in some detail. "...the strategic concept for the war on

terrorism specified three priority targets for initial action: al Qaeda, the Taliban, and Iraq. It urged that of the three, al-Qaeda and Iraq posed a strategic threat to the United States. Iraq's long-standing involvement in terrorism was cited, along with its interest in weapons of mass destruction." Six years later, the Taliban has been removed from power in Afghanistan, Saddam Hussein is dead, Iraq is largely under U.S. military control and al-Qaeda has been forced to massively change its strategy and behavior in response to U.S. and worldwide efforts to thwart its activities. To put it succinctly, we are long past whatever the September 14, 2001 document had planned for. Similarly, the requested document "Evolution of Infinite Resolve Planning (AQ, UBL)," is cited in the 9/11 Commission Report as advising significant use of ground troops in Afghanistan. Operation Enduring Freedom, which commenced almost six years ago, did just that as it put significant U.S. and allied ground troops in Afghanistan. "Evolution of Infinite Resolve Planning (AQ, UBL)," is hardly an operationally significant military plan as it has already been largely implemented and/or obviated by the drastically altered political and military situation in Afghanistan. Neither of these documents continue to be relevant to (a) military plans or operations, (c) intelligence activities or (g) system vulnerabilities.

Additionally, in the very highly unlikely event that there is any information contained in such documents that remains operationally relevant, the Department has a duty to excise that specific piece of information without blanketing the entire document in classification. Just because a document is noteworthy or interesting does not mean it is sensitive. Similarly, just because a document was once very sensitive does not mean that it is entitled to indefinite classification. Although six years may not seem like a lot of time, the world as it is relevant to these documents is a completely transformed place. The nature of America's enemy has changed and the U.S. military and political reaction to this threat has changed. The information contained in these documents is irrelevant for current U.S. national security operations.

I also ask that the Policy, Appeals and Litigation Branch reconsider the initial decision to withhold "DOD notes, Victoria Clarke notes, Sept. 11, 2001." This document is described by the 9/11 Commission Report as discussing the role of Saddam Hussein in 9/11 and considers possible strikes against Iraq in retaliation. The public already knows from the 9/11 Commission Report and from the release of Stephen Cambone's notes from September 11, that on September 11, the Secretary of Defense was considering retaliation against Iraq as well as Osama bin Laden in Afghanistan. The Department's August 30, 2007 decision to withhold Ms. Clarke's notes is excessive, as the information contained in the document is confirmed in the 9/11 Commission Report and in the released Cambone notes. Furthermore it is difficult to see how these notes relate to any of the criteria the August 30, 2007 letter provides as justification for withholding. These notes are not (a) military plans, unless the Department takes the untenable position that a note saying "Hit Saddam Hussein at the same time," counts as a war strategy for military operations in Iraq, nor do they (c) concern intelligence activities as these are policy notes, not intelligence information or (g) concern vulnerabilities or capabilities of systems, as we know from the 9/11 Commission Report that these notes concern taking action in retaliation for the attacks, not assessing system vulnerabilities.

Regarding the last document, "DOD memo, Wolfowitz to Rumsfeld, "Preventing More Events," Sept. 17, 2001," it is fairly difficult to believe that if released, the information contained in document would pose new risks to security that have not already been exploited and made obvious to the public, or obviated by subsequent overhauls to security systems and/or the destruction of threats. Additionally, as with the other three documents, the 9/11 Commission Report describes this document in substantive detail. "Deputy Secretary Wolfowitz continued to press the case for dealing with Iraq. Writing to Rumsfeld on September 17 in a memo headlined, "Preventing More Events," he argued that if there was even a 10 percent chance that Saddam Hussein was behind the 9/11 attack, maximum priority should be placed on eliminating that


threat. Wolfowitz contended that the odds were "far more" than 1 in 10, citing Saddam's praise for the attack, his long record of involvement in terrorism, and theories that Ramzi Yousef was an Iraqi agent and Iraq was behind the 1993 attack on the World Trade Center." ²

It is difficult to understand the Department's position that the release of these documents would pose a threat to U.S. national security when the specific substance of each of these documents has already been known by the public for over three years, as it was released by 9/11 Commission Report, an official government publication cleared for release by the U.S. Department of Defense. The public release of this information by the 9/11 Commission Report has not created any threat or resulting compromise of U.S. national security, as is claimed would be the result of such disclosure by the August 30, 2007 denial letter. Why can the 9/11 Commission Report, again an official government publication cleared for release by the DOD, provide the substance of the information contained in these documents, and indeed even quote document four, "DOD memo, Wolfowitz to Rumsfeld," yet the Department of Defense cannot undertake what is seemingly logical and release the same information, this time in the original documents that are quoted and summarized by the 9/11 Commission Report?

As I'm sure the Policy, Appeals and Litigation Branch appreciates, excessive secrecy only undermines the very security it is designed to protect because it obscures truly sensitive information with the mundane and weakens protection for all, in addition to creating a vast bureaucratic burden for the DOD. The vast amount of documentation that is already available, including official testimonies and declassified documents, suggests that it was overwhelmingly poor choices based on spotty information and a failure to communicate, rather than openness or declassification that compromised the national security of the United States on September 11. A lack of discussion, coordination, and disclosure, not the release of information, proved detrimental to our security. As I have stated previously, it is exceedingly difficult to see how the release of these documents – whose content has already been largely released by other official U.S. government publications – would pose a threat to the safety and security of the nation, or to the continued success of U.S. military or intelligence operations.

In conclusion, I respectfully ask for a further review of these documents, as I find it difficult to accept that all requested information, regardless of age or relevance, pose an ongoing threat to U.S. security. 



To whom it may concern:

I am writing to appeal the denial of my Freedom of Information Act request to U.S. Special Operations Command for a copy of the 15-6 investigation report into the alleged disclosure of classified material to me during my research for my book, "Not a Good Day to Die – The Untold Story of Operation Anaconda." This document was denied in total to me by USSOCOM, in a letter dated May 3, 2005, and signed by Colonel Mark J. Meyers, USSOCOM deputy chief of staff. My FOIA request was assigned USSOCOM FOIA control number 2005-007.

I am appealing this denial on the following grounds:

- Any information shared with me pertained to events that occurred no later than March 2002, over three years ago. This information is now dated and could be released with no significant risk.
- As the professed purpose of the investigation reveals, I am already in possession of the information that USSOCOM is allegedly concerned about. No possible extra breach of security could occur by releasing to me the report of an investigation into the alleged disclosure of information I am already in possession of.
- If for some reason the investigation report includes highly classified information, it should be possible to reduct that information and release the rest of the report to me.
- My FOIA request represents an attempt on my part to find out what a large and powerful arm of the federal government the Department of Defense said about me, a private citizen, in an investigation into events that I was allegedly at the center of. This is exactly the sort of situation that the Freedom of Information Act was designed to address. It reflects poorly on USSOCOM and the Defense Department if you cannot bring yourselves to allow a private citizen to see the results of an investigation concerning him that you have spent public funds to conduct.
