Dear Mr. Hogan:

This is an appeal under the Freedom of Information Act. Through a recent letter, your agency released an excised version of the RAND Corporation Memorandum (RM-4015-ISA): "The French Nuclear Weapons Program: A Reappraisal" by Arnold Karmish and James R. Schlesinger, August 1964. I ask for further review of this document to determine whether portions, or perhaps all, of the exempt information may be released without harm to national defense or foreign relations.

I also ask the Department to take into account previously declassified information concerning U.S. Intelligence assessments of the French nuclear weapons program in the late-1950s and 1960s which may be relevant to further review of this document. With this, I enclose a number of declassified documents from U.S. intelligence agencies that report on French nuclear weapons production, nuclear weapons delivery systems, etc. during the late 1950s and early 1960s (see enclosure 1, 2, 3, 4). As you will note, the reports include considerable declassified detail on the French nuclear weapons production program. The enclosed documents, or at least very similar documents, could have been referenced in the excised footnotes in the RAND memorandum. In light of the declassification of formerly sensitive Intelligence information on the French nuclear weapons program, the release of more details from this document can be released without harm to national security.

This responds to your Freedom of Information Act (FOIA) request dated May 30, 1995, Archive # 950784AIR011, to the United States Department of the Air Force (USAF), for the August 1964 RAND study entitled "The French Muclear Weapons Program: A Responsibility Use Icited dated January 25, 1999, the USAF referred your request and one responsive document to this Office for review and direct response to you. I apologize for the delay of this response, which was caused by the need to consult with other Department of Defense components and other federal agencies.

The enclosed 99-page document, reducted in part, is provided as responsive to your request. The United States Department of the Air Force, the Department of Energy (DOE), the Defense Threat Reduction Agency (DTRA), the Central Intelligence Agency (CIA), and the Office of International Security Policy have determined that the deleted information in the enclosed document is exempt from release because it is currently and properly classified in accordance with Executive Order 12958, as amended, pursuant to the following sections: Section 1.4 (c) concerning intelligence activities (including special activities), intelligence sources or methods, or cryptology; Section 1.4 (d) concerning foreign relations or foreign activities of the United States, including confidential sources; 1.4 (e) concerning scientific, technological, or economic matters relating to the national security, which includes defense against transnational terrorism; and Section 1.4 (h) concerning weapons of mass destruction. The denied information is also exempt from automatic declassification in accordance with Section 3.3 (1), which pertains to information that could reveal the identity of a confidential human source, or a human intelligence source, or reveal information about the application of an intelligence source or method; Section 3.3 (2), which pertains to information that would assist in the development or use of weapons of mass destruction; Section 3.3 (6), which pertains to information, including foreign government information, that would seriously and

demonstrably impair relations between the United States and a foreign government, or seriously and demonstrably undermine ongoing diplomatic activities of the United States; and Section 3.3 (9), which pertains to information that could violate a statute, treaty, or international agreement. It has also been determined that certain information is exempt from release pursuant to 5 U.S.C. § 552(b)(3), which pertains to information exempted from release by statute, in this instance, 42 U.S.C. § 2162(a), which provides for withholding Restricted Data under the Atomic Energy Act of 1954, and 50 U.S.C. § 403(g) Section 6 of the CIA Act of 1949, which provides for the withholding of CIA functions and information. Accordingly, this information is denied pursuant to 5 U.S.C. §§ 552 (b)(1) and (b)(3). Additional information provided by the Department of Energy regarding their withholdings has also been included at their request (see document labeled "Enclosure 2").

If you are not satisfied with this action, you may submit an administrative appeal to James Hogan, Chief, Policy, Appeals and Litigation Branch at the above address. Your appeal should be postmarked within sixty days of date of this letter, should cite to case number 99-F-0680, and should be clearly marked "Freedom of Information Act Appeal."

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. Section 552, et seq. This letter constitutes an appeal under 5 U.S.C. § 552(a)(6) of the Freedom of Information Act ("FOIA") of United States Central Command's ("CENTCOM") no record response to the FOIA request of Mr. Zakirjan Hassam ("Mr. Hassam") and Cleary Gottlieb Steen & Hamilton LLP ("Cleary Gottlieb").

L Background

By letter dated April 27, 2006, Mr. Hassam, who is presently detained at the U.S. Naval Base at Guantánamo Bay, Cuba ("Guantánamo"), and Cleary Gottlieb requested certain information from CENTCOM pursuant to FOIA (the "FOIA Request") (Attachment A).² The FOIA Request sought expedited processing due to "imminent loss of substantial due process rights and humanitarian need," see 32 C.F.R. § 286.4(d)(3)(iv), and requested production of six categories of documents:

1. All records concerning the circumstances under which Mr. Hassam first came to be in the custody of U.S. forces or their agents;

The United States military has assigned the identification number "ISN 672" to Mr. Hassam.

The FOLA Request was also sent to United States Southern Command and the Department of I

The FOIA Request was also sent to United States Southern Command and the Department of Defense Office of Freedom of Information and Security Review.

- All records concerning the decision by U.S. forces or their agents to transfer Mr. Hassam from Afghanistan to the U.S. Naval Base at Guantánamo Bay, Cube;
- 3. All records concerning Mr. Hassam's detention and interrogation by U.S. forces end/or their agents at (1) the U.S. Naval Base at Guantánamo Bay, Cuba, (2) Bagram Airfield, Afghanistan, (3) Kandahar Airfield, Afghanistan, and/or (4) any other facilities or locations in which Mr. Hassam has been detained, imprisoned or confined while in custody of U.S. forces or their agents;
- All records concerning Mr. Hassam's Combatant Status Review Tribunal ("CSRT") process, including, without limitation, any records reviewed in connection with, or referenced in, any CSRT proceedings concerning Mr. Hassam;
- 5. All records concerning Mr. Hassam's entire medical history, including, without limitation, any treatments, surgeries, exam results, diagnoses and drug information, during his detention at (1) the U.S. Naval Base at Guantánamo Bay, Cuba, (2) Bagram Airfield, Afghanistan, (3) Kandahar Airfield, Afghanistan, and/or (4) any other facilities or locations in which Mr. Hassam has been detained, imprisoned or confined while in custody of U.S. forces or their agents; and
- 6. All documents concerning Mr. Hassam not otherwise responsive to the above-enumerated requests.

CENTCOM received the FOIA Request on April 28, 2006. See Attachment B. By letter dated May 5, 2006, CENTCOM confirmed receipt of the FOIA Request and granted expedited processing. See Attachment C.

On May 11, 2006, Cleary Gottlieb sent correspondence to CENTCOM relating its understanding that CENTCOM's grant of expedited processing applied to all six categories of information identified in the FOIA Request, even though CENTCOM's May 5 letter referenced only one of the six categories. See Attachment D. By voicemail of May 12, 2006, CENTCOM stated that it had granted expedited processing with respect to records in possession of CENTCOM but was not in a position to produce responsive information maintained by United Stated Southern Command. See Attachment E. By letter dated May 19, 2006, Cleary Gottlieb reiterated its understanding that CENTCOM's grant of expedited processing applied to all six categories of documents identified in the FOIA Request. See Attachment E.

CENTCOM informed Cleary Gottlieb by voicemail on May 22, 2006, that upon further review of the FOIA Request it had concluded that it did not have the authority to grant expedited processing because the information requested fell under the purview of United States Army Forces Central Command ("ARCENT"). See Attachment F. CENTCOM further stated

that it would forward the FOIA Request to ARCENT, which would in turn respond to the FOIA Request. Id.

By letter dated June 26, 2006, CENTCOM stated it had conducted a search that encompassed "only those documents in existence within the control of []CENTCOM and its subordinate commands." See Attachment G. CENTCOM asserted that "despite [its] extensive and exhaustive search, [it was] unable to locate responsive documents." Id. Finally, CENTCOM provided that an appeal of this finding could be made within 60 calendar days if the "no record response" was decorded to be a decidal. Id.

No communications or correspondence has ever been received from ARCENT. It is not clear from the June 26 letter whether the FOIA Request was ultimately granted expedited processing or whether ARCENT was involved in the search in any capacity.

II. Basis For Appeal

Department of Defense regulations provide for appeals: (i) from "no record determinations when the requester considers such responses adverse in nature"; (ii) for "review on an expedited basis a determination not to grant expedited access to agency records," and (iii) for "any determination found to be adverse in nature by the requester." 32 C.F.R. § 286.24(a) (emphasis in original).

Mr. Hassam and Cleary Gottlieb consider CENTCOM's "no record" response to be adverse in nature and challenge the adequacy of the search conducted by CENTCOM and its subordinate commands in response to the FOIA request. Mr. Hassam and Cleary Gottlieb also challenge CENTCOM's denial, and ARCENT's constructive denial, of expedited processing for the FOIA request.

A. Mr. Hassam And Cleary Gottlieb Have Demonstrated A Compelling Need For The Requested Records And For Expedited Processing Of The FOIA Request

As stated in the FOIA Request and accompanying Declaration of Christopher Moore in Support of Request for Expedited Processing, on information and belief, Mr. Hassam has suffered and will continue to suffer loss of substantial due process rights, and the requested documents are necessary to belp alleviate ongoing humanitarian violations. See Attachment A; 32 C.F.R. § 286.4(d)(3)(iv) (providing that FOIA requests demonstrating "imminent loss of substantial due process rights and humanitarian need" merit expedited processing).

The U.S. government determined over one year ago that Mr. Hassam is <u>not</u> an enemy combatant, yet he nevertheless remains imprisoned at Guantanamo. Mr. Hassam has now been detained and interrogated by the U.S. military for more than four years with extremely limited access to counsel and without any legitimate legal process. <u>See</u> Attachment A.

Mr. Hassam was seized by U.S. forces in Northern Afghanistan in 2002 and subsequently detained at both Bagram Airfield, Afghanistan, and Kandahar Airfield, Afghanistan prior to being transferred to Guantánamo. On information and belief, Mr. Hassam was physically and/or mentally abused by U.S. forces and/or their agents while detained at Bagram Airfield, Kandahar Airfield and Guantánamo. On information and belief, Mr. Hassam has been the subject of extensive medical interventions (mostly involuntary), while in the custody of U.S. forces, including at least one surgery and the administration of various medications, Id.

Information relating to Mr. Hassam's capture, conditions of detention and medical treatment are necessary to assist with ongoing efforts to secure Mr. Hassam's release from Guantánamo and locate a suitable country for resettlement.

Mr. Hassam and Cleary Gottlieb have clearly satisfied the "imminent loss of substantial due process rights and humanitarian need" standard set forth in 32 C.F.R. § 186.4(d)(3)(iv). The FOIA Request is therefore entitled to expedited processing.

B. Based On Its Area Of Responsibility, CENTCOM Holds Records Relating To Mr. Hassam's Capture, Conditions of Detention and Medical Treatment In Afghanistan

Afghanistan falls explicitly with CENTCOM's Area of Responsibility. See http://www.centcom.mil/sites/uscentcom1/Shared%20Documents/CENTCOM%20FAQ.htm (last checked August 24, 2006). CENTCOM has been in command of U.S. and Coalition forces operating in Afghanistan as part of Operation Enduring Freedom since October 2001. Hearing Before the S. Armed Servs. Comm., 107th Cong. 1-3 (February 7, 2002) (statement of Gen. Tommy R. Franks, Commander, U.S. Cent. Command). As of July 31, 2002, U.S. and Coalition forces screened more than 7,500 detainees in Afghanistan and conducted more than 3,500 interrogations on 2,200 individuals, leading to the detention of more than 500 individuals at Guantánamo. Hearing Before the Senate Armed Services Committee to receive testimony on Operation Enduring Freedom, 107th Cong. 9 (July 31, 2002) (statement of Gen. Tommy R. Franks, Commander, U.S. Cent. Command). In addition, according to Gen. Tommy R. Franks, CENTCOM has screened more than 16,000 documents and added 12,000 documents to a database concerning those individuals. Id.

In approximately June 2002, the XVIII Airborne Corps was designated as Combined Joint Task Force-180 and assumed command responsibility for military functions in Afghanistan. Id. at 6. Combined Joint Task Force-180 was a subordinate command of CENTCOM. U.S. Cent. Command News Release, Combined Joint Task Force Headquarters (May 14, 2002) (available at http://www.centcom.mil/sites/uscentcom1/Lists/Press%20Releases/DispForm.aspx?ID=31) (last checked August 24, 2006).

United States and coalition forces currently deployed in Afghanistan as part of Operation Enduring Freedom are commanded by Combined Forces Command-Afghanistan, a

subcomponent command of CENTCOM. Hearing Before the S. Armed Servs. Comm. to receive testimony from combatant commanders on their military strategy and operational requirements in review of the Defense Authorization Request for Fiscal Year 2007 and the Fuhire Years Defense Program. 109th Cong. 1, 22-23 (March 16, 2006) (statement of Gen. John P. Abizaid, U.S. Army Commander, U.S. Cent. Command). Combat operations throughout Afghanistan are now directed by Combined Joint Task Force-76, a division-level subordinate command of CENTCOM. Id. at 23.

CENTCOM and/or one of its subordinate commands thus necessarily possesses records relating to Mr. Hassam's capture, detention and medical treatment at Bagram Airfield and Kandahar Airfield, and possibly other locations in Afghanistan. Records relating to Mr. Hassam's transfer from Afghanistan to Guantánamo may also be in the possession of CENTCOM or one of its subordinate commands.

C. CENTCOM's Explanation Of The Search Conducted In Response To The FOLA Request Is Inadequate

CENTCOM's June 26 letter states that its search for records responsive to the FOIA Request encompassed an "extensive and exhaustive search" of documents within the control of CENTCOM and its subordinate commands. This response is inadequate.

The established standard for the adequacy of an agency's search efforts in response to a FOIA request is "reasonableness." Krikorian v. Dep't of State, 984 F.2d 461, 468 (D.C. Cir. 1993); see also Truitt v. Dep't of State, 897 F.2d 540, 542 (D.C. Cir. 1990) ("adequacy of an agency's search is measured by a 'standard of reasonableness,' and is 'dependent upon the circumstances of the case") (citations omitted). "It is elementary that an agency responding to a FOIA request must 'conduct[] a search reasonably calculated to uncover all relevant documents,' and, if challenged, must demonstrate 'beyond material doubt' that the search was reasonable." Truitt at 542 (citations omitted).

CENTCOM has provided no information supporting its conclusory statement that it conducted an adequate search. Rather, it merely states that CENTCOM and its subordinate commands conducted an "extensive and exhaustive search," without describing any details concerning that search or identifying any of the subordinate commands that purportedly participated in that search. See Attachment G. In order to demonstrate whether the search conducted by CENTCOM was adequate, CENTCOM was required, at a minimum, to identify: (i) any and all subordinate commands that purportedly conducted searches in response to the FOIA Request; (ii) any and all files that were searched in response to the FOIA Request; (iii) the persons who conducted any such searches; and (iv) the procedures employed during any such searches. See Weisberg v. Dep't of Justice, 627 F.2d 365, 371 (D.C. Cir. 1980). It failed to do so. See id. (descriptions of search should provide information specific enough to enable a challenge, if necessary, to the procedures utilized).

III. Request For Relief

For the foregoing reasons, we respectfully appeal CENTCOM's "no record" response, and request that CENTCOM be required to 1) conduct an adequate search for the records requested in the FOIA Request and 2) identify the procedures utilized in conducting that search, including but not limited to the subordinate commands and/or individuals involved in such search and the files and/or data bases that were searched.

In addition, for the foregoing reasons, we respectfully appeal CENTCOM's denial, and ARCENT's constructive denial, of expedited processing of the FOIA Request.

I. Records Sought

Recently released documents indicate that Mr. Hassam is identified by the Department of Defense as "Zakirjan Asam." See List of detainees who went through complete CSRT process, released April 19, 2006 (available at http://www.defenselink.mil/puba/foi/detainees/detainee_list.pdf). Cleary Gottlieb therefore requests the following six categories of documents concerning, relating or pertaining to "Zakirjan Hassam," "Zakirjan Asam," "ISN 672," or any other identifier by which Mr. Hassam has been designated by the Department of Defense or any other agency:

- All records¹ concerning² the circumstances under which Mr. Hassam first came to be in the custody of U.S. forces or their agents. On information and belief, Mr. Hassam was sold to U.S. forces in Afghanistan for \$5,000.00 in or about Spring 2002.
- All records concerning the decision by U.S. forces or their agents to transfer Mr.
 Hassam from Afghanistan to the U.S. Naval Base at Guantánamo Bay, Cuba.
- 3. All records concerning Mr. Hassam's detention and interrogation by U.S. forces and/or their agents at (1) the U.S. Naval Base at Guantánamo Bay, Cuba, (2) Bagram Airfield, Afghanistan, (3) Kandahar Airfield, Afghanistan, and/or (4) any other facilities or locations in which Mr. Hassam has been detained, imprisoned or confined while in custody of U.S. forces or their agents.
- 4. All records concerning Mr. Hassam's Combatant Status Review Tribunal ("CSRT") process, including, without limitation, any records reviewed in connection with, or referenced in, any CSRT proceedings concerning Mr. Hassam. The government does not dispute that the Office for the Administrative Review of the Detention of Enemy Combatants (OARDEC) maintains separate files for each CSRT at its headquarters in Arlington, Virginia. See Declaration of Teresa A. McPalmer dated June 25, 2005, ¶ 3, Associated Press v. United States Department of Defense, No. 05 Civ. 3941 (JSR) (S.D.N.Y.) (docket no. 11).
- 5. 1)This website lists the names of numerous DOD databases:

http://www.defenselink.mil/privacy/notices/

The response, however, stated that giving out the name of any DOD databases would somehow allow a computer expert access.

I've attached a list of just some of the databases identified on this site.

Dozens more can be found in the Federal Register.

2)Identifying the names of databases does not grant access. Government databases are protected with layers and layers of safeguards, including firewalls, passwords and other security measures.

If a computer expert could get access with just a name, why then did the U.S. Army Audit Agency disclose (in the document I attached to my FOIA and to this appeal) the name of a database that identifies other databases? Why then doesn't DOD make a policy that the names of all databases are never to be made public? Why then does DOD continue to identify the names of databases?

I respectively ask that you consider that this request and appeal are made by a journalist for a newspaper in this country and that the information I seek is sought under a law intended by Congress to keep our citizens informed about the activities of government — a law our government and many other feels is vital to a free national. I also respectively ask that you consider that this response is not in keeping with the spirit or the letter of that law or with your own policies.

In any case, I expect to receive your decision no later than by 20 business days, as the statute requires.





Dear Mr. Hogan:

This letter constitutes an administrative appeal in accordance with the Freedom of Information Act (FOIA), 5 U.S.C. Sec. 552. of a Department of Defense response to an undated request in 2005, My associate, Mary Lilley, filed a request for records pertaining in whole or in part to the arrest of Ricardo Palmera Pineda, also known as Simon Trinidad, who was senior leader of the Revolutionary Armed Forces of Colombia.

In a letter dated December 24, 2008 (Attachment 1), the Department of Defense informed Ms. Lilley that her request resulted in the retrieval of one document, which according to the office of the Assistant Secretary of Defense for Western Hemisphere Affairs, is exempt from release "because it contains information which is currently and properly classified in accordance with Executive Order 12958, as amended, Section 1.4(d), which concerns foreign relations or foreign activities of the United States."

While I am aware of the importance of the classification procedures pursuant to Executive Order 12958, I request that the Department of Defense exercise its discretion to ensure maximum declassification of information on Ricardo Palmera's arrest by conducting a detailed line-by-line review of the withheld document.

I would point out that his arrest was widely covered by news media throughout the world due to his infamous reputation as a FARC senior leader and the efforts of the U.S. base in Manta, Ecuador and Ecuadorian personnel in the arrest (Attachment 2).

Additionally, I ask that you please consider the renewed commitment to transparency by President Barack Obama, who, on his first full day in office, pledged to create "an unprecedented level of openness in Government." President Obama has also stated his clear preference that in making declassification decisions, agencies should favor openness: "All agencies should adopt a presumption in favor of disclosure, in order to renew their commitment to the principles embodied in FOIA, and to usher in a new era of open Government."

In making your declassification decision, I also ask that you please consider the value of this material both to historians and to ongoing peace and reconciliation efforts in Colombia. The release of any material related to "Simon Trinidad" would be of great benefit to the Colombian government's National Commission on Reparation and Reconciliation (CNRR), created under the Justice and Peace Law of 2005 to administer and An Independent non-governmental research institute and library located at the George Washington University, the Archive collects and publishes declessified documents obtained through the Freedom of information Act. A tax-exempt public charity, the Archive receives no U.S. government funding; its budget is supported by publication royalties and donations from foundations and individuals. adjudicate the disarmament and demobilization of thousands of illegal armed actors and to oversee their reintegration into Colombian society. As important, the Commission has also been charged with ensuring that victims of violence receive just reparations from those responsible for these crimes, and with the preservation of the right of the victims and of society to an accurate reconstruction of the truth.

In particular, release of this material would assist the Commission in the production of its report on the "emergence and evolution of the illegal armed groups" in Colombia, including the United Self-Defense Forces of Colombia (AUC), the Revolutionary Armed Forces of Colombia (FARC), the National Liberation Army (ELN), narcotrafficking organizations and other groups. The report will cover some of the most egregious acts of violence committed by these groups and, in some cases, agents of the Colombian state.



Dear Mr. Hogan:

This letter is an administrative appeal under the Freedom of Information Act, regarding a FOIA request submitted on June 20, 2006 for records concerned with a late November 2001 meeting between Secretary Rumsfeld and Gen. Tommy Franks at CentCom headquarters, including the secretary's talking points for the meeting. In a letter dated November 20, 2006, Will Kammer informed me that DOD had located a responsive record and was withholding it in its entirety under exemptions (b)(1) and (b)(5).

With regard to material withheld under exemption (b)(1), I argue that withheld text can and should be released for two reasons. First, the U.S. public needs this information in order to understand and assess the operations of the U.S. government. Second, considerable information on related issues is already in the public domain. Regarding point one, the news media, congress, and the public at large are currently and will continue for some time to closely scrutinize the government's decision to initiate war with Iraq, and the assumptions that underlay war planning. In order to do so, they need information about high-level decision-making, including the crucial interaction between the secretary of defense and his chief commander. Regarding point two, the very high level of interest in these matters has led to the publication of a considerable number of books and articles discussing the government's planning for war, including precise details about how plans were promulgated and revised from late 2001 through March 2003. Disclosure of the document that has been withheld by the Defense Department would contribute to the quality of this debate by providing the public with accurate information about these issues.

In regard to information withheld under exemption (b)(5), I ask that you review the withheld material again, noting that documents withheld under this exemption can be released at your discretion. There has been considerable public criticism about the department's war planning process, focusing on such questions as whether the views of those with combat and regional experience were granted due consideration. Maximum transparency about this process will serve the interests of the American people by ensuring that any errors in judgment are not repeated in the future.

We contend that over-application of the (b)(5) exemption prevents the public from obtaining access to information on the actions and deliberations of the government, and is therefore counter to the intent of the Freedom of Information Act. At minimum, please release all factual portions of responsive documents. Factual and post-decisional information, unless inextricably intertwined with other text, is not protected under (b)(5) and must be released. Since the Rumsfeld/Franks meeting led to the latter's revamping of war plans so as to prepare for varpious contingencies, such as the initiation of conflict with reduced force levels, it seems probable that the document contains at least some factual and post-decisional information that is not subject to this exemption.

Mr. Kammer's letter indicated that the department was unable to locate the secretary's talking points among the records of the Joint Staff or NESAA, but would search further if provided with additional information regarding date, title, author, recipient, subject matter, and description. According to secondary sources, the talking points, which were drafted around the late November 2001 date of the Rumsfeld/Franks meeting, were prepared by Donald Rumsfeld, Paul Wolfowitz, and Douglas Feith, and their subject matter included the viability of Saddam Hussein's regime, its vulnerabilities, the likelihood of its overthrow, contingencies for attacking Iraq with limited forces, and anti-regime operations by special forces and Kurdish insurgents. The document therefore might well be found among records or retired records of the secretary, the deputy secretary, or the office of the under secretary for policy.



Dear Mr. Hogan:

This letter is an administrative appeal regarding a Freedom of Information Act (FOIA) request submitted on July 27, 2006. The request was for the October 27, 2003 memorandum sent by Douglas J. Feith, Undersecretary of Defense for Policy, to senators Pat Roberts and Jay Rockefeller. In his July 25, 2007 letter, Will Kammer stated that the Department located two responsive documents and was withholding them in their entirety under exemptions (b)(1) and (b)(5).

I contend that information within these documents is unlikely to harm national security interests or the foreign policy of the United States because it concerns intelligence on the former Saddam Hussein regime no longer in power. Moreover, the public interest regarding this documents exists within the commentary and analysis provided by the documents more so than in its specific sources.

Further, large excerpts from these documents have already been made public through a November 24, 2003 article in the enclosed Weekly Standard article. This same article was publicly commented on by Vice President Richard Cheney in a January 9, 2004 interview with the Rocky Mountain News in which he commented on the topic of al-Qacda's relationship with the Hussein government by stating:

"One place you ought to go look is an article that Stephen Hayes aid in the Weekly Standard here a few weeks ago, that goes through and lays out in some detail, based on an assessment that was done by the Department of Defense and forwarded to the Senate Intelligence Committee some weeks ago. That's your best source of information."

Again, in a January 11, 2006 interview. Vice President Cheney publicly confirmed the validity of the

of the federal government have recognized the public's interest in this document and its usefulness in informing the public concerning terrorist activities.

In regard to material withheld under (b)(5), I contend that this exemption prevents the public from obtaining access to documentation regarding the actions and deliberations of the government and is therefore counter to the intent of the Freedom of Information Act. As we understand the application of exemption (b)(5), information is exempt only if it is both "predecisional" and "deliberative." Petroleum Info. Corp. v. Dep't of the Interior, 976 F.2d 1429, 1434 (D.C. Cir. 1992). "A document is predecisional if it was 'prepared in order to assist an agency decision maker in arriving at his decision,' rather than to support a decision already made." Id. In order to withhold materials as predecisional deliberative process materials under the (b)(5) exemption, the agency must be able to identify a specific agency decision, and the role those documents played in coming to that final decision. See Paisley v. CIA, 712 F.2d 686, 698 (D.C. Cir 1983) and 724 F.2d 201 (D.C. Cir 1984). The court held, "to approve exemption of a document as predecisional, a court must be able "to plapoint an agency decision or policy to which the document contributed."

In addition, material is deliberative only if it "reflects the give-and-take of the consultative process." Petroleum Life, Corp., 976 F.2d at 1434 (citations omitted). "The privilege is designed to protect agency policy-oriented indepents and the processes by which policies are formulated, rather than 'purely factual, investigative markets." Factual, post-decisional information, unless inextricably intertwined with other information, is not protected under the fifth exemption and must be released. National Ass'n of Home Builders v. Norton, 309 F.3d 26, 39 (D.C. Cir. 2002) (citing Environmental Protection Agency v. Mink, 410 U.S. 73, 89 (1973)) (additional citations omitted). In fact, the D.C. Circuit has drawn an explicit discharge in 'between factual information, which 'generally must be disclosed,' and 'materials embodying officials' opinions,' which are 'ordinarily exempt." National Ass'n of Home Builders, 309 F.3d at 39; see Charles v. Dep't of Navy, 893 F.2d 390, 392 (D.C. Cir. 1990).

I ask that you, at a minimum, review these documents again and release all reasonably segregable information from these documents.



This is in response to your July 27, 2006 Freedom of Information Act (FOIA) request seeking "The October 27, 2003 memorandum sent by Douglas J. Feith, Undersecretary of Defense for Policy, to senators Pat Roberts and Jay Rockefeller in response to a request by the US Senate Intelligence Committee in preparation of the committee's in report on prewar intelligence assessments in Iraq." We received your request on the same day.

Mr. Michael H. Mobbs, the Staff Director and Special Advisor to the Under Secretary of Defense Policy, an Initial Denial Authority determined that the two responsive documents, one totaling eight pages and one totaling five pages exempt from release in their entirety because they are currently and properly classified in accordance with Executive Order 12958, as amended. Specifically, Section 1.4 (b) concerning foreign government information, and Section 1.4 (d) concerning foreign relations or foreign activities of the United States, including confidential sources. This information is also exempt from release pursuant to 5 U.S.C. § 552(b)(5), which pertains to certain interor intra-agency communications protected by the deliberative process privilege.

Accordingly, this information is denied pursuant to 5 USC § 552 (b)(1) and (b)(5).

This letter constitutes an administrative appeal under the Freedom of Information Act, 5 U.S.C. Sec. 552a. It is in response to a determination by the Department of Defense on a Freedom of Information Act (FOIA) request originally filed on August 8, 2006. By letter dated July 18, 2008, the Department of Defense withheld two documents under exemptions (b)(1.4(b), 1.4(c), 1.4(d)), (b)(3), (b)(5), (b)(6) of the FOIA.

My initial request asked for documents related to the following five meetings:

- NSC Deputies Meeting on or around April 19, 2001
- NSC Deputies Meeting on or around April 30, 2001
- NSC Deputies Meeting on or around June 29, 2001
- Counterterrorism Security Group (CSG) Meeting on or around June 22, 2001
- NSC Principals Meeting on or around September 4, 2001

These National Security Council and Counterterrorism Security Group meetings each specifically relate to terrorism, U.S. counterterrorism policy, and events relevant to September 11, 2001 as they are each specifically referenced in the official report released by the 9/11 Commission. [See Deputies Meetings April 19, 2001 and April 30, 2001 on page 510 of the 9/11 Commission Report, NSC Principals Meeting on Sept. 4 2001 on page 212 and CSG Meeting on June 22, 2001 on page 534 of the 9/11 Commission Report.]

I ask the Appeals and Litigation Branch at the Department of Defense to reconsider this initial determination. Although I understand the sensitivity of these requested documents, the overwhelming public interest in these materials and the fact that the fundamental discussion in many of these documents has already been released to the public through the 9/11 Commission Report provide strong justification for further review and release.

These documents tell the story of how the U.S. government interpreted and responded to the growing threat of Islamist terrorists and are of outstanding interest to the public. Furthermore, I would argue that the use of the (b)(1) exemption to withhold documents such as these that would elucidate the actions or inactions of the U.S. government leading up to 9/11 is inappropriate considering it is the duty of the U.S. government to be transparent regarding such a matter of public safety. Classification must not be used as a barrier to public access to primary government materials that would serve to empower the public debate and heighten government accountability on these issues.

Additionally, all of these documents predate 9/11. I ask the Appeals and Litigation Branch to take into consideration the extraordinary changes in geopolitical circumstances surrounding issues related to terrorism

and al-Qaeda that have taken place since the creation of these documents and the policy decisions they describe. The continued, present-day national security sensitivity of policy documents from early 2001 regarding al-Qaeda is questionable since U.S. counterterrorism policy related to al-Qaeda and al-Qaeda itself has been completely altered since these documents were created. I ask that the Appeals and Litigation Branch keep in mind the public benefit in their release and the diminutive risk to actual national security the release of these documents would pose.

The U.S. government has consistently recognized the extraordinary public right to documents on its actions relating to 9/11 and has rightfully made exceptional public releases of pertinent previously classified documents in an effort to be accountable to the public. Documents that have almost without exception been consistently withheld under the (b)(1) exemption of the FOIA have been cleared for release in light of the distinctive public right to documentation on government action related to 9/11. For examples of this dedication to public access regarding 9/11 see the April 10, 2004 release of the August 6, 2001 Presidential Daily Brief by the Central Intelligence Agency and multiple other releases by intelligence agencies found in the 9/11 Commission Report.

With respect to the material withheld on the basis of (b)(5), I ask that documents be re-assessed balancing the two competing interests in determining whether or not to release these documents - the benefit of release to public debate vs. the interference release may cause to the government's deliberative process. In the case of these specific documents it is clear that significantly more harm is done in continued withholding than any injury to policy deliberation that may result from release. Regarding such a matter of overwhelming importance to the general public and public safety, the government does not have a right to shield its policy decisions as deliberative material, as the public has the right to know what immediate action the National Security Council, the Secretary of Defense and the Department of Defense undertook in order to protect the American public. Certainly the Department of Defense feels a sense of duty to be responsive to the public's need for information regarding an issue such as 9/11. Do not withhold information under the (b)(5) exemption because the type of document requested indicates it can be withheld under the (b)(5) exemption. As Mr. Hogan's office is aware, the (b)(5) exemption is discretionary, and the public trusts the government will use it sparingly and only in cases where specific harm to a deliberative process can be identified, where the public's interest in these activities is outweighed by the need to protect the process and finally, where there is actual harm in release.

The Department of Defense has previously released material that clarify the 9/11 policy debate and discussion regarding responding to the attacks. Please see Stephen Cambone's notes from the afternoon of 9/11 that were released to outragedmoderates.org (available at http://www.outragedmoderates.org/2006/02/dod-staffers-notes-from-911-obtained.html) I ask that materials related to these NSC and CSG meetings also be released in order to clarify policy.

Additionally I ask the Appeals and Litigation Branch to consider that an explicit intent of the Freedom of Information Act is to provide public access to materials that document the actions of government officials. As this FOIA request concerns a topic of overwhelming public interest and concern, I ask that you consider the example that may be afforded by the maximum release of this information, as it readily affects public safety. It is important to keep in mind that over application of the (b)(5) exemption prevents the public from accessing documentation regarding the actions and deliberations of their government and is counter to the intent of the Freedom of Information Act. At a minimum, please review these records in the appeal process to release factual portions found responsive to the request. Factual, post-decisional information, unless inextricably intertwined with other information, is not protected under the fifth exemption and must be released. Please see the Supreme Court's ruling in EPA v. Mink, 410 U.S. 73. Further, the FOIA requires release of "any reasonably segregable portion of the record" "after deletion of the portions which are exempt." See 5 U.S.C Sec. 552 (b). It seems certain that there is releasable material in at least some portion of the 64 pages of records denied in their entirety.

With respect to the material withheld on the basis of (b)(6), I ask that, at a minimum, you review these records in the appeal process to release the segregable portions that would not be considered an unwarranted invasion of privacy. The FOIA requires release of "any reasonably segregable portion of the record" "after deletion of the portions which are exempt." See 5 U.S.C Sec. 552 (b). In this case, since the documents sought pertain directly background materials on the events of September 11, 2001, exemption b(6) only applies when disclosure would result in a "clearly unwarranted" invasion of privacy that would outweigh the public interest. It remains difficult to conceive of a subject of greater public interest than September 11, 2001. See also Department of State vs. Ray, 502 U.S. 164 (1991) which clarified that disclosure of personal information without identifying details "constitutes only a de minimis invasion of privacy." Such a limited privacy invasion, if one even remains after minimal identifying redactions, carries little weight when balanced against the public interest in disclosure that is recognized by exemption b(6).

Lastly, in regards to the material withheld under Exemption (b)(3), in this instance, 50 U.S.C. 403 (g) Section 6 of the CIA Act of 1949 which provides for the withholding of CIA functions and information, I request that the Appeals and Litigation Branch consider that the CIA Act of 1949 does not allow for the wholesale classification of the role of the CIA in U.S. foreign policy. Only very specific operational duties are exempt from disclosure as such exposure would harm the functioning of the Agency and perhaps even jeopardize CIA officials. The withholding of such detailed information is understandable and commendable. However, it is doubtful that in general NSC and CSG policy documents that such a level of operational detail would be documented. General information regarding the role of the CIA in pre-9/11 counterterrorism policy designed to combat the threat of al-Qaeda is not operational information, it is policy information, and therefore not subject to withholding under the CIA Act of 1949 and therefore the (b)(3) exemption of the FOIA.

In conclusion, it seems unlikely that the release of this information would engender any threat to the national security of the United States or the conduct of its counterterrorism missions that would outweigh the obvious public benefit of its release. Actions taken by the government to answer to the events of 9/11 have largely concluded and are at this point more historical than operational or deliberative policies. Maximum disclosure of information would greatly serve the public interest by increasing public understanding of these critical policy decisions on public safety.

The request was for all records of correspondences between Scoretary of State Colin L. Powell and Coalition Provisional Authority Administrator L. Paul Bremer from May 1, 2003 through December 31, 2003 concerning Iraq. In a letter dated January 11, 2007 from Will Kammer, the Department stated that the Defense Reconstruction Support Office (DRSO) located six responsive documents. Five of those documents were released with excisions and one was withheld. The letter stated that material was withheld under exemptions (b)(5) and (b)(6) although the individual exemptions are not displayed on any of the documents. This appeal pertains to material which we believe to exist, but was not located, and material withheld under (b)(5).

Paul Bremer states in his book, My Year in Iraq, that he had exchanged e-mail with Secretary of State Colin Powell during this period, particularly August 2003. This reference is provided in an attachment to our initial request. As a former high ranking civilian official of the Department of Defense stationed in Iraq, we believe that the information he provides in his book is accurate and that it is reasonable to believe that a search of the Department's records should have resulted in the retrieval of e-mails during this period. The correspondence we received, however, contains only official memoranda and none are during the month of August 2003. For these reasons, we ask that you search your records again for all types of responsive records and documents.

The material excised under (b)(5) in these documents consists of unusually large portions, often the majority and even the entirety of paragraphs. As we understand the application of exemption (b)(5), information is exempt only if it is both "predecisional" and "deliberative." Petroleum Info. Corp. v. Dep't of the Interior, 976 F.2d 1429, 1434 (D.C. Cir. 1992). "A document is predecisional if it was 'prepared in order to assist an agency decision maker in arriving at his decision,' rather than to support a decision already made." Id. In order to withhold materials as predecisional deliberative process materials under the (b)(5) exemption, the agency must be able to identify a specific agency decision, and the role those documents played in coming to that final decision. See Paisley v. CIA, 712 F.2d 686, 698 (D.C. Cir 1983)


In addition, material is deliberative only if it "reflects the give-and-take of the consultative process."

Petroleum Info. Corp.. 976 F.2d at 1434 (citations omitted). "The privilege is designed to protect agency policy-oriented judgments and the processes by which policies are formulated, rather than 'purely factual, investigative matters." National Ass'n of Home Builders v. Norton, 309 F.3d 26, 39 (D.C. Cir. 2002) (citing Environmental Protection Agency v. Mink, 410 U.S. 73, 89 (1973)) (additional citations omitted). In fact, the D.C. Circuit has drawn an explicit distinction "between factual information, which 'generally must be disclosed,' and 'materials embodying officials' opinions,' which are 'ordinarily exempt."

National Ass'n of Home Builders, 309 F.3d at 39; see Quarles v. Dep't of Navy, 893 F.2d 390, 392 (D.C. Cir. 1990). Further, it is our contention that over-application of the (b)(5) exemption prevents the public from obtaining access to documentation regarding the actions and deliberations of the government and is therefore counter to the intent of the Freedom of Information Act.

In addition to requesting that conduct another search, I ask that you give review the documents previously found responsive again for maximum disclosure of information giving due consideration to public interest on matters addressed in the documents. The efforts of the United State government to create stable political institutions in Iraq after the war is of great interest to the American public as well as of great historical value. At a minimum, release all factual portions found responsive to the request. Factual, post-decisional information, unless inextricably intertwined with other information, is not protected under the fifth exemption and must be released. See the Supreme Court's ruling in EPA v. Mink, 410 U.S. 73.

We appreciate your prompt response in releasing these documents to the public. Thank you for your attention to this request.





This is in response to your January 29, 2007, Freedom of Information Act (FOIA) appeal, concerning the January 11, 2007) response from the Office of Freedom of Information (OFOI). You appealed the denial of information and the adequacy of the search for records conducted by the OFOI in response to your August 28, 2006, FOIA request. I apologize that this response was not provided in a more timely manner.

A review of the denied information has been completed at the appellate level and I have determined that additional information should be released. Portions of the withheld information in the enclosed documents remain exempt from release because it is specifically exempted by 10 U.S.C §130c, which applies to certain sensitive information of foreign governments and international organizations. Additionally, a portion of the withheld information is exempt from release because it is pre-decisional and deliberative in nature and contains subjective evaluations, opinions and recommendations which, if disclosed, would inhibit the decision making process. Release of this information would have the foreseeable harm of curtailing open discussions and recommendations in the future. Finally, some information is withheld because release would constitute a clearly unwarranted invasion of the personal privacy of individuals. Consequently, this information is exempt from release pursuant to 5 U.S.C. § 552 (b)(3), (b)(5) and (b)(6).

As for your appeal of the adquency of search, new pages responsive to your request were located. These pages were addressed in a previous response to you.

These documents are the best source of information regarding the U.S. government's assessment of the Iraqi government's effectiveness in "standing up." Further, the public interest in these materials is evidenced by the facts that the media has presented daily reports on the security situation in Iraq and that the presence of U.S. soldiers attempting to stabilize braq has been funded by tax-payer money. It is likely that these documents will inform the public regarding U.S. foreign policy in Iraq.

However, in accordance with the principles and spirit of the Paperwork Reduction Act (PRA) of 1995, whose stated goals are "to have Federal agencies become more responsible and publicly accountable for reducing the burden of Federal paperwork on the public...," in lieu of sending you photocopies to attest to my due inclusion into this status, I include the following Internet URL (http://jeremybigwood.net/JBsPUBS/Articles4FOIA.htm#*) where digital facsimiles of articles I have published can be found. These articles alone are sufficient to fulfill the stated requirement of a long track record of publication and the likelihood of further publication and clearly bestow upon me "representative of the news media" status. 

This is our final response to your Freedom of Information Act (FOIA) requests dated January 31, 2006 and December 18, 2006, case control numbers SC 06-100 and SC 07-038, respectively. In your request you requested information related to the Bolivia's Chinese made Surface Air Missiles (SAMs) and Man Portable Air Defense Systems (MANPADS).

During our search for information responsive to your request, we located two documents consisting of five pages. However, upon completion of our line-by-line review, we determined the information within the documents is currently and properly classified in accordance with Executive Order 12958, as amended, Section 1.4 (a), which pertains to military plans, weapons systems, or operations; (b), which pertains to foreign government information; and (c), which pertains to intelligence activities (including special activities), intelligence sources or methods; and (d), which pertains to foreign relations or foreign activities of the United States, including confidential sources. Other information if released would allow circumvention of physical security procedures and force protection measures by openly giving insight into the security capabilities or vulnerabilities concerning the protection of our agency property, personnel, and sources. Release of other information would constitute a clearly unwarranted invasion of the personal privacy of individuals. Accordingly, release of this information is denied pursuant to Title 5 U.S.C. § 552 (b) (1), (b) (2), and (b) (6), Freedom of Information Act by Captain Donna Sue Holly, USN, Vice Director of Intelligence and Colonel Stephen A. Medeiros, USMCA, Vice Director, Strategy, Policy, and Security Cooperation.

Should you deem Captain Holly's and Colonel Medeiros' decision of denying all this information to be an adverse action, you have the right to appeal their decision by writing to the Office of Freedom of Information, 1155 Defense – Pentagon, Washington, D.C. 20301-1155, within 60 days of receipt of this letter. Both your letter and envelope should be clearly marked "Freedom of Information Act Appeal." A copy of this letter should be enclosed with your appeal. Please refer to the above case control number SC 07-038.

Under provisions of the Freedom of Information Act and under the Electronic Freedom of Information Act, 5 U.S.C 552, I am filing this administrative appeal to U.S. Special Operations Command's denial of my longstanding request for any and all information related to written and/or verbal correspondence between the command and retired Army CSgtM Eric Haney over the creation and copyright of a military emblem and logo.

That emblem and logo has been (and may currently be) used by the 1st Special Forces Operational Detachment-Delta, more commonly known as Delta Force.

In a July 6 letter, Special Operations Command said it had denied my request because the information is classified. The command cited 5 USC 552 (b)(1).

No explanation is provided as to why the information is classified, who determined it should be classified, and what public or private interest is protected or advanced by its remaining classified.

Delta Force, based at Fort Bragg, NC, has been the subject of media coverage for many years and the logo has appeared on the covers of books written by former unit members, including Eric Haney.

The following are a few of the authoritative books written by ex-military personnel and that include detailed descriptions of Delta Force:

"Inside Delta Force," by Eric Haney. The book's cover shows the logo/emblem: a sword covered by a triangle-shaped thunderbolt.

"The Guts To Try," by retired Air Force Col. James Kyle.

"No Room For Error," by retired Air Force Col. John Carney.

"Delta Force," by retired Army Col. Charlie Beckwith, the founder of Delta Force. The logo/emblem is featured prominently on the cover of his book.

Additionally, former Army Chief of Staff Gen. Peter Schoomaker includes several references to 1st Special Force Operational Detachment-D in his official career summary.

Army Maj. Gen. John Mulholland also makes specific reference to his time "Delta Force" in his official career summary.

As the above clearly demonstrates, references to Delta Force and its logo/emblem are public knowledge. There are even disclosures sanctioned by the U.S. Army.

When I requested the information well over a year ago, I was a reporter with The Tampa Tribune. I am now a reporter with the Associated Press in Washington, DC.

My original FOIA request for this information was filed with the U.S. Army Special Operations Command, Ft. Bragg, NC. That request was given case number 06-55(J).

The information I requested is urgently needed by the AP, which is engaged in disseminating information in order to inform the public of alleged or actual federal government activities.

I would appreciate your handling this request as quickly as possible.


