- [6] U.S. Military Identification Card
- [7] U.S. Military Dependent Identification Card
- [8] U.S. Military Retiree Identification Card
- [9] Identification card issued by Federal, State, or local government agencies.
- [10] Native American Tribal Document
- [11] INS Form I-179 - Identification Card for Use of Resident Citizen in the United States
- [12] INS Form I-551 - Permanent Resident Card or Alien Registration Receipt Card
- [13] Foreign Passport
- [14] Foreign Passport with a temporary (INS Form I-551) stamp or temporary (I-551) printed notation on a machine readable immigrant visa.
