Subject: CSIS Team to Iraq

As you recall, Congressman Frank Wolf mentioned the "Play to Win" report by the Center for the Association of the United States Army (AUSA) and the Center for Strategic and International Studies (CSIS) in his recent Iraq report to Secretary Rumsfeld. On June 13, LTG Skip Sharp and I met with John Hamre, head of CSIS and former DepSecDef, to explore the possibility of a CSIS-AUSA team going to Iraq.

We discussed a small team (no more than three or four people) going to Iraq as informal consultants to you and OSD. They would look at reconstruction efforts and make recommendations based on what they saw and what they know of reconstruction efforts in other countries. SecDef thinks there may be value in Hamre's leading such a group to Iraq. If you agree, I'll put Hamre in touch with the appropriate person on your staff.

Attached is the CSIS proposal. The proposal doesn't specify that Hamre will personally be on the team in Iraq, but I think he must participate. A key question is whether the team should go immediately, so their thoughts can be input for the campaign plan now in the works, or whether they should go in late July.



In addition to meeting with key coalition officials, it would be necessary to travel throughout Iraq and have a way to meet and talk with Iraqi citizens from all walks of life. Some of the time should also be spent outside of the official bubble with others who are active on the ground (e.g., NGOs). Given the brief time in country, our team could split up and cover different regions, but these kinds of details and the development of an itinerary should await direction from the field.

As I mentioned, we see ourselves as informal consultants, and as such would seek no compensation. We would expect the government to pay for travel to and from the United States and local costs. There would be a need for security support, transport, interpreters, and basic housing. If it would be easier to work through an existing contract, that would be fine.

Our goal would be to take a fresh, independent look at the reconstruction efforts and challenges ahead, provide honest reporting, and make recommendations that would help this significant challenge succeed. In addition to briefings, we would produce an executive report, which would be made available to the public upon the completion of the project.

We look forward to further discussions with the two of you and [REDACTED] in the coming days. Because I will be on travel status, [REDACTED] will serve as the point of contact. She can be reached as follows:

[REDACTED] currently serves as a Senior Adviser in the International Security Program and [REDACTED] of the Post-Conflict Reconstruction Project at CSIS. [REDACTED] co-authored several recent reports on post-conflict reconstruction in Iraq. [REDACTED] is also a visiting lecturer at the Woodrow Wilson School at Princeton University, where he was previously the Frederick H. Schultz Professor of Economic Policy. From 1999-2001, [REDACTED] served as UN Deputy High Commissioner for Refugees in Geneva. He was the first Director of the Office of Transition Initiatives at the U.S. Agency for International Development in Washington, D.C. (1994-1999), where he helped to start political development programs in over 20 war-torn regions, from the Philippines to Rwanda, from Bosnia to Haiti. A graduate of Harvard College [REDACTED], [REDACTED] earned his M.B.A. from Boston University [REDACTED], with an emphasis on public management.

[REDACTED] is a [REDACTED] International Affairs Fellow for the Council on Foreign Relations. She is spending the year at CSIS, where she is working with CSIS's Post-Conflict Reconstruction Project. She has co-authored several recent CSIS reports on post-conflict Iraq. During his military career, [REDACTED] served as Senior Speechwriter to the Chief of Staff, Army, Military Liaison Team Chief to the Republic of Slovenia, and Assistant Professor of International Relations at the United States Military Academy. He served as the Operations Officer of a Cavalry Regiment in the Gulf War, and commanded an armored battalion and an armored brigade. His awards include the Defense Superior Service Medal, two Legions of Merit, Bronze Star, and Purple Heart. Feil received a B.S. from the U.S. Military Academy and a M.A. in Political Science from Stanford University.

[REDACTED] is a Senior Program Officer at the UN Foundation. Previously, she was Senior Fellow in the Role of American Military Power program at the Association of the United States Army and as a Co-Director of the CSIS/AUSA Post-Conflict Reconstruction Project. She served as Senior Policy Advisor for the Bureau for Humanitarian Response at the U.S. Agency for International Development, and was



assigned by USAID to be a Senior Social Scientist and Attorney at the World Bank's Post-Conflict Unit. She also served as Senior Advisor to the Office of Transition Initiatives at USAID. Mendelson holds a faculty appointment at The American University's School of International Service in Washington, D.C. and at Georgetown University's Center for National Security Studies. Mendelson received a J.D. from Washington College of Law at The American University, a Ph.D. in Latin American history from Washington University, St. Louis, and a M.A. of International Affairs, with a Certificate of Latin America Studies from Columbia University in New York.

SUBJECT: Oil-for-Food (OFF) Program

- As you may know, an interagency Task Force is reviewing the pricing of 760 (roughly 10%) of the approved and funded OFF contracts. Those contracts, valued at \$7B, represent 60% of committed funds.
- The Task Force has reviewed the first 628 contracts. Attached are its initial recommendations.
- The potential savings from implementing the recommendations could be significant
 - Up to \$600M saved if overpriced contracts are renegotiated; and
 - \$2-3B saved if overpriced and questionable contracts are cancelled.
- The CPA has the authority to advise the UN Secretary General to either cancel or *eventually* negotiate adjustments in OFF contracts. If cancelled, the amounts would be deposited in the Development Fund for Iraq. If adjusted, the amounts could be used to meet current reconstruction and humanitarian requirements.
- You may want to consider the Task Force's recommendations, as you determine how to proceed with the OFF program. My staff is ready to help you.

OFF TASK FORCE INTERIM FINDINGS AND RECOMMENDATIONS

Interim Findings

- Of the 628 contracts already reviewed, roughly 50% were assessed to likely be overpriced. The average overpricing is 22% per contract.
- The total value of the contracts assessed to be overpriced is approximately \$2.8B; potential overpricing in the contracts is roughly \$600M.
- The OFF program reflects heavy dependence on old technology, particularly in the electrical sector; significant variability in prices for identical items; and little itemization of training, spare parts, and transportation costs.
- Several items of questionable value were identified, such as contracts for Cigarette Paper, Mercedes Benz Sedans, Sports Halls and larger-than-expected quantities of spares, passenger vehicles and other items such as maize headers.

Recommendations Regarding OFF Contracts

- Request documentation from suppliers for overpriced OFF contracts;
- Assess whether contract terms regarding spares or other items should be amended and whether contracts for "old technology" or items of questionable value are essential for immediate needs;
- Require adjustments in contracts that are overpriced.

Recommendations for Post-OFF Contracting

- Require that future contracts itemize transportation, insurance, and deliverables, including spare parts, services, or other items;
- Require suppliers to provide detailed specifications on items being supplied and detailed cost data for unique (sole source) items; and
- Require competitive bidding for commodity items; limit the use of middlemen.

INTERIM FINDINGS AND RECOMMENDATIONS

Interim Findings

- The Task Force is reviewing 760 (roughly 10%) of the approved and funded OFF contracts. Those contracts, valued at \$7B, represent 60% of committed funds.
- Of the 628 contracts already reviewed, roughly 50% were assessed to likely be overpriced. The average overpricing is 22% per contract.
- The total value of the contracts assessed to be overpriced is approximately \$2.8B; potential overpricing in the contracts is roughly \$600M.
- The OFF program reflects a heavy dependence on old technology, particularly in the electrical sector; significant variability in prices for identical items; and little itemization of training, spare parts, and transportation costs.
- Several items of questionable value were identified, such as contracts for Cigarette Paper, Mercedes Benz Sedans, Sports Halls and larger-than-expected quantities of spares, passenger vehicles and other items such as maize headers.

Recommendations Regarding OFF Contracts

- Request documentation from suppliers for overpriced OFF contracts;
- Assess whether contract terms regarding spares or other items should be amended and whether contracts for "old technology" or items of questionable value are essential for immediate needs;
- Require adjustments in contracts that are overpriced.

Recommendations for Post-OFF Contracting

- Require that future contracts itemize transportation, insurance, and deliverables, including spare parts, services, or other items;
- Require suppliers to provide detailed specifications on items being supplied and detailed cost data for unique (sole source) items; and
- Require competitive bidding for commodity items; limit the use of middlemen.

SUBJECT: Response to Your Mass Graves Proposal

I agree we need to take immediate action to secure mass grave sites, preserve the evidence they contain and assist Iraqis in identifying the bodies. The policy should note, however, that Deputy Secretary Wolfowitz directed the Secretary of the Army to secure and preserve evidence of Iraqi regime atrocities.

I recommend you revise the policy as follows:

- Coordinate with the Army:

Any FBI efforts in assessing and prioritizing the sites. (The Army is already working with the FBI on the Afghanistan investigations.)

The deployment of the humanitarian response and international forensics teams.

The proposal to create evidence coordination teams and a central evidence repository.

- The action plan suggests that USCENTCOM provide light security with augmentation by local Iraqi security forces at each site. It would be best, I think, to make maximum use of local security forces with USCENTCOM providing overall supervision and responsibility.

The above has been reviewed by lawyers from the DoD General Counsel, the Army and the Joint Staff. They concur. I don't think the document needs the Secretary's personal review. I have discussed the proposal with him in general terms.

As you know, some of the confirmed mass grave sites have been temporarily secured by the military to exploit for evidence of war crimes. The military has not secured many remaining sites which, although they pose evidence of crimes against humanity, do not present evidence of war crimes. While I have not yet visited the site at Hillah (I will Thursday), I understand from Jay Garner's recent trip there that at least some local leaders are satisfied with the degree of U.S. involvement, which is minimal. We will take this experience into account as we move forward.

Whatever we do, we must recognize that Iraqi families would like to conduct their own search for lost relatives. However, uncoordinated exploitation of grave sites diminishes the probability of identifying the missing and disadvantages those families who are not able to reach the mass grave site quickly. In addition, failure to preserve evidence may hamper future prosecutions by the new Iraqi government against the perpetrators. The international community and human rights organizations have urged us to take action to secure these sites and to bring forensics teams.

We are working on a mass graves policy that would provide security as required at sites that have not yet been subject to extensive digging. At sites that are already overrun with an emotional grieving population, I would not call on the military to remove families, but would deploy teams to work with local Iraqis in encouraging a more systematic process. I have attached a draft Action Plan for your review.

I would also like to urge rapid deployment of the FBI-led assessment team. I understand that there is some discussion of deploying Administration policy officials to accompany the FBI team. I think that any deployment of Administration policy officials should wait until after the assessment by the technical teams.

MASS GRAVES: ACTION PLAN

STEP ONE: PUBLIC AWARENESS AND ASSESSMENT

Public Awareness Program

- ORHA has initiated a media campaign through Al Sabah, Iraqi Media Network and other media outlets to explain to the public the necessity of preserving grave sites to facilitate identification of the missing and gather evidence of regime atrocities.
- We have also engaged local and religious leaders in this process.

Assessment teams

- An FBI-lead team will deploy immediately to Iraq to assess and prioritize mass graves.
- The FBI-led effort will be assisted by other coalition assessment teams, including the following: UK – Forensics investigative team of 8 to arrive within 24 hours and begin with al Hillah sites; ORHA is coordinating; Denmark – Danish team of 2 forensics experts currently collocated with ORHA judicial assessment team to begin to assess sites; Australian, Norwegian and Dutch governments have expressed initial interest.

STEP TWO: SECURITY AND SUPPORT

A. Sites subject to overwhelming local attention (e.g., Hillah)

Humanitarian Response Team:

- We will deploy a Humanitarian Response Team to Hillah and any other grave site subject to extensive digging. The Team will work with local leaders to implement a systematic process including: outreach of families; orderly digging; detailed examinations of personal effects; records of all remains identified; Death Certificates; witness interviews; and documentation of all information found at the site.

Military Support

- The military will continue to support grieving families by providing water, simple plastic bags, gloves, and masks.
- The military will assist in coordinating the efforts of NGOs, ICs or international expert forensics teams who may be on the scene.

B. Sites that have not been subject to extensive digging

Investigative and Forensics Teams to Investigate and Exhume Mass Graves

- Following the initial assessment and prioritization, Forensics Investigative Teams from the coalition will be deployed to conduct exhumations. These teams will be coordinated out of ORHA offices at the Iraq Forum.

- The teams will hire and train local Iraqis in digging grave sites.

Local Guard Force

- When possible, CENTCOM will provide light security at prioritized sites. As a longer-term measure, we will fund the salaries of local Iraqis to guard mass graves (Estimate: \$75,000).
- The local force will protect sites using the minimum force necessary (Lethal force only in Self-Defense; Light Weapons only).

STEP THREE: IDENTIFICATION

Identification Services / Missing Persons

- We will announce establishment of an Iraqi Committee on Missing Persons to collect the records of disappeared and create a national database. We will work with existing Iraqi organizations, such as the Committee for Free Iraqi Prisoners, to establish interview teams to collect data.
- We will develop a mechanism for integrating information on missing persons with the results of the forensics examination. (Estimate: \$1 million)
- We will create outreach programs for families to provide emotional support.

STEP FOUR: PROSECUTION


Central Evidence Repository

- ORHA will work with DRL and S/WC1 to request Evidence Coordination Teams from the coalition who will assess and create centralized and systematic warehouses for the storage, documentation and preservation of evidence.
- The Evidence Coordination Teams will train local experts in handling and preservation of forensics evidence.
