



REPORTS OF SEXUAL ASSAULT RECEIVED AT MILITARY INSTALLATIONS AND COMBAT AREAS OF INTEREST BY FISCAL YEAR

SEPTEMBER 01, 2021

This response contains information about non-intimate partner-related adult sexual assault reports made at military installations throughout the world. The tables that follow provide the number of sexual assault reports received or managed by Sexual Assault Response Coordinators (SARCs).

Reports are grouped by each Service's installation or platform and include the type (i.e., Restricted or Unrestricted), the Fiscal Year (FY) in which the victim reported the incident, and number of adult sexual assault reports currently or previously receiving services at the time the data were recorded. For reports made in Combat Areas of Interest, the tables show report totals by country and year where the victim made the report. In addition, some of the sexual assaults reported may have occurred during the same FY the individual reported the incident, during prior FYs, or prior to the individual entering military Service. Therefore, the number of sexual assaults reported to DoD in a given FY does not necessarily reflect the number of sexual assault incidents that occurred during that FY.

Moreover, the location where a victim made a report is not necessarily the location where the alleged incident occurred. Those making a report of sexual assault may do so at a time and place of their choosing, regardless of where or when the assault occurred. Consequently, an alleged incident of sexual assault that is reported to a SARC at a particular installation may have occurred elsewhere, or prior to entering military Service.

Nevertheless, a SARC that receives a sexual assault report is responsible for managing support services for the victim, until such time that the victim terminates the support or moves to another location. If the victim elects to continue support at the new installation, the SARC at the losing location initiates a person-to-person handoff to the SARC at the gaining location. This change in support is also annotated in the Defense Sexual Assault Incident Database (DSAID), preventing double counting of the incident.

Sexual Assault Reports

DoD uses the term "sexual assault" to refer to a range of adult sex-related crimes punishable under the Uniform Code of Military Justice (UCMJ). Sexual assault includes penetrating crimes (i.e., rape, sexual assault, and forcible sodomy), sexual contact crimes (i.e., aggravated and abusive sexual contact), and attempts to commit these offenses.

An Unrestricted Report of sexual assault is one where the adult sexual assault allegations are investigated and command is notified that a service member has alleged being sexually assaulted or has been identified as an alleged perpetrator of a sexual assault offense. Unrestricted Reports are referred for investigation to the Military Criminal Investigative Organization (MCIO) or civilian law enforcement agency with primary jurisdiction over the

alleged incident. A person making an unrestricted report is also provided victim support services for which he or she may be eligible.

A Restricted Report provides a confidential reporting option for those eligible persons who do not want their sexual assault allegations investigated. An individual may elect to make a Restricted Report to specified individuals within DoD authorized to accept such reports (e.g., SARCs, Sexual Assault Prevention and Response Victim Advocates (SAPR VAs), or healthcare providers). A Restricted Report allows Service members to receive legal advice, medical, and advocacy services, but does not trigger an investigation. Limited information about the incident is provided to Command, but the information does not include identification of the victim or the alleged perpetrator. Even when initially electing a Restricted Report, an individual may later convert to an Unrestricted Report if desired.

Who Makes Sexual Assault Reports

The sexual assault reporting numbers summarized in this document come from persons aged 17 or older who allege a sexual assault by someone who is not a spouse or intimate partner (i.e., incidents that do not otherwise fall under DoD's Family Advocacy Program). These include:

- 1. Service members on active duty (Title 10 status) from all four DoD Service branches² and activated Reserve and National Guard
- 2. Eligible adult (18 years of age and older) dependents of active duty members
- 3. DoD contractor personnel when they are authorized to accompany the Armed Forces in a contingency operation OCONUS
- 4. Other Civilian victims alleging a sexual assault by an active duty military member

Sexual assault and sexual abuse reports in which the alleged perpetrator and victim are spouses or intimate partners, or in which the victim is a military dependent child, are addressed by DoD's Family Advocacy Program.

When DoD Received the Sexual Assault Reports

The reports described in this release span from FY17 (October 1, 2016) through FY20 (September 30, 2020). The report numbers reflect a snapshot in time, meaning that they show the status of all reports at the time the data were retrieved from DSAID.³ The tables that follow describe the number and type of sexual assault reports made to and/or managed by SARCs assigned to the listed locations.

Installation-Based Reports of Sexual Assault

The reports in the tables that follow are grouped by the installation where the individual making the report last received services at the time of data retrieval. As previously stated, the numbers do not necessarily reflect where or when an alleged assault occurred. The installation data listed may include reports for sexual assaults that:

- Occurred at another location
- Occurred prior to the victim's military service
- Occurred while the victim was deployed, on leave, or in a temporary duty status

The installations listed are those installations that were managing the sexual assault report at the end of the FY listed. As a result, these numbers may not reflect a record of incidents that actually occurred at or near the installation.

The number of reports at each installation is not the same as sexual assault prevalence. A prevalence rate estimated the number of alleged incidents of sexual assault that may have occurred within a given population – not just the incidents that are reported. The Department estimates that about one third of active duty members who experience a sexual assault report the incident to a DoD authority.

Installations with more reports tend to be the larger military installations. Comparing the number of reports at one installation to another may not give an accurate picture of the differences between them.

A number of factors can contribute to the differences in reporting numbers across locations. For example, at installations that conduct recruit training, the number of cases reported may be larger due to new personnel reporting sexual assaults that occurred prior to entering military service. Most new members of the military receive their first introduction to the SAPR program at basic training. SARCs at the basic training facilities capture reports from new Service members who seek to address a prior to service history of sexual assault by making a Restricted or Unrestricted Report. Additionally, larger installations may also be managing larger numbers of expedited transfer cases due to the greater availability of open positions, medical care, and support facilities at the larger installation. Service members can choose for their case management to transfer with them to their new duty location.

Since 2005, DoD has implemented policies that encourage more Service members to report their sexual assault allegations and engage support services available to them, regardless of when the incident occurred.

The percentage of Service members who choose to report the crime has increased over time. In 2006, an estimated 7 percent of military victims reported an alleged sexual assault to a military authority.⁴ In FY18, DoD estimated that about one in three (30 percent) Service members who experienced a sexual assault reported the incident to either SAPR program personnel or military criminal investigative organization.

To assess the estimated occurrence of sexual assault among active duty Service members, DoD administers a confidential survey that scientifically samples the military population. The *Workplace and Gender Relations Survey of Active Duty Members* (WGRA) gives the Department representative and reliable estimates of how many Service members likely experienced a sexual assault in 12 months prior to survey administration. The results of the most recent *WGRA* were published in DoD's FY18 Annual Report on Sexual Assault in the Military ("Annual Report"). It should be noted that only when allegations are reported and investigated can a determination be made that a sexual assault occurred.

Congress requires DoD to report the number of sexual assault reports it receives each year involving Service members as the victim and/or alleged perpetrator. The Annual Report includes the number of Restricted and Unrestricted Reports made to DoD SAPR personnel and investigators at MCIOs and provides sexual assault reporting numbers for Army, Navy, Marine

Corps, and Air Force.⁵ The Case Synopses section of the Annual Report identifies the country in which the report is made.

¹¹ The location where a victim made a report is not necessarily the location where the incident occurred. Those making a report of sexual assault may do so at a time and place of their choosing, regardless of where or when the assault occurred. Consequently, an alleged incident of sexual assault that is reported to a SARC at a particular installation may have occurred elsewhere, or prior to entering military Service.
