- Regulatory compliance expertise gained from my Internal Revenue Service (IRS) domestic and international tax compliance experience with 28 years of service at the top management level.
- Large and complex operations executive and management expertise as demonstrated directing IRS division level organizations with over 3,000 professional employees. No theoretical management case studies, but hands on operational experience with awards for high level of management and executive performance.
- Highest of personal trust extended by the SBA Office of the Inspector General, IRS Internal Inspection Service and the U.S. /State Attorney General's office in directing complex and sensitive national and statewide regulatory, civil and criminal issues.
