I APPRECIATE YOUR LETTER OF MARCH 17 ON ARGENTINA. I SHARE YOUR BELIEF THAT WE NEED TO MAKE EFFECTIVE USE OF THE TIME AND FLEXIBILITY REMAINING BEFORE THE OCTOBER I LEGISLATIVE CUTOFF OF ARMS SALES TO ARGENTINA TO PERSUADE THE ARGENTINE GOVERNMENT TO IMPROVE ITS HUMAN RIGHTS PRACTICES. INFUL 13526

THERE HAVE BEEN SOME RECENT IMPROVEMENTS IN THE HUMAN RIGHTS SITUATION IN ARGENTINA, BUT THESE ARE MORE THAN OUTWEIGHED BY THE CONTINUING DISAPPEARANCES AND THE TRAGIC, UNEXPLAINED DEATHS OF TWO NUNS AND FIVE OTHER WOMEN WHO WERE ABDUCTED IN DECEMBER. IN VIEW OF THIS SITUATION AND THE STRONG CONGRESSIONAL

UNCLASSIFIED INTEREST IN OUR POLICY ON ARMS TRANSFERS TO ARGENTINA. WE THINK IT WOULD BE BEST AT THIS TIME NOT TO GO AHEAD WITH THE PENDING ARMS TRANSFER CASES AND NOT TO GRANT THE ARGENTINE REQUEST TO PURCHASE TRAINING.

INSTEAD, WE SUGGEST THAT A TEAM CONSISTING OF SENIOR STATE DEPARTMENT OFFICIALS AND SENIOR U.S. MILITARY OFFICERS SHOULD MEET AT A HIGH LEVEL WITH REPRESENTATIVES OF THE ARGENTINE GOVERNMENT. THE TEAM WOULD EXPLAIN THAT BECAUSE OF HUMAN RIGHTS ABUSES IN ARGENTINA. WE ARE NOT IN A POSITION TO ACT FAVORABLY

ON EITHER THE LARGE NUMBER OF ARMS TRANSFER CASES THAT HAS ACCUMULATED OR THE ARGENTINE REQUEST TO PURCHASE TRAINING. AND THAT ONLY SUBSTANTIAL. AUTHENTIC HUMAN RIGHTS IMPROVEMENTS IN ARGENTINA WOULD PERMIT US TO CHANGE OUR POSITION ON THESE MATTERS.

THE TEAM WOULD INFORM THE ARGENTINES THAT IF THEY CURTAIL THE IRREGULAR DETENTION AND ABDUCTION PRACTICES USED BY THE SECURITY FORCES, AND ESTABLISH AND MEET A SCHEDULE FOR CHARGING AND TRYING--OR RELEASING--THOSE HELD UNDER EXECUTIVE AUTHORITY, WE WILL RESPOND IN A CALIBRATED AND SEQUENTIAL FASHION, AS THE HUMAN RIGHTS IMPROVEMENTS OCCUR, WITH APPROVALS OF THE PENDING MATTERS. DEPENDING UPON ARGENTINA'S RESPONSE TO THE FOREGOING, THE TEAM WOULD HAVE AUTHORITY TO INDICATE APPROVAL OF SOME OF THE PENDING CASES.

I HOPE YOU WILL AGREE THAT THE INCLUSION OF SENIOR U.S. MILITARY PERSONNEL IN SUCH A TEAM WOULD HAVE A SUBSTANTIAL AND DESIRABLE EFFECT ON THE ARGENTINES.

I APPRECIATE YOUR VERY THOUGHTFUL AND POSITIVE REPLY TO MY LETTER OF MARCH 17 CONCERNING INITIATIVES TO ENCOURAGE HUMAN RIGHTS IMPROVEMENTS IN ARGENTINA. IN VIEW OF CIRCUMSTANCES SUBSEQUENT TO MY LETTER, I RECOGNIZE THE WISDOM IN THE GRADUATED RESPONSE APPROACH YOU SUGGEST.

WE ARE IN COMPLETE AGREEMENT WITH YOUR PROPOSAL TO SEND A STATE/DOD TEAM TO ARGENTINA AS OUTLINED IN YOUR LETTER. MY REPRESENTATIVES WILL BE MAJOR GENERAL LEE E. SURUT, U.S. ARMY, REPRESENTING THE JCS, AND REAR ADMIRAL GORDON J. SCHULLER, DIRECTOR, INTER-AMERICAN REGION, OSD-ISA. THEY ARE PREPARED TO FULLY COOPERATE AND WORK WITH YOUR REPRESENTATIVES IN PREPARATION FOR AND FULFILLMENT OF THE MISSION.

I AM HOPEFUL THAT THIS INITIATIVE WILL LEAD TO MAJOR PROGRESS TOWARD THE ATTAINMENT OF OUR HUMAN RIGHTS OBJECTIVES IN ARGENTINA, WHILE AT THE SAME TIME SERVING THE BROAD RANGE OF OUR BILATERAL INTERESTS. YOU HAVE THE FULL SUPPORT OF THE DEPARTMENT OF DEFENSE IN THIS ENDEAVOR.

HAROLD 3. (S) SECSTATE PROPOSAL FOR HIGH LEVEL TEAM, AS INDICATED BY SECDEF RESPONSE, PERCEIVED IN OSD AND TO SOME EXTENT IN J-5 AS POSITIVE INITIATIVE. FEELING IS THAT NOW ARGENTINES CAN GET FAVORABLE RESPONSES FROM HSG DEPENDENT UPON CONTINUED COMMITMENT TO PROTEC-TION OF HUMAN RIGHTS. IF GEN VIDELA INTENDS TO CONTINUE HUMAN RIGHTS PROGRESS OF HIS GOVERNMENT, AS REPORTED IN REF C. THEN APPROVAL OF SPARE PARTS AND TRAINING REQUESTS SHOULD BE POSSIBLE. GIVEN CURRENT HUMAN RIGHTS SITUATION, AS REPORTED REF D, THE 1 MAY STATE RESPONSE SEEMS BEST WE CAN EXPECT AND MAY WORK OUT THOUGH JCS INITIALLY OPPOSED SENDING MILITARY TEAM.

4. (C) CONCERNING WHETHER TEAM WILL BE HELPFUL, AMEMBASSY, BUENOS AIRES VIEWS HAVE BEEN PROVIDED TO STATE, AMBASSADOR CASTRO STRONGLY SUPPORTED THE INITIATIVE.
