1. ~~(C)~~ I have reviewed your letter to Captain Dick Howe dated 14 March 1978. I fully appreciate your concern for the tone of welcome I may receive in Argentina, but am not dissuaded from making the trip for that reason. I shall continue to plan for approximately a three and one-half day visit, unless Ambassador Castro should indicate otherwise. I expect to arrive with my party via C-130 at Ezeizu International Airport at approximately 2130 local on 4 April (permission has been granted by the local MAC representative to land after dark) and to depart from Bahia Blanca at approximately 1200 on Saturday, 8 April on a direct flight to Lima, Peru, or Santa Cruz, Bolivia, for RON. (Your assistance in arranging for the necessary clearance of Argentine customs on the 8th would be sincerely appreciated.) I will be accompanied by Mrs. McAuliffe; COL Donald D. (C) While I realize that a considerable part of my in-country itinerary will be at the discretion of host country officials, I would like you, to the extent possible, to attempt to arrange for me to meet with ^{page - 3} small groups of junior officers of the Argentine Armed Forces. I am most interested in having the opportunity to learn firsthand their personal reactions to the current state of U.S.-Argentina relationships and their views of the future. However, whether or not such meetings can be arranged for me in view of my limited time schedule, I would ask that COL Wilson and Lt Col Souder meet with junior officers in Buenos Aires and Bahia Blanca. Additionally, as the Senior Marine representative at USSOUTHCOM, COL Wilson should be scheduled (apart from my schedule) to meet with the Commander of the Marine Forces and to visit with the units and troops in his command, at both locations. (COL Wilson will require an interpreter.)
