Reference is made to ATTNG-SAT-A's undated letter requesting OSD guidance concerning the subject program.

The guidance provided in Sec Def 0219322 Oct 78 remains unchanged, i.e., after 30 September 1978 no new MAP orders, including those for IMET, will be issued for Argentina and no new Letters of Offer (DD Form 1513) or Amendments (DD Form 1513-1) will be issued. Implementation of existing (accepted) FMS Training Cases will continue, including any sequential training specifically cited in the Letters of Offer.
