MEMORANDUM FOR THE SECRETARY OF DEFENSE

SUBJECT: Reserve Forces Policy Board Reception and Dinner

Mr. Louis Conti, Chairman, Reserve Forces Policy Board, has extended an invitation to you to co-host a reception and dinner at Bolling AFB Officers' Club on Monday, December 6. The purpose of this reception and dinner is to commemorate the 30th Anniversary of the founding of the Board in 1952. Mr. Edwin Meese III has accepted an invitation to be the guest speaker.

The reception and dinner will involve approximately 350 to 400 guests. The list of guests includes senior OSD staff, members of Congress, and key staffers from Oversight Committees, and several guests from the Organization of American States. The Reserve Forces Policy Board has testified in favor of greater emphasis on Latin American Affairs. They have been negotiating with OAS officials, and as a result, Ambassador Orfila and his personal staff will meet with the Board and their wives on Wednesday, December 8.
