1. ~~CONFIDENTIAL~~ INFORMATION RECEIVED INFORMALLY INDICATES THAT A CAPTAIN SALVIO O. MENENDEZ, ARGENTINE NAVY (ARA) WILL BE TRAVELING TO THE UNITED STATES FOR MEDICAL TREATMENT AT BETHESDA NNMC. THE CAPTAIN, WHO WORKED FOR SPECIAL NAVY INTELLIGENCE, RECEIVED INJURIES TO RIGHT LEG DURING A TERRORIST ACTIVITY ENCOUNTER. FEMUR WAS SHATTERED AND NEEDS TO BE RE-PAIRED WITH METAL SUPPORTS.
2. ~~CONFIDENTIAL~~ THE ARA WAS QUERIED WHETHER ANY ASSISTANCE WAS NEEDED. REPLY WAS, ALL ARRANGEMENTS HAVE BEEN MADE THROUGH THEIR EMBASSY IN WASH DC AND AT BETHESDA HOSP AND THAT NO ASSISTANCE BY ~~CONFIDENTIAL~~ WAS NEEDED AT THIS TIME. INFORMATION IS BEING HELD CLOSE IN THAT MENENDEZ IS WELL KNOWN AND A GOOD TARGET FOR THE TERRORISTS.
3. ~~CONFIDENTIAL~~ ABOVE INFO SENT TO ENSURE ARRANGEMENTS HAVE BEEN MADE. CAPT MENENDEZ AND FAMILY OF FIVE TENTATIVELY SCHEDULED TO DEPART BUENOS AIRES 20 DEC 1976 VIA AEROLINEAS ARGENTINA AIRCRAFT.
