## TOP SECRET (TS); SECRET (S); CONFIDENTIAL (C)

WARNING NOTICE - SENSITIVE INTELLIGENCE SOURCES AND METHODS INVOLVED (WNINTEL). This marking will be prominently displayed on all information and materials relating to sensitive intelligence sources and methods. Materials so marked will not be disseminated in any manner outside authorized channels without the permission of the originating department and an assessment by the senior intelligence officer in the disseminating department as to the potential risk to the national security and to the intelligence sources and methods involved.

DISSEMINATION AND EXTRACTION OF INFORMATION CONTROLLED BY ORIGINATOR (ORCON). This marking shall be used when unique source sensitivity factors, known to the originator, require strict compliance with third agency rule procedures, in addition to a continuing knowledge and supervision on the part of the originator as to the extent to which the original document and information contained therein is disseminated. Documents and information bearing this marking will not be disseminated beyond the Headquarters elements of the recipient organizations and the information contained therein shall not be extracted and incorporated into other reports without the permission of and under conditions prescribed by the originator.

USIB DEPARTMENTS ONLY (USIBONLY). Foreign intelligence so marked will not be disseminated to departments and agencies not represented on the U.S. Intelligence Board without the permission of the originating agency. The Department of Defense is a USIB member; therefore, items with this marking can be disseminated to all DOD components.

NOT RELEASABLE TO CONTRACTORS OR CONTRACTOR/CONSULTANTS (NOCONTRACT). Foreign intelligence so marked shall not be disseminated to contractors or contractor consultants without the permission of the originating agency. This restriction shall not apply to those consultants hired under Civil Service Commission procedures, or comparable procedures derived from authorities vested in heads of departments and agencies by law, and who are normally considered an extension of the office by which they are employed.

CAUTION - PROPRIETARY INFORMATION INVOLVED (PROPIN). This marking will be used in conjunction with foreign intelligence obtained from various sources in the U.S. private business sector as the information may bear upon propietary interests of the source or may otherwise be used to the source's detriment. Recipients of reports bearing this marking shall take every reasonable precaution to ensure that the information is not used to the detriment of the source. (This control marking cannot be used alone. When it is used, the control marking "NOCONTRACT" must also be used.)

NOT RELEASABLE TO FOREIGN NATIONALS (NOFORN). Foreign intelligence so marked involves special considerations requiring that it not be released in any form to foreign governments, foreign nationals, or non-U.S. citizens without the permission of the originating agency.

THIS INFORMATION HAS BEEN AUTHORIZED FOR RELEASE TO (Specified Countries) (REL Specified Countries). This marking may be used when the originating agency predetermines that information can be released to specified foreign governments.

MRS. PERON ALTERS COURSE.

(C/NOFORN) The President has announced that she will neither seek reelection nor bow to those calling for her resignation. She has also stated that national elections will be held this year. At the same time, the government has announced the reconvening of Congress next week, only several days after ordering that body's adjournment to thwart impeachment proceedings against the President.

(C/NOPORN) These maneuvers are designed to ease the ever-mounting pressures for the President's ouster and are similar to the tactics Mrs. Peron has used before to retain the Presidency. When her advisers have perceived that opposition forces might be seriously threatening the President's tenure, they have effectively silenced -for the moment at least -- their critics through appeasement.

(C/NOPERN) Whether the current tactics are successful remains to be seen. Although Mrs. Peron has probably slowed the movement for her removal, her most important base of support -- labor -- is likely to insist on further concessions. Labor leaders are likely to demand Cabinet changes to replace those recently deposed ministers who were favorably oriented toward the workers' movement. Nonetheless, after a key labor meeting on 18 February to determine that group's position on the current political situation, a profound change was noted. For the first time, labor endorsed a basic support for the institution of the Presidency instead of giving its absolute personal support for This represents a sound defeat for the Mrs. Peron. President in that labor now appears more interested in reorganizing its forces than propping up Mrs. Peron.

Her continued loss of congressional support and only a lukewarm labor endorsement increase the chances that she may still be removed by constitutional means, thus reducing for the moment pressure on the military to remove her.
