WARNING NOTICE - SENSITIVE INTELLIGENCE SOURCES AND METHODS INVOLVED (WNINTEL). This marking will be prominently displayed on all information and materials relating to sensitive intelligence sources and methods. Materials so marked will not be disseminated in any manner outside authorized channels without the permission of the originating department and an assessment by the senior intelligence officer in the disseminating department as to the potential risk to the national security and to the intelligence sources and methods involved.

DISSEMINATION AND EXTRACTION OF INFORMATION CONTROLLED BY ORIGINATOR (ORCON). This marking shall be used when unique source sensitivity factors, known to the originator, require strict compliance with third agency rule procedures, in addition to a continuing knowledge and supervision on the part of the originator as to the extent to which the original document and information contained therein is disseminated. Documents and information bearing this marking will not be disseminated beyond the Headquarters elements of the recipient organizations and the information contained therein shall not be extracted and incorporated into other reports without the permission of and under conditions prescribed by the originator.

USIB DEPARTMENTS ONLY (USIBONLY). Foreign intelligence so marked will not be disseminated to departments and agencies not represented on the U.S. Intelligence Board without the permission of the originating agency. The Department of Defense is a USIB member; therefore, items with this marking can be disseminated to all DoD components.

NOT RELEASABLE TO CONTRACTORS OR CONTRACTOR/CONSULTANTS (NOCONTRACT). Foreign intelligence so marked shall not be disseminated to contractors or contractor consultants without the permission of the originating agency. This restriction shall not apply to those consultants hired under Civil Service Commission procedures, or comparable procedures derived from authorities vested in heads of departments and agencies by law, and who are normally considered an extension of the office by which they are employed.

CAUTION - PROPRIETARY INFORMATION INVOLVED (PROPIN). This marking will be used in conjunction with foreign intelligence obtained from various sources in the U.S. private business sector as the information may bear upon proprietary interests of the source or may otherwise be used to the source's detriment. Recipients of reports bearing this marking shall take every reasonable precaution to ensure that the information is not used to the detriment of the source. (This control marking cannot be used alone. When it is used, the control marking "NOCONTRACT" must also be used.)

NOT RELEASABLE TO FOREIGN NATIONALS (NOFORN). Foreign intelligence so marked involves special considerations requiring that it not be released in any form to foreign governments, foreign nationals, or non-U.S. citizens without the permission of the originating agency.

LEGISLATIVE ASSEMBLY WILL NOT CONVENE.

~~(S, NOFORN)~~ The Senate President's decision not to convoke a legislative assembly next week probably moves Argentina closer to a military government.

~~(S, NOFORN)~~ On 4 March, Senator Italo Luder announced that such an assembly would be unconstitutional. He suggested that a multi-party meeting would be the best way to solve the country's pressing political problems. However, some opposition congressmen accused Luder of being bought off by close supporters of Mrs. Peron, and that by his action he had blocked the last chance for a constitutional solution to the current political crisis.

~~(S, NOFORN)~~ Meanwhile, the inability of the Peronists to solve their political problems will probably be demonstrated at a Party Congress scheduled to begin 6 March. Party delegates are already sharply divided with little chance for reconciliation. The meeting is likely to be a real showdown between those opposing and supporting Mrs. Peron's continuance in office.

~~(S, NOFORN)~~ In another development, on 5 March the government launched a crash program to revive the rapidly faltering economy. A six-month wage and price freeze with a 12 percent wage increase for workers retroactive to 1 March was effected. At the same time the "peso" was devaluated and the cost of gasoline, fuel oil, gas, and public services and utilities was raised. These economic measures probably constitute another last ditch effort by Mrs. Peron to stave off military intervention by appealing to labor elements for support. The new program, however, except for the wage increase, is not likely to gain support from the country's workers who will directly experience the increased costs of public services.

(~~C/NOFORN~~) In any event, neither the Party Congress nor the economic measures will significantly affect the outcome of the political crisis. If a serious confrontation occurs among the various factions at the Party Meeting or if labor is not receptive to the new economic plan, the military's contention that civilian institutions are no longer capable of providing solutions to the nation's problems will be reinforced.

(~~C/NOFORN/WHINTEL~~) There are still indications that the military will take over the government, and the ultimate decision as to when reportedly remains in the hands of Army Commander, General Videla. The most likely time for such a move is on a Friday evening or weekend when the majority of the labor force is off and can't be readily organized to interfere or protest the military's intervention in the government. Some reporting indicates that the military commanders are pressing for the coup next weekend, which now seems likely. (~~NOFORN - Declassify upon notification of originator~~)
