## TOP SECRET (TS); SECRET (S); CONFIDENTIAL (C)

WARNING NOTICE - SENSITIVE INTELLIGENCE SOURCES AND METHODS INVOLVED (WNINTEL). This marking will be prominently displayed on all information and materials relating to sensitive intelligence sources and methods. Materials so marked will not be disseminated in any manner outside authorized channels without the permission of the originating department and an assessment by the senior intelligence officer in the disseminating department as to the potential risk to the national security and to the intelligence sources and methods involved.

DISSEMINATION AND EXTRACTION OF INFORMATION CONTROLLED BY ORIGINATOR (ORCON). This marking shall be used when unique source sensitivity factors, known to the originator, require strict compliance with third agency rule procedures, in addition to a continuing knowledge and supervision on the part of the originator as to the extent to which the original document and information contained therein is disseminated. Documents and information bearing this marking will not be disseminated beyond the Headquarters elements of the recipient organizations and the information contained therein shall not be extracted and incorporated into other reports without the permission of and under conditions prescribed by the originator.

USIB DEPARTMENTS ONLY (USIBONLY). Foreign intelligence so marked will not be disseminated to departments and agencies not represented on the U.S. Intelligence Board without the permission of the originating agency. The Department of Defense is a USIB member; therefore, items with this marking can be disseminated to all DOD components.

NOT RELEASABLE TO CONTRACTORS OR CONTRACTOR/CONSULTANTS (NOCONTRACT). Foreign intelligence so marked shall not be disseminated to contractors or contractor consultants without the permission of the originating agency. This restriction shall not apply to those consultants hired under Civil Service Commission procedures, or comparable procedures derived from authorities vested in heads of departments and agencies by law, and who are normally considered an extension of the office by which they are employed.

CAUTION - PROPRIETARY INFORMATION INVOLVED (PROPIN). This marking will be used in conjunction with foreign intelligence obtained from various sources in the U.S. private business sector as the information may bear upon propietary interests of the source or may otherwise be used to the source's detriment. Recipients of reports bearing this marking shall take every reasonable precaution to ensure that the information is not used to the detriment of the source. (This control marking cannot be used alone. When it is used, the control marking "NOCONTRACT" must also be used.)

NOT RELEASABLE TO FOREIGN NATIONALS (NOFORN). Foreign intelligence so marked involves special considerations requiring that it not be released in any form to foreign governments, foreign nationals, or non-U.S. citizens without the permission of the originating agency.

## ARGENTINA

MILITARY AGREE COUP IS NECESSARY.

(STNOFORNYWNINTED) The military high command has reportedly decided to carry out a coup against Mrs. Peron before 5 March. Should congressional leaders now meeting be unable to reach a decision to declare the President unfit to continue in office -- the only constitutional alternative remaining other than resignation -- Mrs. Peron could be out of office as early as this weekend.

(C./NOPERMY/MARKYTHE) The navy and air force commanders meeting on 18 February apparently convinced reluctant Army Commander Videla that the situation in the country had deteriorated to the point where the armed forces should takeover the government. Military planning for a coup is well along and individual units have their instructions. Planning now envisions Videla heading the new government, at least for a while, aided by a predominantly military Cabinet.

(C/MOTORN) Following renewed presentation of armed forces' recommendations on government changes to an unyielding President, the Minister of Defense has resigned. He reportedly left the country without awaiting Presidential reaction. This removes him from the uncomfortable position of having to decide between supporting the government or the military commanders.

(C/MEMEREN) Mrs. Peron's political position has deteriorated steadily over the past several weeks, with labor, politicians and, most recently, members of her own party turning against her. Nonetheless, the military under Videla's leadership, had been reported as still leaning toward a constitutional solution. Congress, however, has been unable to

move against Mrs. Peron. Action to initiate impeachment proceedings against Mrs. Peron failed on

the 25th. The remaining alternative is convocation of a special assembly which would declare her unfit to remain in office, presumably for health reasons. Such an alternative reportedly is now being discussed. Should the move fail, a coup against Mrs. Peron as early as this weekend is almost certain. mupon nobification of originator)
