## DESTRUCTIVE EFFECT ON OUR OBJECTIVES HERE.

2. IN ADDITION TO THE REASONING OUTLINED IN REFERENCE A AND B FOR MAINTAINING A TOP PRIORITY OF THE MILGP, I WOULD LIKE TO EMPHASIZE THE FOLLOWING:

A. US MILITARY MISSIONS ARE PRESENT IN ARGENTINA AT THE EXPRESS REQUEST OF THE ARGENTINE GOVERNMENT. THIS IS A RESULT OF BILATERAL AGREEMENTS OF LONG STANDING - NAVY, 1935, AIR FORCE - 1956, AND ARMY 1961. THESE AGREEMENTS HAVE FOR THE PAST SEVERAL YEARS BEEN CONSISTENTLY IGNORED BY THE US AS REGARDS TO MANNING LEVELS. DUE TO BUDGETARY AND SECURITY CONSTRAINTS THE MILGP HAS DECREASED FROM APPROXIMATELY SIXTY (60) PERSONNEL TO THE PRESENT FOURTEEN (14). BECAUSE THE ARGENTINE ARMED FORCES UNDERSTANDS THESE PROBLEMS THEY HAVE WITHOUT COMPLAINT TOLERATED THESE ACTIONS. THEY HAVE, HOWEVER, EXPRESSED VERY STRONGLY THEIR CONCERN ABOUT THE SITUATION.

B. THE ARGENTINE ARMED FORCES, IN POWER SINCE MARCH 1976, ARE HEAVILY COMMITTED TO STRAIGHTENING OUT THE POLITICAL, ECONOMIC AND SOCIAL CHAOS LEFT BY THE PRECEDING GOVERNMENT. RECENT LEFT AND RIGHT WING TERRORIST ACTS ARE PLAINLY DESIGNED TO FORCE THE GOA INTO REPRESSIVE MEASURES WHICH WILL THEN BE EXPLOITED BY THESE ELEMENTS TO DISCREDIT THE GOA WORLD-WIDE AND WEAKEN ITS POPULAR SUPPORT.

C. ALL THREE COMMANDERS OF THE ARGENTINE ARMED FORCES (NOW MEMBERS OF THE RULING JUNTA) AND THE MINISTER OF DEFENSE HAVE CONSISTENTLY EXPRESSED THEIR REQUIREMENTS AND DESIRE FOR THE CONTINUED PRESENCE OF US MILITARY PERSONNEL. ANY COURSE OF ACTION WHICH WOULD APPEAR TO SLIGHT THIS GOVERNMENT, WHICH IS STILL FEELING ITS WAY, WOULD HAVE A STRONG ADVERSE REACTION.

D. IT WASN'T UNTIL THE PERONIST REGIME HAD BROUGHT ARGENTINA TO THE VERY BRINK OF DISASTER THAT GENERAL VIDELA AND THE ARMED FORCES RELUCTANTLY ASSUMED THE RESPONSIBILITY OF GOVERNMENT. NOW, HOWEVER, THEY BELIEVE THAT THEY MUST CONTINUE TO GOVERN UNTIL THE CHAOS CREATED BY THE FORMER REGIME HAS BEEN CLEARED UP. ONLY THEN WOULD A

RETURN TO FULL REPRESENTATIVE GOVERNMENT BE POSSIBLE. A UNILATERAL MOVE BY THE US, SO OBVIOUSLY COUNTER TO THE PERCEIVED NEEDS OF THE GDA LEADERS, IS BOUND TO HAVE ADVERSE EFFECTS ON THE RELATIONSHIPS BETWEEN THE TWO COUNTRIES.

E. OVER THE PAST TWO YEARS THE OPERATIONS OF VARIOUS PROVISIONS OF THE FAA AND DECISIONS OF THE SENATE APPROPRIATIONS COMMITTEE HAVE HAD THE EFFECT OF IRRITATING AND ANTAGONIZING THE ARGENTINE MILITARY FOR REASONS THAT HAD NOTHING TO DO WITH THEM. ANOTHER SITUATION IN WHICH THEY SEE US TREATING OUR MILITARY RELATIONS AS UNIMPORTANT OR INSIGNIFICANT COULD BE DEVASTATING. OUR COMMITMENTS TO THE ARGENTINE MILITARY INSTITUTIONS NOW AND LATER WILL BE A MAJOR DETERMINANT OF OUR BILATERAL RELATIONS IN THE FUTURE.

3. IN VIEW OF THE ABOVE AND PREVIOUS RECOMMENDATIONS FROM THIS EMBASSY, IT WOULD APPEAR THAT LONG-TERM US INTERESTS WOULD BEST BE SERVED BY PLACING ARGENTINA IN THE HIGH PRIORITY CATEGORY OF COUNTRIES IN WHICH THE MILGPs WILL CONTINUE TO OPERATE. I BELIEVE THE EXECUTIVE BRANCH SHOULD AT LEAST RECOMMEND THIS TO THE CONGRESS. I HOPE YOU AGREE.
