TOP SECRET (TS); SECRET (S); CONFIDENTIAL (C)

WARNING NOTICE - SENSITIVE INTELLIGENCE SOURCES AND METHODS INVOLVED (WNINTEL). This marking will be prominently displayed on all information and materials relating to sensitive intelligence sources and methods. Materials so marked will not be disseminated in any manner outside authorized channels without the permission of the originating department and an assessment by the senior intelligence officer in the disseminating department as to the potential risk to the national security and to the intelligence sources and methods involved.

DISSEMINATION AND EXTRACTION OF INFORMATION CONTROLLED BY ORIGINATOR (ORCON). This marking shall be used when unique source sensitivity factors, known to the originator, require strict compliance with third agency rule procedures, in addition to a continuing knowledge and supervision on the part of the originator as to the extent to which the original document and information contained therein is disseminated. Documents and information bearing this marking will not be disseminated beyond the Headquarters elements of the recipient organizations and the information contained therein shall not be extracted and incorporated into other reports without the permission of and under conditions prescribed by the originator.

USIB DEPARTMENTS ONLY (USIBONLY). Foreign intelligence so marked will not be disseminated to Departments and agencies not represented on the U.S. Intelligence Board without the permission of the originating agency. The Department of Defense is a USIB member; therefore, items with this marking can be disseminated to all DoD components.

NOT RELEASABLE TO CONTRACTORS OR CONTRACTOR/CONSULTANTS (NOCONTRACT). Foreign intelligence so marked shall not be disseminated to contractors or contractor consultants without the permission of the originating agency. This restriction shall not apply to those consultants hired under Civil Service Commission procedures, or comparable procedures derived from authorities vested in heads of departments and agencies by law, and who are normally considered an extension of the office by which they are employed.

CAUTION - PROPRIETARY INFORMATION INVOLVED (PROPIN). This marking will be used in conjunction with foreign intelligence obtained from various sources in the U.S. private business sector as the information may bear upon proprietary interests of the source or may otherwise be used to the source's detriment. Recipients of reports bearing this marking shall take every reasonable precaution to ensure that the information is not used to the detriment of the source. (This control marking cannot be used alone. When it is used, the control marking "NOCONTRACT" must also be used.)

NOT RELEASABLE TO FOREIGN NATIONALS (NOFORN). Foreign intelligence so marked involves special considerations requiring that it not be released in any form to foreign governments, foreign nationals, or non-U.S. citizens without the permission of the originating agency.

ARGENTINA

MRS. PERON TEMPORIZES WHILE MILITARY
CONTINUES TO PLAN.

~~(C/NOFORN)~~ In a further effort to appease labor and attempt to rally support, the government has reportedly awarded all workers a 20 percent wage boost.

~~(C/NOFORN)~~ The move follows several days of wildcat strikes by labor protesting the 12 percent increase announced earlier as part of the government's new economic austerity plan. Union workers in the capital and the nation's key industrial city of Cordoba had claimed the raise was insufficient in light of a cost of living increase of almost 30 percent in the first two months of 1976, devaluation of the peso by over 40 percent, and government-authorized price increases in the cost of fuel and basic utilities.

~~(C/NOFORN)~~ Mrs. Peron also addressed the nation from the headquarters of the principal labor organization, stressing that its leaders had approved the government's austerity program and calling for sacrifice and unity in support of the government. Despite the headquarters' support, however, subordinate unions will almost certainly consider the 20 percent unacceptable and further strikes are likely. The labor movement's chronic factionalism will further dilute the leadership's backing for Mrs. Peron.

~~(C/NOFORN)~~ Meanwhile, Mrs. Peron's political position does not appear to have improved as a result of her reelection as chief of the Peronist Party earlier this week. Her reelection is considered a pyrrhic victory at best since the opposition delegates either boycotted the proceedings or were not permitted to attend.

(C/NOFORN/INTTEL) The military reaction to the government's latest move remains unclear. The armed forces leadership apparently remains firm in the resolve to act against the President, but Army Commander Videla and other moderates wish to delay moving until Mrs. Peron's government is completely discredited. Her failure to successfully implement the economic austerity program, continuing terrorist violence, and further strikes by labor will, however, strengthen the position of hard-line military commanders who are pressing for a coup and threatening to depose Videla if he refuses to act. Gen Videla may thus be forced to move within the next few days. Key army corps commanders apparently met with Videla in the capital on the 10th.

(C/NOFORN) If Videla can hold off, the armed forces will stand to benefit. Those army and air force elements which reportedly are not ready to assume the responsibility for the ministries they have been designated will be able to complete their preparations. The further deterioration of the political situation will also tend to discredit Mrs. Peron and Peronism and increase popular support for the armed forces. ~~(AGDS-2 Declassify upon notification of originator)~~
