

KEY TO CLASSIFICATION AND HANDLING CAVEAT ABBREVIATIONS USED IN DEFENSE INTELLIGENCE AGENCY CURRENT INTELLI-GENCE PUBLICATIONS.

TOP SECRET (TS); SECRET (S); CONFIDENTIAL (C)

NO FOREIGN DISSEM (NFD) - Originator has determined that the information must not be released in any form, not even by paraphrasing, to foreign governments.

NO DISSEM ABROAD (NDA) - The information will not be sent outside the continental United States, Hawaii, and Alaska, except as determined by the originator in order to satisfy special conditions.

BACKGROUND USE ONLY (BUO) - The information will not be included in any other document or publication without the specific approval of the originating organization.

CONTROLLED DISSEM (CD) - Limits distribution to personnel within the intelligence components of USIB member agencies. Such information will not be disseminated to contractors.

WARNING NOTICE: SENSITIVE INTELLIGENCE SOURCES AND METHODS INVOLVED (WNSISMI) - The intent of this warning is to emphasize the sensitivity of the information and the need for special controls while permitting distribution to individuals with a valid need to know.

ISSUE OF PRESIDENTIAL SUCCESSION CAUSES DISSENSION.

(C/NFD) President Peron's recent rapprochement with opposition parties may be short-lived as a result of her power play in the senatorial election of 25 April. In a move that many opposition as well as Peronist senators believe was unconstitutional, Mrs Peron and her adviser, Social Welfare Minister Jose Lopez Rega, blocked the elections for a new Senate President -the individual next in line for presidential succession. The incumbent, Jose Allende, was forced to resign by the Peronists. As a Christian Democrat, Allende was unacceptable to the Peronists' leadership as a potential president, although he was looked upon with favor by the military and other sectors.

(c)NPD) By forcing their measure through, President Peron and Lopez Rega have removed a viable presidential alternative and succeeded in elevating Peronist Chamber of Deputies President Raul Lastiri, who happens to be Lopez Rega's son-in-law, as constitutional successor. For the time being, President Peron remains the lesser of evils to those individuals upset with the political situation. Lastiri is presently unacceptable to labor leaders as a presidential possibility and is perceived as being as amenable to his father-in-law's control as is the President. Thus, Lopez Rega has solidified his position, once again demonstrating an uncanny ability to remain in power despite being almost universally detested.

(S/MFD/MNSTONE) The unity that had been developing between labor and the military to demand Lopez Rega's ouster appears to be faltering. Neither the generals nor the labor leaders wish to take the first step. This reluctance is reinforced by their realization that the Peronist government, despite severe economic and political difficulties, retains considerable popular

support. What may eventually cause a shift in this support is the increasing terrorism, especially that being carried out by the Argentine Anticommunist Alliance (AAA), the right-wing vigilante group that operates with covert government support.

(CAND) Even for the Argentines, who have a tradition of apathy toward the political machinations of opposing factions, the leftist-rightist terrorism may eventually reach an intolerable level. Until the military perceive that this point has been reached, however, a move against the government is not very likely. (MCDS-1, 2, and 4 Declassify upon notification of originated
