

WARNING NOTICE - SENSITIVE INTELLIGINCE SOURCES AND METHODS INVOLVED (WWINTEL). This marking will be prominently displayed on all information and materials relating to sensitive intelligence sources and methods. Materials so marked will not be disseminated in any manner outside authorized channels without the permission of the originating department and an assessment by the senior intelligence officer in the disseminating department as to the potential risk to the national security and to the intelligence sources and methods involved.

DISSEMINATION AND EXTRACTION OF INFORMATION CONTROLLED BY ORIGINATOR (ORCON). This marking shall be used when unique source sensitivity factors, known to the originator, require strict compliance with third agency rule procedures, in addition to a continuing knowledge and supervision on the part of the originator as to the extent to which the original document and information contained therein is disseminated. Documents and information bearing this marking will not be disseminated beyond the Headquarters elements of the recipient organizations and the information contained therein shall not be extracted and incorporated into other reports withoriginator.

USIB DEPARTMENTS ONLY (USIBONLY). Foreign intelligence so marked will not be disseminated to departments and agencies not represented on the U.S. Intelligence Board without the permission of the originating agency. The Department of Defense is a USIB member; therefore, items with this marking can be disseminated to all DoD components.

NOT RELEASABLE TO CONTRACTORS OR CONTRACTOR/CONSULTANTS (NOCONTRACT). Foreign intelligence so marked shall not be disseminated to contractors or contractor consultants without the permission of the originating agency. This restriction shall not apply to those consultants hired under Civil Service Commission procedures, or comparable procedures derived from authorities vested in heads of departments and agencies by law, and who are normally considered an extension of the office by which they are employed.

CAUTION - PROPRIETARY INFORMATION INVOLVED (PROPIN). This marking will be used in conjunction with foreign intelligence obtained from various sources in the U.S. private business sector as the information may bear upon propletary interests of the source or may otherwise be used to the source's detriment. Recipients of reports bearing this marking shall take every reasonable precaution to ensure that the information is not used to the detriment of the source. PRESIDENT HOSPITALIZED.

on 3 November, reportedly because of an acute gall bladder problem, could return her constitutional successor, Senator Luder, to the presidency.

The President's illness, which has also been reported as a nervous attack, comes only three weeks after returning from a month's sick leave. The Argentine leader is facing impeachment threats by opposition members of congress over her alleged diversion of public welfare funds to a private bank account. Some of her close advisers, including the exiled former Social Welfare Minister Lopez Rega, are also suspected of corruption. One of her close associates was forced to resign on 31 October because of such charges.

(CYNOFORN) Mrs. Peron's naming last week of Anibal Demarco, a follower of Lopez Rega, as Social Welfare Minister aroused fears that the residual influence of the former official is still strong. In making the appointment, the President chose to ignore overwhelming sentiment against placing him in the post. Opponents to Demarco's selection included the Cabinet's top figure, Interior Minister Robledo, who had promised the military prior to Mrs. Peron's resumption of the presidency on 16 October that he would keep her in line. The appointment will undoubtedly harden opposition in and out of the government and will lessen Robledo's credibility with the military.

Peron's condition as being not serious, one medical source says that surgery may be required, which would

incapacitate her for about a month. In all likelihood, whether or not her deteriorating condition is from a malfunctioning gall bladder or nerves, the President's opposition — including the military — will use this latest setback in her health as a means to press her into an indefinite leave of absence or resignation. Despite increasing talk of a military coup, the armed forces would probably be content for now with Luder's return.
