

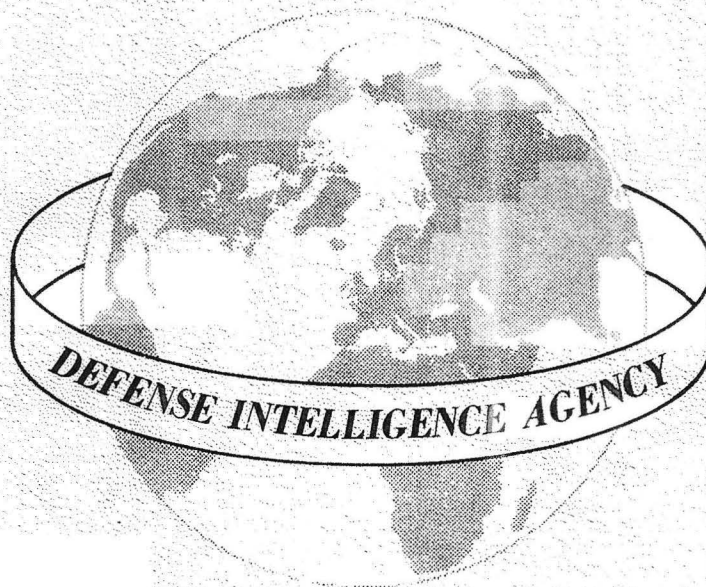

TOP SECRET (TS); SECRET (S); CONFIDENTIAL (C)

WARNING NOTICE - SENSITIVE INTELLIGENCE SOURCES AND METHODS INVOLVED (WNINTEL). This marking will be prominently displayed on all information and materials relating to sensitive intelligence sources and methods. Materials so marked will not be disseminated in any manner outside authorized channels without the permission of the originating department and an assessment by the senior intelligence officer in the disseminating department as to the potential risk to the national security and to the intelligence sources and methods involved.

DISSEMINATION AND EXTRACTION OF INFORMATION CONTROLLED BY ORIGINATOR (ORCON). This marking shall be used when unique source sensitivity factors, known to the originator, require strict compliance with third agency rule procedures, in addition to a continuing knowledge and supervision on the part of the originator as to the extent to which the original document and information contained therein is disseminated. Documents and information bearing this marking will not be disseminated beyond the Headquarters elements of the recipient organizations and the information contained therein shall not be extracted and incorporated into other reports without the permission of and under conditions prescribed by the originator.

USIB DEPARTMENTS ONLY (USIBONLY). Foreign intelligence so marked will not be disseminated to departments and agencies not represented on the U.S. Intelligence Board without the permission of the originating agency. The Department of Defense is a USIB member; therefore, items with this marking can be disseminated to all DoD components.

NOT RELEASABLE TO CONTRACTORS OR CONTRACTOR/CONSULTANTS (NOCONTRACT). Foreign intelligence so marked shall not be disseminated to contractors or contractor consultants without the permission of the originating agency. This restriction shall not apply to those consultants hired under Civil Service Commission procedures, or comparable procedures derived from authorities vested in heads of departments and agencies by law, and who are normally considered an extension of the office by which they are employed.

CAUTION - PROPRIETARY INFORMATION INVOLVED (PROPIN). This marking will be used in conjunction with foreign intelligence obtained from various sources in the U.S. private business sector as the information may bear upon proprietary interests of the source or may otherwise be used to the source's detriment. Recipients of reports bearing this marking shall take every reasonable precaution to ensure that the information is not used to the detriment of the source. (This control marking cannot be used alone. When it is used, the control marking "NOCONTRACT" must also be used.)

NOT RELEASABLE TO FOREIGN NATIONALS (NOFORN). Foreign intelligence so marked involves special considerations requiring that it not be released in any form to foreign governments, foreign nationals, or non-U.S. citizens without the permission of the originating agency.

THIS INFORMATION HAS BEEN AUTHORIZED FOR RELEASE TO (Specified Countries) (REL Specified Countries). This marking may be used when the originating agency predetermines that information can be released to specified foreign governments.

## ARGENTINA

## CONTINUING AIR FORCE REVOLT SPURS MILITARY ACTION.

(U) Various press reports indicate that Moron Air Base, the location of the rebel air force command, has been attacked by aircraft under orders of Air Force Commander General Agosti.

(S) In a 20 Dec meeting Gen Agosti gave rebel leader General Cappellina, an ultimatum calling for the rebels to surrender by 1400 EST or be the object of a military operation. When the deadline passed without any rebel action, aircraft strafed and bombed the main runway at Moron. No casualties have been reported in the air strike which was probably a show of force aimed at breaking the will of the mutineers and ending the three-day old uprising.

(S) Both the rebels and pro-government military forces have stressed the need to avoid bloodshed, but rebel Gen Cappellini issued a communique saying, "If we are attacked...we will not respond against our comrades with gunfire, but will...attack the Casa Rosada (Presidential Palace)...." The rebellious forces are believed to have little chance of carrying out a significant attack on the Presidential Palace, but the Palace is reportedly being evacuated and the surrounding area cleared.

(S) Meanwhile, a Buenos Aires radio broadcast reported that President Peron suffered an illness in her office. It is likely that the pressures of the past few days have taken their toll on the frail president and her illness could pave the way for Senate leader Italo Luder to once again assume the Presidency while she recuperates. Although the rebellious air force officers have called for the replacement of Mrs. Peron by Army Commander General Videla, they may be willing to accept Luder after reflecting on General Agosti's show of force.
