PD2 is a Contract Writing System used by several DoD Agencies. The system contains documents associated with contract awards, such as: Requirements Packages, Purchase Requests, Performance Work Statements, Solicitations, Contracts, Modifications, and Contract Action Reports (CARs). The Procurement Desktop Defense (PD2) application is the Standard Procurement System (SPS) used by the Washington Headquarter Services, Acquisitions Directorate (WHS-AD), Defense Secure Cooperation Agency (DSCA), & Defense Human Resources Activity (DHRA) procurement processes and workflows. It is a Commercial Off-the-Shelf (COTS) product developed by CACI, and is used throughout the Department of Defense (DoD) to interface with the enterprise-wide Standard Procurement System (SPS). The Contracting officer's name, work email and work cell phone numbers, title are part of the contracting officer signature on contracts.
