for government and contractor construction personnel to address. Email notifications are sent to users when new documents/submittals are uploaded and when new design review comments are entered. The software is also used to document construction related inspections and to develop/document functional performance tests for the commissioning (i.e., acceptance testing) of new building systems (e.g., heating units, fire alarm systems, lighting systems). Finally, the system is used to generate WHS Building Code permits, which are required for construction projects on the Pentagon Reservation.  The only PII data collected is the contact information (name, home/cell phone, work email address, position/title, and work phone) of the users and their associated DOD ID number found on their active CAC. The DOD ID is used to provide access to the CAC enabled system. Contact info (name and phone number is displayed) with the associated design review comments that are entered.
